Opinion

We have audited the accompanying financial statements of Veterinary Service, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets in liquidation available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets in liquidation available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

General: Veterinary Service, Inc. (the Company), established the Veterinary Service, Inc. Employee Stock Ownership Plan (the Plan) effective April 1, 1990. The Plan, as amended, operated as an employee stock ownership plan (ESOP), and was designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code 2586 (the Code), as amended, and was subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. An administrative committee appointed by the Company's Board of Directors administered the Plan.

Sale of Company: Effective March 31, 2022, all of the outstanding common stock of the Company was sold to a new ownership group and the Plan was terminated. Therefore, as of March 31, 2022, the Plan no longer owned any common stock of the Company. Consequently, as stated in the termination amendment, the Plan was converted to a profit-sharing plan at March 31, 2022; however, the Plan did not change its name. Due to the sale, all participants became fully vested in their benefits under the Plan. Liquidation was determined to be imminent, and therefore, the plan's financial statements have been prepared using the liquidation basis of accounting in accordance with U.S. GAAP. As of March 31, 2025, the Plan has distributed all funds to plan participants.

Participant accounts: The Plan was a defined contribution plan under which a separate individual account was established for each participant. As of the end of each plan year, each participant was allocated a share of the current year's earnings or losses based on their account balance as of the beginning of the year. The contribution for each year was divided among eligible participants in proportion to their share of covered compensation. As of March 31, 2025, there were no unallocated plan assets that had not yet been allocated to participant accounts.

Administrative expenses: The Company paid the administrative costs of the Plan associated with plan communication and recordkeeping, as well as provided equipment, personnel, and supplies to administer the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting: The financial statements were prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuations and concentration: Due to the sale of the common stock on March 31, 2022, the only assets of the Plan as of March 31, 2024 were interest-bearing cash and a receivable (Note 4). As of March 31, 2025 all assets of the Plan were distributed to plan participants.

Payment of benefits: Benefits are recorded when paid.

NOTE 3 – ADMINISTRATION OF PLAN ASSETS

The plan's assets, which consisted primarily of interest-bearing cash, were held by the Trustee of the Plan. Company contributions were held and managed by the Trustee, who, prior to the sale of the Company, invested cash received and interest income. The Trustee remained responsible for making distributions to participants.

NOTE 3 – ADMINISTRATION OF PLAN ASSETS (CONTINUED)

Certain administrative functions were performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

NOTE 4 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Prior to the sale of the Company, the Plan invested in Company common stock which was a related party and party-in-interest transaction. As described in Note 1, the Company paid all plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

As of March 31, 2024 the Plan had a receivable of \$21,945 from Argent Trust Company, the service provider that processed and sent benefit payment checks directly to participants based on their benefit payment elections. The receivable related to checks which the Plan stopped payment on, which were not deposited back into the Plan's accounts by Argent Trust Company until after March 31, 2024.

NOTE 5 – STOCK SALE ESCROW FUNDS

As a result of the sale of the Company discussed in Note 1, three specific escrow holdback amounts were required to be deposited into escrow, of which \$2,120,682 was allocated to the Plan. Based on the terms of the purchase agreement, these amounts were paid back to the Plan within 18 to 30 months, less any amounts used to pay for contingent claims and expenses. Given the contingent and uncertain nature of the amount the Plan expected to receive in the future, no receivable was accrued as of March 31, 2024. In November 2024, the Plan received the final proceeds from escrow of \$466,659.

NOTE 6 – TAX STATUS

The Plan received a determination letter from the Internal Revenue Service (IRS) dated August 9, 2023, stating that the Plan is qualified under the Internal Revenue Code and, therefore, the related Plan is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualification.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain tax positions to disclose in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – SUBSEQUENT EVENTS

The plan sponsor evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated and disclosed in the notes through June 20, 2025, the date the financial statements were available to be issued.
