Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Bacon Universal Company, Inc. 401(K) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Notes to Financial Statements
For the Short-Year Ended September 3, 2024 and Year Ended June 30, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Bacon Universal Company, Inc. (the Company) 401(K) Profit Sharing Plan (the Plan) provides for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan's sponsor, Bacon Universal Company, Inc., approved the merger of this Plan with ProService Hawaii 401(K) Plan, effective September 3, 2024. As a result, all investments were transferred from the Plan into the ProService Hawaii 401(K) Plan on that date. The financial year end for the Plan was changed from June 30 to September 3 in conjunction with the merger. Accordingly, the current financial statements were prepared for the period from July 1, 2024 to September 3, 2024 and as a result, the comparative figures stated in the statements of net assets available for benefits, statements of changes in net assets available for benefits, and the related notes are not comparable.

a. General

The Plan is a defined contribution profit sharing plan covering eligible employees of the Company. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Contributions

The Plan provides for the Plan sponsor, Bacon Universal Company, Inc., to contribute a portion of its net profit as determined by management to the Plan annually. All participants employed on the last day of the Plan year and who have completed 1,000 or more hours of service during the Plan year are eligible for allocation of the Plan sponsor contribution. The participant's allocation is determined by applying a set percentage to their annual compensation. Eligible participants may also elect to contribute up to \$23,000 of their compensation for the calendar year 2024, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

c. Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and, (b) Plan earnings or losses. Employees are eligible for participation upon a latter of reaching the age of 20.5 or completion of six months with at least one hour of service in each month.

d. Forfeitures

Forfeited balances of terminated participants' non-vested accounts can be used to offset the Company's contribution or Plan expenses. For the years ending September 3, 2024 and June 30, 2024, forfeitures were \$4,526 and \$3,523, respectively.

1. DESCRIPTION OF THE PLAN (CONTINUED)

e. Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic installments as allowed by law. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or they may elect to have their vested interest rolled-over into another qualified plan or Individual Retirement Account.

f. Vesting of Benefits

Participants are immediately vested in their salary deferrals plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of services as follows:

g. Notes Receivable from Participants

Certain eligible participants may borrow from their accounts for valid reasons. The maximum loan amount is \$50,000 (reduced by the highest outstanding loan balance during the 12-month period ending on the day before the loan is made) or 50% of their vested interest in the Plan, whichever is less. The loans are secured by a maximum of 50% of the present value of the participant's vested interest in the Plan and bear interest at the prime rate as of the date of the loan plus one percent. Principal and interest are paid ratably through payroll deductions. Fees related to loans are charged to the participant's account.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of September 3, 2024 and June 30, 2024, no allowance for doubtful accounts has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a deemed distribution of participant loan based on the terms of the Plan document. There were no deemed distributions for the short-year ended September 3, 2024 and year ended June 30, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of Accounting

The accompanying financial statements were prepared in accordance with accounting principals generally accepted in the United States of America. Substantially all information in the accompanying financial statements and supplemental schedules was provided by Hicks Pension Services (the Third-Party Administrator) and John Hancock (the Custodian). The Custodian has certified that the information contained in the custodial and plan reports are complete and accurate for the short-years ending September 3, 2024 and year ending June 30, 2024.

b. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

c. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. In general, investments are valued at quoted market prices, if available. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. All Plan assets were transferred to the ProService Hawaii 401(K) Plan before close of business on September 3, 2024.

d. Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

e. Payment of Benefits

Benefit payments to participants are recorded upon distribution when paid.

f. Net Appreciation (Depreciation) in Fair Value of Investments

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

3. PLAN TERMINATION

The Company reserves the right to amend or terminate the Plan. However, no amendment can take away any benefits already earned. If the plan is terminated, participants will be entitled to the full amount in their account as of the date of the termination, regardless of the percent the participants are vested at the time of termination.

4. INCOME TAX STATUS

The Internal Revenue Service has ruled that the Plan qualified under Section 401 of the Internal Revenue Code, therefore not subject to tax under present income tax laws. The Plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by the tax authorities; however, there are currently no audits for any tax periods in progress. For income tax purposes, the tax returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurements and Disclosure*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

5. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at September 3, 2024 and June 30, 2024.

- Participant directed investments: Valued at daily calculated net asset value of shares held by plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's independent auditor did not perform audit procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedules.

7. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

As of September 3, 2024 and June 30, 2024, loans totaling \$58,376 and \$59,606 to participants qualify as party-in-interest transactions, respectively.

Certain administrative fees are paid by the Plan's sponsor, Bacon Universal Company, Inc., fees paid to John Hancock as custodian amounted to \$1,002 and \$5,828, paid to Hicks Pension Services as third-party administrator amounted to \$298 and \$9,373 for the short-year ended September 3, 2024 and year ended June 30, 2024, respectively.

Generally, the Company remits funds within 7 business days from the paycheck date. However, in this case the participant contributions in the plan short-year ended September 3, 2024 and year ended June 30, 2024 were remitted in 2-33 business days late. The Company will utilize the Voluntary Fiduciary Correction Program with the Department of Labor and participant accounts will be credited with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. REPORTABLE TRANSACTIONS

The Plan had no reportable transactions as defined in 29 CFR 2520.103-8.

11. PLAN MERGER

On September 3, 2024, Bacon Universal Company, Inc. 401(K) merged into the ProService Hawaii 401(K) Plan. In connection with the plan merger, there was a blackout period effective August 26, 2024 through October 11, 2024, in which all plan participants were notified on July 16, 2024. During the blackout period, participants were temporarily unable to direct or diversify investments in their individual account, obtain a loan, or obtain a distribution from the Plan. Administrative costs incurred after the merger date would be absorbed by ProService Hawaii 401(K) Plan.

Prior to the merger, the plan covered eligible employees. The transferred net assets have been recognized in the accounts of the ProService Hawaii 401(K) as of September 3, 2024, at their balances as previously carried in the accounts of the Bacon Universal Company, Inc. 401(K). The changes in net assets of the plan are included in the accompany statement of changes in net assets available for benefits from September 3, 2024.

12. CHANGE IN THIRD-PARTY PLAN ADMINISTRATOR AND CUSTODIAN

During the short-year ended September 3, 2024 the Plan transitioned its third-party administrator from Hicks Pension to ProService. This change was implemented to enhance service offerings and improve compliance. The Plan's management has reviewed the transition process to ensure that all participant records, transactions, and plan operations were accurately maintained and that there was no disruption in service or compliance during the transition period. As part of the transition, plan data and administrative responsibilities were transferred to ProService.

The Plan also transitioned its Custodian from John Hancock to Transamerica Retirement Solutions, LLC. A total balance of \$3,309,385 was migrated to Transamerica Retirement Solutions, LLC as of September 3, 2024.
