Scope and Nature of the ERISA Section 103(a)(3)(e) Audit

We have performed audits of the accompanying financial statements of Independent Project Analysis, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Independent Project Analysis, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).



1. Plan Description

The following description of Independent Project Analysis, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (“Principal”) is the trustee of the Plan and holds the Plan’s investments. Principal Life Insurance Company (“Principal Life”) performed the recordkeeping functions for the Plan during the years ended December 31, 2024 and 2023.

General: The Plan is a defined contribution profit sharing plan covering full time employees of Independent Project Analysis, Inc. (the “Sponsor”) who have completed three months of service and are age 20 or older. Effective January 1, 2024, certain long-term part-time employees that meet the Plan’s hourly requirements may also participate. The Plan management is responsible for oversight of the Plan. The Plan management determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s trustees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Amendment No. 1 to the Plan was effective January 1, 2024.

Contributions: Each year participants may contribute pretax annual compensation, as defined in the Plan, subject to statutory limitations of the Internal Revenue Code (“IRC”). In addition, participants 50 years of age or older may elect to make catch-up contributions up to the maximum allowed by the IRC. Effective January 1, 2024, participants may also make Roth contributions. Participants may also make rollover contributions representing distributions from other qualified benefit plans.

The Plan provides for employer matching contribution equal to 50% of elective deferral and Roth contributions up to 6% of pay that a participant contributes to the Plan. The Plan also allows for a qualified non-elective contribution (QNEC) of 3% of annual pay and additional contributions of 2% of compensation. During the year ended December 31, 2024, employer matching, QNEC, and additional contributions were \$339,381, \$382,210, and \$254,805, respectively.

Investment options: Participants direct the investment of their deferral contributions and employer contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and mutual funds as investment options for participants. Participants may change their investment options daily.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, the Sponsor’s matching contributions, the Sponsor’s qualified non-elective contributions, the

Sponsor's additional contributions, and allocations of Plan earnings/losses, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is limited to the vested balance of the participant's account.

Vesting: Participants are immediately vested in their contributions and any rollover contributions, plus the actual earnings thereon. Participants are vested in the Sponsor's contributions plus actual earnings thereon based on years of service, as defined by the following schedule:

1	20%
2	40%
3	60%

If a participant becomes completely disabled, reaches 65 years of age, or upon death they automatically become fully vested in their accounts.

Payment of Benefits: The Plan permits withdrawals when a participant terminates employment, retires, or becomes disabled or deceased. Upon termination of service, participants are eligible to request a cash distribution of their vested account balance. Hardship withdrawals are also permitted, subject to Plan provisions. For accounts with a balance less than \$5,000, the trustee may distribute the balance into a Principal individual retirement account (IRA) after 60 days in absence of direction from the participant. If a participant has not directed a distribution prior to reaching the age of 73, the plan administrator will direct the trustee to begin distributions to the participant no later than April 1 of the calendar year following attaining age 73. Participants may also elect to have their distribution rolled into an IRA, a new employer qualified plan or a 403(a) annuity.

Forfeitures: Forfeitures may be used to pay reasonable plan expenses, fund employer contributions or allocated to participants, in accordance with plan provisions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$53,399 and \$64,953, respectively. During the year ended December 31, 2024, \$42,721 of forfeitures were used by the Plan to pay plan expenses.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. A loan may extend up to five years, or over a reasonable period of time for the purchase of a

participant's primary residence, as established by the Plan Administrator at the time of the loan. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan administrator and which remain fixed for the life of the loan. As of December 31, 2024, the interest rates on outstanding loans were between 5.25% and 10.50%. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Date of Management's Review: Subsequent events were evaluated through June 30, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States ("GAAP") requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the

accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant ceases to make scheduled loan repayments and the Plan Administrator considers the participant loan to be in default, the participant's note receivable balance is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions: Contributions from Plan participants and matching contributions from the Sponsor are recorded in the year in which the participant contributions are withheld from amounts paid. QNEC and additional employer contributions are recognized upon authorization and in the year the underlying compensation is recognized under the Plan. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Administrative fees for participant-initiated transactions are charged directly to the participant's account. Administration fees and investment-related fees paid using the Plan's assets are generally allocated to the participants proportionately based on the value of their account balance or paid out of forfeitures. Certain investment related expenses are included in the net appreciation (depreciation) of fair value of investments. Expenses for maintaining the Plan paid directly by the Sponsor are not included in these financial statements.

3. Information Prepared and Certified by Trustee

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

4. Fair Value Measurements

The framework for measuring fair value provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 inputs are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 inputs include quoted prices for similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

Level 3 inputs are unobservable and significant to the fair value measurement.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset

value (NAV) and to transact at that price. The mutual funds held by the Plan are considered actively traded.

Pooled Separate Accounts: Valued based on the underlying investments (i.e., stock, mutual funds, short-term securities). Although the NAV of the pooled separate accounts is not publicly quoted, the NAV is available to current investors and is the basis for current transactions; therefore, the Plan considers the pooled separate accounts to have a readily determinable fair value.

5. Related Party and Party-in-Interest Transactions

The Plan holds investments in funds managed by Principal and Principal Life and these transactions are considered party-in-interest transactions, however they are exempt from the prohibited transaction rules under ERISA. The Plan pays investment advisory fees to Morgan Stanley, which are considered party-in-interest transactions. Certain expenses of the Plan, including audit fees, are paid by the Sponsor on the Plan's behalf.

6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and will receive the balance of their accounts.

7. Income Tax Status

The Plan adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the IRS dated June 30, 2020 as to the prototype plan's qualified status. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code, and therefore, believe the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. During the year ended December 31, 2024, the plan administrator conducted periodic reviews of investment options as part of the Plan's overall risk management.
