To the Trustees
Lawrence Paper Company Employees 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Lawrence Paper Company Employees 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note I to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note B1 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, described in Note B1; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Note A - Description of Plan

The following description of Lawrence Paper Company Employees 401(k) Profit Sharing Plan and Trust (the Plan), provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan of the Lawrence Paper Company and its wholly-owned subsidiaries [Jayhawk Boxes, Inc., and American Packaging, Inc.] (the Company), is a defined contribution plan that covers all employees who are at least 18 years of age and have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for oversight of the Plan, including reviewing the appropriateness of the Plan's investment offerings and monitoring investment performance.

1. Contributions

Effective January 1, 2023, the Plan is a "qualified automatic enrollment arrangement (QACA) safe harbor 401(k) plan." The Company makes safe harbor matching contributions equal to 100 percent of participant salary deferrals that do not exceed 1 percent of compensation, plus 50 percent of participant salary deferrals in excess of 1 percent and up to 6 percent of compensation. The QACA safe harbor matching contribution is fully vested and is referred to as a QACA Safe Harbor Contribution.

Additionally, a discretionary profit-sharing amount may be contributed by the Company. No profit-sharing contributions were made for the years ended December 31, 2024 and 2023.

Participants may make voluntary contributions to the Plan so long as the total participant's contributions do not exceed the Internal Revenue Code Section 402(g) limitation. Adjusted for costs of living, this limitation is \$23,000 for the 2024 plan year, plus an additional \$7,500 of catch-up contributions permitted for employees age 50 and older.

2. Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Employer's contribution, and (b) plan earnings and (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

3. Vesting

Participant contributions, qualified nonelective contributions, and qualified automatic enrollment contributions together with the net earnings attributable to such contributions, are fully vested with the participants at all times. Vesting in the remainder of their account is based on years of credited service with the Employer. For contributions made after January 1, 2023, a participant is 100 percent vested upon two years of credited service. For contributions made prior to January 1, 2023, a participant is 100 percent vested upon three years of credited service. The nonvested benefit (forfeitures) is used to reduce first the Plan's ordinary and necessary administrative expenses and then the Employer contributions.

4. Investment options

Each participant may direct account balances to be invested in one or any combination of investment options offered by the Plan and may change the allocation daily. The Plan does not have any nonparticipant-directed investments.

5. Payment of benefits

The Plan provides for payment of benefits upon death, disability, retirement, or termination of employment. If the separated participant has a vested account balance of less than \$1,000, the benefit will be paid to them in cash as soon as administratively feasible without the participant's election. If the participant's vested account balance is between \$1,000 and \$5,000, the benefit will be rolled over to an IRA as soon as administratively feasible without the participant's election. A participant with a vested account balance in excess of \$5,000 may elect to receive the benefit to be paid in a lump sum distribution or keep the balance in the Plan.

6. Forfeited accounts

At December 31, 2024, forfeited nonvested accounts totaled \$9,879. At December 31, 2023, forfeited nonvested accounts totaled \$12,434. In 2024, \$29,049 of the forfeitures balance was applied to reduce Plan administrative expenses.

Note B - Summary of Accounting Policies

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

1. Basis of accounting

The accounting records of the Plan are prepared on the modified cash basis of accounting. The modified cash basis is used for the Plan's financial reporting under ERISA. The modified cash basis of accounting adopted by the Plan differs from the accrual basis in that revenues, except for unrealized gains and losses on investments, are recognized when received rather than when earned, and expenses are recognized when paid rather than when the obligation is incurred. Gains and losses on investments are recognized as revenue or expense whenever fluctuations in the market value occur.

2. Use of estimates

The preparation of the financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

3. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note D for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Net appreciation (depreciation) in fair value of investments

The Plan presents in the Statement of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

5. Payment of benefits

Benefits are recorded when paid.

6. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

7. Date of management's review and subsequent events

Subsequent events were evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

Note C - Related-party Transactions and Party-in-Interest Transactions

Certain plan investments are shares of mutual funds that are issued by Vanguard, a third-party administrator of the Plan. Fees paid to Vanguard and Ascensus are included in administrative expenses. Vanguard has an administrative relationship with Ascensus (the custodian of the Plan) and, therefore, these transactions qualify as party-in-interest transactions. Total administrative expenses were \$88,189 for the year ended December 31, 2024.

Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in inactive markets.
 - Inputs other than quoted prices that are observable for the asset or liability.
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
 - If the asset or liability has a specified contractual term, Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market account

Money market fund whose stated objective is to maintain \$1 net asset value.

Mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Cash surrender value of life insurance

Valued at the gross cash value less surrender charges.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to access the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Note E - Income Tax Status

On June 30, 2020, the Internal Revenue Service stated that the nonstandardized pre-approved agreement adopted by the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination. However, the Plan Administrator and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and tax-exempt.

Accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal taxing authorities. Management is not aware of any uncertain tax positions taken by the Plan. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note F - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note G - Plan Termination

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participant accounts will become 100 percent vested.
