Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Rice Services, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan providing retirement income, disability, termination, and death benefits to eligible employees. The Plan was adopted effective October 1, 2020 with a year end of December 31. The Plan was amended and restated effective January 1, 2021. The Plan is administered by Rice Services, Inc. (Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility and Participation

All of the employees of the Company and affiliated companies (except those covered by a collective bargaining agreement, leased employees and non-resident aliens) are eligible to participate in the Plan if they are at least 21 years old and have completed 6 month of service. Employees may begin contributing to the Plan starting on the first day of the month following eligibility.

Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, and participants qualifying for age-based catch-up provisions may contribute up to an additional \$6,500 of pretax annual compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may make discretionary and matching contributions to the Plan. The Company did not make any discretionary or matching contributions during the years ended December 31, 2024 and 2023.

Participant Accounts

A participant's account is credited with the participant's contributions, allocations of (a) the Company's matching contributions and (b) plan earnings. A participant's account is debited with an allocation of plan losses and charged with administrative expenses; as applicable. Allocation of earnings or losses are based upon participant account balances. Allocation of the Company's matching contributions are based upon eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their salary deferral contributions and rollover accounts plus actual earnings thereon. Vesting in the Company's match or discretionary contribution is based on years of continuous service. A year of service is obtained with the completion of 1,000 hours of service during a year. A participant is vested in the Company's discretionary or matching contributions based on the following schedule:

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant is also entitled to receive the value of the vested interest in his or her account as a lump sum distribution. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59 and a half, the participant is allowed to withdraw certain funds from the Plan.

Participants who separate from service and have vested account balances of \$5,000 or less will automatically have their account balance distributed directly to the individual; less any applicable federal income tax.

Forfeitures

Forfeitures of non-vested plan sponsor matching contributions are retained in the Plan and may be used to reduce future Company contributions and pay plan expenses. There were no forfeitures of non-vested accounts as of December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States (U.S. GAAP) requires management to make estimates and assumptions that affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from such estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Expenses related to the administration of the Plan, including fees of the independent public accountants, are paid by the Company. The investment options have certain management fees which reduce the overall return on assets.

Subsequent Events

On January 27, 2025, the Plan was amended to include the provisions of the Secure Act 2.0. The provisions include increasing the involuntary cash out distributions threshold from \$5,000 to \$7,000, higher catch up contributions for ages 60 to 63 for the 2025 calendar year as well as other provisions outlined in the Secure Act 2.0.

The Plan has evaluated subsequent events through June 18, 2025, the date the financial statements were available to be issued, and concluded that there were no other events or transactions that require recognition or disclosure in the financial statements as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023:

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The investment is classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INSURANCE CONTRACTS

The Plan entered into a fully benefit-responsive guaranteed investment contract with Standard Insurance Company (Insurance Company) through the investment in a stable value fund. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than one percent. The crediting rate is reviewed on a quarterly basis for resetting. The annualized net interest rate at December 31, 2024 and 2023 was 2.09% and 1.83%, respectively. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, less withdrawals and administrative expenses, plus interest credited. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the insurance contract at December 31, 2024 and 2023 was \$452,850 and \$270,481, respectively.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including partial or total plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Certain Plan investments are managed by Reliance Trust Company is the custodian as defined in the Plan and, therefore, these transactions are considered to be exempt party-in-interest transactions. The Plan paid certain administrative fees in 2024. These transactions qualify as party-in-interest transactions for which a statutory exception exemption exists.

NOTE 7 - PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vest in their employer profit sharing contributions.

NOTE 8 - TAX STATUS

Effective January 1, 2021, the Company adopted the Crossplans Non-Standardized Pre-Approved Profit Sharing Plan with CODA which obtained its opinion letter for the restated Plan on June 30, 2020. In this letter, the Internal Revenue Service (IRS) states that the Plan is acceptable under Section 401 of the IRC for use by the employers for the benefit of their employees. The Company believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - PROHIBITED TRANSACTION

During the year ended December 31, 2024 and 2023, the Plan Sponsor failed to remit to the Plan's custodian, employee contributions totaling \$1,983 and \$5,179, respectively within the period prescribed by Department of Labor regulations. Delays in remitting contributions to the custodian were due to administrative errors, and the Company is in the process of rectifying the matter by paying lost earnings on the employee contributions that were remitted late. During the year ended December 31, 2024, the Plan Sponsor completed the process of computing the lost earnings on the late deferrals related to 2023 and has made the corrective contribution for lost earnings to the Plan. Subsequent to year end, the Plan Sponsor completed the process of computing the lost earnings on the late deferrals related to 2024 and has made the corrective contribution for lost earnings to the Plan.

NOTE 10 - QUALIFIED NONELECTIVE CONTRIBUTION

During the year ended December 31, 2021, the Plan Sponsor erroneously failed to withhold employee deferrals on certain eligible wages. The corrective contribution for these missed deferrals totaled \$713 and is included in the Plan's receivables at December 31, 2023. During the year ended December 31, 2024, the Plan Sponsor has completed the process of computing the lost earnings on these deferrals and has made the corrective contribution for lost earnings to the Plan.

NOTE 11 - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risk such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
