To Whom it May Concern:

I am writing to explain the reason for the late filing of the Form 5500 for the Idaho Milk Medical Plan for the year 2024. We acknowledge the importance of timely filing and the compliance obligations that come with it. However, we believe that the late filing was due to reasonable cause, and we are requesting your consideration of this matter under the “reasonable cause” provisions outlined by the IRS and the Department of Labor.

Idaho Milk Transport was a new acquisition to Kenan Advantage Group in 2024. Idaho Milk Transport’s plan year ran from 8/1/2023-7/31/2024 and came onto Kenan Advantage Group’s benefits effective 8/1/2024. There was some miscommunication with our third-party administrator (TPA). We experienced an unexpected delay in receiving the necessary documentation from our TPA, which ultimately caused a delay in the preparation and submission of the form. We have since taken steps to ensure that this will not happen in the future.

We are committed to complying with all filing deadlines and have taken the following actions to avoid delays in the future. Moving forward we will work with our broker of record to ensure that documents are received on time and the Form 5500 will be submitted on time. We understand the importance of maintaining compliance with ERISA filing requirements and have implemented a more proactive approach to ensure all future filings are timely.

Given the circumstances described above, we respectfully request that the Department of Labor consider waiving any penalties associated with the late filing of this Form 5500. We are committed to complying fully with all reporting requirements and appreciate your understanding and consideration.
