1. Description of the Plan

The following description of the **Melgar Facility Maintenance, LLC Health and Welfare Plan (formerly Melgar Facility Maintenance Wrap Plan)** (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General: The Plan was established on September 1, 2019, and provides health and other benefits to eligible employees of Melgar Facility Maintenance, LLC. (the Company) and their covered dependents. Eligible employees include full-time and part-time prevailing wage employees, non-prevailing wage employees who work at least 20 hours per week and employees subject to a collective bargaining agreement that provides for participation in the Plan. The assets of the Plan are held in a trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Employees become eligible to participate the first day of the month following the completion of 30 days of employment.

Benefits: The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, disability benefits, accidental death and dismemberment benefits, critical illness, hospital indemnity, and accident benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Plan has a health reimbursement arrangement (HRA) that is funded solely through Company contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses up to \$2,000 for prevailing wage employees and \$3,000 for non-prevailing wage employees. Amounts remaining at the end of the year can generally be carried over to the next year up to 90 days. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the employer. At August 31, 2022, \$12,148 was owed to the HRA administrator for the reimbursement of claims under the arrangement. At August 31, 2021 (unaudited), the HRA administrator held \$23,851 on account for the reimbursement of claims under the arrangement.

Insured benefits: The Plan offers medical and dental programs that participants can choose. The Plan fully insures all benefits other than medical described below. Premiums for the critical illness, hospital indemnity and accident benefits are paid from the general assets of the Company. All other premiums are paid from the assets of the trust.

Self-insured benefits: Effective September 1, 2021, medical benefits are provided under a level-funded arrangement with an insurance provider under which the Plan pays a fixed monthly fee for each participant to cover the claims liability, stop-loss premiums and administrative costs. If actual claims incurred by the Plan are less than the amount paid, the Plan may be entitled to a refund at the end of the policy year. If the claims exceed the amount paid, the cost is covered by the stop loss portion of the policy and no additional amounts are due to the insurance provider. For the year ended August 31, 2022, claims paid exceeded the amount of the premiums paid and no refund was due to the Plan.

Contributions: Participants contribute specified amounts to the Plan based on applicable monthly premium equivalents established for their respective benefit elections.

The Company makes contributions on behalf of certain employees in amounts required to satisfy the fringe benefit contribution obligations under different prevailing wage programs. The Company also makes contributions to the Plan as needed to fund premiums, claims, and administrative expense in excess of participant contributions.

Participant accounts: A separate Premium Reserve Account is maintained for each participant. The account is credited monthly with the employee and employer contributions for the month and reduced by the premiums paid and administrative expenses incurred on behalf of each participant. Any net contribution in excess of a one month premium reserve is paid to the Company's qualified retirement plan on the participant's behalf.

2. Significant accounting policies

Basis of accounting: The accompanying financial statements have been prepared using the accrual basis of accounting.

The Plan's benefit obligations as of August 31, 2022 and 2021 and changes in benefit obligations for the year ended August 31, 2022 have been presented on the same statements as the Plan's net assets available for benefits and changes in net assets available for benefits.

Cash and cash equivalents: Cash and cash equivalents consist of highly liquid debt instruments with initial maturities of ninety days or less. The Plan maintains a cash balance at one commercial bank which can exceed the Federal Deposit Insurance Corporation (FDIC) insured deposit limit of \$250,000 per financial institution. At August 31, 2022 and 2021, the Plan's cash balance held at a commercial bank exceeded the FDIC limit by approximately \$43,000 and \$8,000, respectively. The Plan has not experienced any losses through the date when the financial statements were available to be issued.

Contributions receivable - employee: Contributions receivable represent amounts due from the participants for premium equivalents.

Contributions advance: Contributions advance represents amounts paid by the Company in excess of amounts due for premiums and prevailing wage contributions.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: Management has evaluated subsequent events for disclosure in these financial statements through June 26, 2025, which is the date the financial statements were available to be issued.

- 3. Administrative expenses** The Plan pays administrative expenses that consist primarily of fees paid to third-party administrators, as well as other professional service fees to administrative service providers. These payments qualify as exempt party-in-interest transactions.
- 4. Tax status** The trust established to hold the Plan's assets has not applied for exemption from federal or state income taxes and is currently subject to income tax on its net investment income. No federal or state taxes are payable for 2022 or 2021, therefore there is no provision for income taxes in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. Plan
termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants.
