### **Opinion**

We have audited the accompanying financial statements of New Hampshire Bankers Association Insurance Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the years then ended and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Basis for Opinion**

### Note 1: Description of the Trust

The following description of the New Hampshire Bankers Association Insurance Trust (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's benefits and other provisions.

The Plan is a defined benefit health and welfare plan which provides a variety of benefit programs (medical, dental, life, accident and disability) to 16 member banks, covering approximately 1,125 participants as of December 31, 2024, and 15 member banks, covering approximately 1,060 participants as of December 31, 2023. Billings to member employers are handled by a third-party administrator and premiums are remitted based upon the billings. Medical premiums are remitted directly to the Plan while dental, vision and life premiums are remitted to the insurance companies who provide the benefits, however, the Plan records these premiums as income and expense in accordance with generally accepted accounting principles in the United States of America (GAAP). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan allows for benefits offered under the Plan to be fully insured, partially insured, or self-funded. Medical coverage offered through the Plan is partially insured with an individual member level and aggregate stop loss policy that will insure benefits above certain levels. Under the stop loss policy, the provider pays claims in excess of \$250,000 and \$200,000 during 2024 and 2023, respectively, per individual for individual claims and the total minimum aggregate attachment point is approximately \$10.4 million and \$8 million in 2024 and 2023, respectively. The Trust reduced claims paid by approximately \$258,000 by amounts due under the policy in 2024 and \$586,000 in 2023. In 2024, the Trust also reduced premiums paid by approximately \$116,000 for amounts due under the policy. All other welfare benefits offered are fully insured through various insurance companies.

Although it has not taken any steps to do so, the Plan's management has the right under the Plan to amend and terminate the Plan with written notice, at any time and with unanimous consent of all Trustees and concurrence of a majority of participating employers, to the participating member companies subject to the provisions set forth in ERISA. In the event of the termination of the Plan, any remaining funds shall be used for the benefit of the covered employees on the basis of objective and reasonable standards. In no event shall any of the Plan's funds revert to or be recoverable by the participating member banks.

Participant eligibility for any month is dependent on the participant being an employee or qualified retiree of a member of the Plan. Each employer can set its own eligibility requirements for its employees or retirees (if applicable).

### Note 2: Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with GAAP.

#### **Use of Estimates**

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

#### **Cash and Cash Equivalents**

The Plan considers all highly liquid debt investments purchased with a maturity of three months or less to be cash equivalents.

The Plan maintains its cash balances at one financial institution. The Plan customarily has amounts on deposit in excess of the maximum Federal Deposit Insurance Coverage of \$250,000. The Plan has not experienced any losses in such accounts, and believes it is not exposed to any significant credit risk on cash.

#### **Stop Loss Receivable**

Under the stop loss policy, claims are incurred and paid by the Plan and claims data is automatically sent from the claims processor to the stop loss provider. Claims are reviewed for reimbursement and paid back to the Plan upon approval. At December 31, 2024 and 2023, there was \$33,129 and \$225,335, respectively, in claims reimbursement receivables under the policy. At December 31, 2024, there was \$115,814 in dividend reimbursements receivables under the policy.

#### **Contributions**

Members are billed monthly for contributions. Contributions received prior to the month for which they apply are reflected as "deferred income" in the accompanying financial statements, if applicable. Any adjustments to coverage provided after a monthly invoice is generated are generally adjusted in the subsequent month. Participant contributions represent amounts paid by terminated employees for continuation of benefits upon termination through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

#### **Premiums Paid and Payable**

Premiums paid are based on contracts with the insurance providers. Premium obligations are those premiums incurred and payable under the contract prior to December 31 but not yet paid. There were \$2,447,179 and \$2,361,426 of premiums incurred and paid during the years ended December 31, 2024 and 2023, respectively. There were no premium obligations at December 31, 2024 or 2023.

#### **Benefits Payable and Estimated Benefits Incurred But Not Reported**

Benefits payable represents medical claims received but not paid as of the year end date.

Estimated benefits incurred but not reported (IBNR), represents anticipated claims for medical benefits as of year end, based upon past experience.

#### **Income Taxes**

The underlying plan has qualified as a tax-exempt organization under Internal Revenue Code Section 501(c)(9). The Plan intends to continue to comply with all requirements necessary to maintain its tax-exempt status. The Plan could be subject to unrelated business income, primarily investment income in excess of a standard deduction. The Plan is also exempt from state income taxes by virtue of its ongoing exemption from federal income taxes.

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable tax authorities. The Plan's management has analyzed the tax positions taken by the Plan and has concluded that through December 31, 2024, there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

### **Note 3: Related-Party and Party-in-Interest Transactions**

The Plan is related by overlapping management to the New Hampshire Bankers Association (NHBA) and New Hampshire Bankers Services, LLC (NHBS). The Plan provides health and welfare benefits to participating employees of NHBA. Member contributions collected from NHBA amounted to approximately \$49,000 and \$47,000 for 2024 and 2023, respectively. Commissions on the premiums collected by the insurance provider are paid directly by the insurance provider to NHBS as the insurance broker of record. Commissions received by NHBS amounted to approximately \$72,000 and \$61,000, for the years ended December 31, 2024 and 2023, respectively. Under a shared services agreement, the Plan pays NHBS for administrative support costs that exceed the commissions received by NHBS. For the years ended December 31, 2024 and 2023, the Plan recognized allocated payroll for these administrative services of \$0 and \$42,951, respectively.

The Board of Trustees are officers of various financial institutions which are participating members of the Plan. Member contributions collected from these financial institutions amounted to approximately \$6,100,000 and \$6,500,000 for 2024 and 2023, respectively.

The Plan also has arrangements with various service providers. These transactions qualify as party-in-interest transactions under ERISA. Payments to parties-in-interest for the years ended December 31, 2024 and 2023, included \$0 and \$31,410, respectively, paid to USI Insurance Services LLC for consulting fees, \$137,000 and \$95,625, respectively, paid to The Richards Group for consulting fees, as well as \$287,650 and \$271,848, respectively, paid to Anthem Blue Cross Blue Shield for administrative services which were offset by pharmacy rebates.

### Note 4: Letter and Line of Credit

The Plan has a letter of credit with a bank in the amount of \$100,000 for the benefit of the New Hampshire Insurance Commission. As discussed in Note 1, the Plan is partially self-insured and the letter of credit is required under state statute for the benefit of covered employees of the member employers and their dependents and can only be accessed by the New Hampshire Insurance Commission. The letter of credit is supported by a line of credit issued by the same bank for the same amount. No advances were outstanding as of December 31, 2024 and 2023. The line of credit is secured by the Plan's assets and is due on demand. Interest is charged based on the Wall Street Journal Prime Rate plus one percentage point, but will not be less than 7.75%. The letter of credit and line of credit expires on September 4, 2025.

### Note 5: Major Participating Members

For the years ended December 31, 2024 and 2023, the Plan had six and five member banks, respectively, which each accounted for more than 10% of the Plan's member contributions. During 2024 and 2023, these member banks accounted for approximately 79% and 74%, respectively, of the Plan's member contributions. No amounts were due from these member banks at December 31, 2024 and 2023.

### Note 7: Subsequent Events

Management has evaluated subsequent events through April 29, 2025, the date when the financial statements were available to be issued.

Subsequent to year end, the Plan obtained a \$500,000 line of credit from a bank for use in occasional shortfalls in working capital caused by potential insurance claims to be reimbursed by member premiums. Draws on the line will accrue interest at an annual rate of 8.5%, which is subject to change.
