## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Central Employees' Savings and Profit Participation Plan (the "Savings Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Savings Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Note 1 - Plan Description

The following description of Central Employees' Savings and Profit Participation Plan (the "Savings Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Savings Plan's provisions.

#### **General**

The Savings Plan is a defined contribution plan covering all eligible employees of Central Mutual Insurance Company (the "Company") who are age 18 or older and meet other eligibility requirements, as defined in the plan document. The Savings Plan is administered by the Central Employees' Savings and Profit Participation Plan Administrative Committee (the "Plan Administrator"). The Savings Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Savings Plan provides for employee salary deferral contributions up to a maximum of 50 percent of the participant's annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Contributions may be before tax, after tax, or Roth. Participants age 50 or older may elect to contribute additional amounts to the Savings Plan up to a maximum that is set by law and to designate catch-up contributions as a Roth 401(k) contribution or as a regular catch-up contribution. Participants may also make contributions to the Savings Plan in the form of a rollover of funds from another qualified plan.

Participants are automatically enrolled in the Savings Plan at a 5 percent salary deferral contribution rate upon meeting eligibility requirements. Participants may adjust their salary deferral contributions at their discretion subject to the limitations noted above.

The Company matches 20 percent of participant contributions on the first 5 percent of compensation deferred. Participants' catch-up contributions are not matched.

The Company may make a profit-sharing contribution in addition to the matching contribution. The profit-sharing contribution is based on a percentage of the Company's consolidated net income after dividends to the policyholders but before federal income taxes, as defined by the Savings Plan, and is recognized in the year of service. The profit-sharing contribution is approved by the Company's board of directors. Profit-sharing contributions of \$434,459 were remitted to the Savings Plan subsequent to December 31, 2024 related to the 2024 plan year. Profit-sharing contributions of \$933,113 were remitted to the Savings Plan during 2024 related to the 2023 plan year.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Savings Plan.

#### **Benefit Payments**

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

### Note 1 - Plan Description (Continued)

The Savings Plan also provides for certain other withdrawals. After two full years of participation, a participant may make withdrawals from the after-tax portion of his or her account, subject to certain limitations, as defined in the plan document. Company contributions made prior to December 31, 1995 are available for in-service withdrawal. Company contributions made subsequent to December 31, 1995 are not available for in-service withdrawal.

#### ***Vesting***

Participants' contributions, the employer match contribution, and the employer profit-sharing contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000, reduced by the highest outstanding note receivable balance during the 12 months prior to the effective date of the note receivable. Notes receivable are collateralized by the participant's account balance and bear interest at the rate published in *The Wall Street Journal* as of the first business day of each quarter plus 1 percent. Principal and interest are paid ratably through semimonthly payroll deductions.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Vanguard Fiduciary Trust Company or its affiliates. Vanguard Fiduciary Trust Company is the trustee of the Savings Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Savings Plan to discontinue its contributions at any time and to terminate the Savings Plan subject to the provisions set forth in the plan agreement and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Savings Plan's investments are stated at fair value.

See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Savings Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including June 10, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Vanguard Fiduciary Trust Company (the "Trustee") holds the Savings Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Savings Plan has the ability to access.

#### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### *Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Savings Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 1 - Plan Description

The following description of Central Employees' Savings and Profit Participation Plan (the "Savings Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Savings Plan's provisions.

#### **General**

The Savings Plan is a defined contribution plan covering all eligible employees of Central Mutual Insurance Company (the "Company") who are age 18 or older and meet other eligibility requirements, as defined in the plan document. The Savings Plan is administered by the Central Employees' Savings and Profit Participation Plan Administrative Committee (the "Plan Administrator"). The Savings Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Savings Plan provides for employee salary deferral contributions up to a maximum of 50 percent of the participant's annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Contributions may be before tax, after tax, or Roth. Participants age 50 or older may elect to contribute additional amounts to the Savings Plan up to a maximum that is set by law and to designate catch-up contributions as a Roth 401(k) contribution or as a regular catch-up contribution. Participants may also make contributions to the Savings Plan in the form of a rollover of funds from another qualified plan.

Participants are automatically enrolled in the Savings Plan at a 5 percent salary deferral contribution rate upon meeting eligibility requirements. Participants may adjust their salary deferral contributions at their discretion subject to the limitations noted above.

The Company matches 20 percent of participant contributions on the first 5 percent of compensation deferred. Participants' catch-up contributions are not matched.

The Company may make a profit-sharing contribution in addition to the matching contribution. The profit-sharing contribution is based on a percentage of the Company's consolidated net income after dividends to the policyholders but before federal income taxes, as defined by the Savings Plan, and is recognized in the year of service. The profit-sharing contribution is approved by the Company's board of directors. Profit-sharing contributions of \$434,459 were remitted to the Savings Plan subsequent to December 31, 2024 related to the 2024 plan year. Profit-sharing contributions of \$933,113 were remitted to the Savings Plan during 2024 related to the 2023 plan year.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Savings Plan.

#### **Benefit Payments**

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

### Note 1 - Plan Description (Continued)

The Savings Plan also provides for certain other withdrawals. After two full years of participation, a participant may make withdrawals from the after-tax portion of his or her account, subject to certain limitations, as defined in the plan document. Company contributions made prior to December 31, 1995 are available for in-service withdrawal. Company contributions made subsequent to December 31, 1995 are not available for in-service withdrawal.

#### ***Vesting***

Participants' contributions, the employer match contribution, and the employer profit-sharing contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000, reduced by the highest outstanding note receivable balance during the 12 months prior to the effective date of the note receivable. Notes receivable are collateralized by the participant's account balance and bear interest at the rate published in *The Wall Street Journal* as of the first business day of each quarter plus 1 percent. Principal and interest are paid ratably through semimonthly payroll deductions.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Vanguard Fiduciary Trust Company or its affiliates. Vanguard Fiduciary Trust Company is the trustee of the Savings Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Savings Plan to discontinue its contributions at any time and to terminate the Savings Plan subject to the provisions set forth in the plan agreement and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Savings Plan's investments are stated at fair value.

See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Savings Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including June 10, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Vanguard Fiduciary Trust Company (the "Trustee") holds the Savings Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Savings Plan has the ability to access.

#### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### *Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Savings Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

## Independent Auditor's Report

To the Plan Administrator

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Central Employees' Savings and Profit Participation Plan (the "Savings Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Savings Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Savings Plan; and determining that the Savings Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Savings Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

### ***Auditor's Responsibilities for the Audits of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that audits conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

### Note 1 - Plan Description

The following description of Central Employees' Savings and Profit Participation Plan (the "Savings Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Savings Plan's provisions.

#### **General**

The Savings Plan is a defined contribution plan covering all eligible employees of Central Mutual Insurance Company (the "Company") who are age 18 or older and meet other eligibility requirements, as defined in the plan document. The Savings Plan is administered by the Central Employees' Savings and Profit Participation Plan Administrative Committee (the "Plan Administrator"). The Savings Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Savings Plan provides for employee salary deferral contributions up to a maximum of 50 percent of the participant's annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Contributions may be before tax, after tax, or Roth. Participants age 50 or older may elect to contribute additional amounts to the Savings Plan up to a maximum that is set by law and to designate catch-up contributions as a Roth 401(k) contribution or as a regular catch-up contribution. Participants may also make contributions to the Savings Plan in the form of a rollover of funds from another qualified plan.

Participants are automatically enrolled in the Savings Plan at a 5 percent salary deferral contribution rate upon meeting eligibility requirements. Participants may adjust their salary deferral contributions at their discretion subject to the limitations noted above.

The Company matches 20 percent of participant contributions on the first 5 percent of compensation deferred. Participants' catch-up contributions are not matched.

The Company may make a profit-sharing contribution in addition to the matching contribution. The profit-sharing contribution is based on a percentage of the Company's consolidated net income after dividends to the policyholders but before federal income taxes, as defined by the Savings Plan, and is recognized in the year of service. The profit-sharing contribution is approved by the Company's board of directors. Profit-sharing contributions of \$434,459 were remitted to the Savings Plan subsequent to December 31, 2024 related to the 2024 plan year. Profit-sharing contributions of \$933,113 were remitted to the Savings Plan during 2024 related to the 2023 plan year.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Savings Plan.

#### **Benefit Payments**

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

### Note 1 - Plan Description (Continued)

The Savings Plan also provides for certain other withdrawals. After two full years of participation, a participant may make withdrawals from the after-tax portion of his or her account, subject to certain limitations, as defined in the plan document. Company contributions made prior to December 31, 1995 are available for in-service withdrawal. Company contributions made subsequent to December 31, 1995 are not available for in-service withdrawal.

#### ***Vesting***

Participants' contributions, the employer match contribution, and the employer profit-sharing contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000, reduced by the highest outstanding note receivable balance during the 12 months prior to the effective date of the note receivable. Notes receivable are collateralized by the participant's account balance and bear interest at the rate published in *The Wall Street Journal* as of the first business day of each quarter plus 1 percent. Principal and interest are paid ratably through semimonthly payroll deductions.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Vanguard Fiduciary Trust Company or its affiliates. Vanguard Fiduciary Trust Company is the trustee of the Savings Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Savings Plan to discontinue its contributions at any time and to terminate the Savings Plan subject to the provisions set forth in the plan agreement and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Savings Plan's investments are stated at fair value.

See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Savings Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including June 10, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Vanguard Fiduciary Trust Company (the "Trustee") holds the Savings Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Savings Plan has the ability to access.

#### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### *Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Savings Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 4 - Fair Value Measurements (Continued)

The following valuation methodologies have been used to value the Savings Plan's investments:

#### **Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

#### **Common/Collective Trust Funds**

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.
