Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Allesco Industries, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Allesco Industries, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering substantially all employees of Allesco Industries, Inc. (the Company) who have attained age twenty-one, as defined in the plan agreement. The Plan is qualified under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may voluntarily contribute up to 92% of pre-tax annual compensation, as defined in the plan agreement, not to exceed the dollar limitations as established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing rollover contributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for auto-enrollment whereby all newly eligible employees are automatically enrolled in the Plan once eligibility requirements are met, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated allocation fund until changed by the participant. Unless such participants affirmatively elect otherwise, their deferral rate will increase annually by 1% until a deferral rate of 10% is reached.

The Plan provides for an annual safe harbor matching contribution equal to 100% of participant elective deferrals, up to 3% of their eligible compensation plus 50% of participant elective deferrals greater than 3% but less than or equal to 5% of their eligible compensation. The Company may also make discretionary matching and profit-sharing contributions. For the year ended December 31, 2024, no discretionary matching or profit-sharing contributions were made.

Participant Accounts

Each participant's account is credited with the participant's and employer contributions, and an allocation of (a) Plan net earnings or net losses and (b) administrative expenses of the Plan if not paid by the Company. Allocations are based on participant compensation or account balances, as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, the safe harbor matching contributions plus actual earnings thereon, and discretionary matching and profit-sharing contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their elected deferral and rollover account balance. Interest rates on outstanding balances are calculated at the prime interest rate, as published by The Wall Street Journal, plus 1%. As of December 31, 2024, the outstanding notes bear interest at rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant, or their beneficiary, may elect to receive the value of the participant's vested interest in his or her account in a lump-sum payment or periodic installments, in accordance with the plan agreement.

Upon termination, if a participant's vested account balance does not exceed \$5,000 and the participant does not elect to take a distribution, the plan administrator may make a lump-sum distribution.

Early Withdrawals

Prior to termination of employment, disability or death, participants may make in-service withdrawals from their accounts upon written request to the plan administrator. Participants who have attained age 59½ may make a discretionary withdrawal from their eligible account balance, as defined in the plan agreement. In the event of serious financial hardship, participants may elect to withdraw up to 100% of the value of their eligible account balance, as defined in the plan agreement.

Forfeited Accounts

As of December 31, 2024 there were no forfeited accounts. As of December 31, 2023, forfeited accounts totaled approximately \$900. Forfeited accounts are held in a separate account within the Plan and will be used to reduce future employer contributions or to offset administrative expenses. Also, in 2024, administrative expenses were reduced by approximately \$900 using forfeited accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by its investment advisor and Reliance Trust, the Plan's Custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. An

allowance for credit losses was not considered necessary as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses such as those related to recordkeeping services, in-service withdrawals and hardship distributions from participants are charged directly to participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through June 27, 2025, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund – Valued at the net asset value of shares held by the Plan at year end.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust – A Stable Value Fund issued by T. Rowe Price Trust Company that is valued daily at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

The Stable Value Fund is a common/collective investment trust fund managed by T. Rowe Price which invests in a variety of investment contracts such as guaranteed investment contracts issued by insurance companies and other financial institutions and other investment products and other similar investments that are intended to maintain a constant net asset value while permitting participant-initiated, benefit-responsive withdrawals for certain

events. Participants ordinarily may direct withdrawals or transfer all or a portion of the investment at contract value.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

5. TRANSACTIONS WITH PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor (DOL) Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. For the year ended December 31, 2024, the Plan's transactions with parties-in-interest are related to administrative expenses and recordkeeping fees paid to the following parties-in-interest: Reliance Trust, the Custodian of the Plan, T. Rowe Price Retirement Plan Services, the recordkeeper of the Plan, and Retirement Resources, the investment advisor to the Plan. Investment management fees associated with each mutual fund are included as a reduction of the return earned by each fund. Also, certain officers and employees of the plan sponsor, who are also plan participants, perform administrative services on behalf of the Plan at no cost to the Plan.

6. TAX STATUS OF THE PLAN

On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as then designed, qualifies under the applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or the DOL. The Plan is subject to routine audits by the IRS and the DOL; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

Investment Risks

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. PLAN FINANCIAL INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust, the Custodian of the Plan.
