Independent Auditors' Report

To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of 403(b) Thrift Plan for Employees of Florida West Coast Symphony, Inc. d/b/a Sarasota Orchestra ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Notes to Financial Statements

December 31, 2024 and 2023

(1) Description of Plan

The following description of the 403(b) Thrift Plan for Employees of Florida West Coast Symphony, Inc. d/b/a Sarasota Orchestra (the “Plan”) is provided for general information purposes. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan was adopted effective January 1, 1998 and is sponsored by Florida West Coast Symphony, Inc. d/b/a Sarasota Orchestra (the “Organization”).

(a) General

The Plan is a defined contribution plan covering all eligible employees. The Plan provides retirement and death benefits to eligible participants. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan operates under a group annuity contract with Mutual of America Life Insurance Company (“MOA”), who serves as trustee of the Plan.

(b) Contributions

Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

For both collectively bargained and non-collectively bargained employees, the Organization contributes to the Plan an employer base contribution equal to 4% to 5%, based on certain eligibility criteria, of the participant’s compensation as defined by the Plan. The Organization’s contribution is also invested as directed by participants.

Each Participant who has satisfied the age and service requirement shall be entitled to receive an allocation of employer matching contributions for each plan year equal to 50% of his or her employee deferral not to exceed 4% of their compensation.

(c) Participant Investment Account Options

The Plan currently offers various pooled separate accounts and a general account as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

(1) Description of Plan - Continued

(d) Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's contributions and an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined.

(e) Vesting

Participants are immediately vested in their elective deferral contributions and the Organization's contributions, plus actual earnings thereon.

(f) Payment of Benefits

The Plan provides for the payment of benefits in the form of either a single lump sum payment or in installments as defined in the Plan under the specified payments option, upon termination, retirement, death, or disability. Financial hardship withdrawals are also permitted.

As a result of the Bipartisan Budget Act of 2018, participants are not required to exhaust loan distributions prior to receiving a hardship distribution. Additionally, participants are not suspended from making contributions to the Plan as a result of a hardship withdrawal.

(g) Notes Receivable from Participants

Loans are available to participants through MOA, subject to certain limitations. Plan loans are issued directly from the funds owned by MOA and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's MOA Interest Accumulation Account balance (a general account obligation of MOA) is reserved, or held as collateral, to cover the outstanding loan amount for the period of time the loan is outstanding. See Note 6 for discussion of the MOA general account. For active loans, investments equal to 120% of the outstanding loan amount are reflected in the statements of net assets available for benefits and serve as collateral for the loan. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution event occurs. At December 31, 2024 and 2023, participants had outstanding Plan loan balances due to MOA of approximately \$18,000 and \$28,000, respectively.

(2) Summary of Significant Accounting Policies

(a) Accounting Basis

The financial statements of the Plan are presented on the accrual basis.

(b) Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Under the group annuity contract, participant contributions are deposited into Separate Account No. 2 or General Account. Separate Account No. 2 consists of investment funds that invest in mutual funds registered with the Securities and Exchange Commission and are carried at the net asset value at which the mutual fund shares are actively traded. Contributions into the General Account are completely liquid, with no front or back end charges, requests for withdrawals are processed daily, and there are no deferred sales charges, load assessments or interest rate adjustments that affect the value as a result of withdrawal request.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(c) Payment of Benefits

Benefits are recorded when paid.

(d) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes therein during the period. Actual results could differ from those estimates.

(e) Contributions

Contributions from Plan participants and the matching contributions from the Organization are recorded in the year in which the employee contributions are withheld from compensation.

(f) Reclassification

Certain items from the 2023 financial statements have been reclassified to conform with the 2024 presentation. Such reclassifications had no effect on the total net assets available for benefits.

(3) Income Tax Status

The Plan is intended to comply with the applicable requirements of Section 403(b) of the Internal Revenue Code, as amended. The Plan has adopted a prototype plan. The prototype plan obtained its latest opinion letter on March 31, 2017, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The prototype plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the prototype plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and is thus exempt from federal income taxes under the provisions of Section 401(a).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(4) Information Prepared and Certified by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, MOA, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Interest income of general account
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(5) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (ASU) Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan’s assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: The Plan Sponsor has assessed pooled separate accounts at Level 1, based on information provided by MOA. The individual pooled separate accounts represent investments within the Separate Account No. 2 which are determined and published based on the value at which the underlying mutual fund shares are actively traded. There are no unfunded commitments. The redemption frequency (if currently eligible) is daily. The redemption notice period is one day.

General Account: General account is an investment option similar to a cash equivalent or money market fund, in which the fund is highly liquid and credited with a stated interest rate (2.85% at December 31, 2024).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(6) Party-in-Interest Transactions

The Plan's expenses are paid either by the Plan or the Organization, as provided in the plan document. Expenses that are paid directly by the Organization, such as professional fees and recordkeeping fees, are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of separate account investments presented in the accompanying statement of changes in net assets available for benefits, as they are paid through revenue sharing rather than direct payment.

MOA manages certain shares of mutual funds included in the pooled separate account investments. MOA also provides certain operating and administrative services to the Plan. As such, MOA is considered to be a party-in-interest and related investment expenses qualify as party-in-interest transactions. Fees paid by the Plan to MOA of \$1,169 for the year ended December 31, 2024 are considered to be party-in-interest transactions.

(7) Plan Termination

Although it has not expressed any intent to do so, the Organization has the right to amend, modify, suspend or terminate the Plan or contributions thereunder provided no such action shall adversely affect participants to the extent of their vested benefits subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested in their accounts.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Plan investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain Plan investments, it is at least reasonably possible that changes in the value of Plan investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) Subsequent Events

The Plan evaluated subsequent events through June 25, 2025, the date the financial statements were available for issuance.
