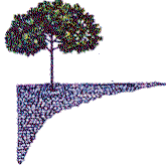

## Independent Auditor's Report

To the Plan Administrator of  
Greater New Bedford Community Health Center, Inc. 403(b) Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Greater New Bedford Community Health Center, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Greater New Bedford Community Health Center, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### 1. DESCRIPTION OF PLAN

The following description of Greater New Bedford Community Health Center, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution plan covering all employees of Greater New Bedford Community Health Center, Inc. (the Plan Sponsor) (the Health Center). The Investment Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan Sponsor's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### b. Eligibility

All employees are eligible to participate in the Plan on their first day of employment with the Plan Sponsor. Employees are also eligible for any Plan Sponsor discretionary matching and discretionary non-elective contributions upon completing one year of service (with at least 1,000 hours). Effective October 1, 2023, the Plan was amended to lower the age requirement to receive the Plan Sponsor's discretionary matching and non-elective contributions from twenty-one to eighteen years old. Additionally, participants must be scheduled to work 20 hours per week in order to receive the discretionary matching contribution on a per pay period basis. If participants are not expected to work 1,000 hours during the plan year, participants will receive the discretionary matching contribution following the end of the plan year if they worked over 1,000 hours.

#### c. Contributions

Each year, participants may contribute a percentage up to 100% of pre-tax annual compensation, subject to Internal Revenue Service (IRS) limitations, as defined by the plan document. The Plan allows for participants to make post-tax (Roth) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions).

Employees of the Health Center who do not affirmatively elect otherwise are automatically enrolled into the Plan. Employees who are automatically enrolled default to deferral contributions in the amount of 1%, unless the participant elects otherwise. Effective October 1, 2024, an amendment was executed to include an auto-escalation provision whereby the deferral percentage is increased by 1% on October 1st of each year for any participant who was automatically enrolled until reaching 6%, unless the participant elects otherwise.

The Plan Sponsor may make discretionary matching and discretionary non-elective contributions, which are determined annually by the Plan Sponsor's Board of Directors. For the year ended September 30, 2024, the discretionary matching contribution was equal to 50% of the participant's salary deferral that does not exceed 6% of eligible compensation. During 2024, the Plan Sponsor contributed \$276,164 of discretionary matching contributions. The Plan Sponsor did not elect to make any discretionary non-elective contributions for the year ended September 30, 2024.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions, the Plan Sponsor's discretionary matching and discretionary non-elective contributions, if any, and an allocation of plan earnings or losses thereon, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### e. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon. Participants vest in the value of their accounts attributable to the Plan Sponsor's discretionary matching and discretionary non-elective contributions as follows:

Less than three years of service	0%
Three or more years of service	100%

Participants who entered the Plan on or before October 1, 2017, vest in the value of their accounts attributable to the Plan Sponsor's discretionary matching and discretionary non-elective contributions as follows:

<u>Years of Credited Service</u>	<u>Vesting Percentage</u>
Less than two years of service	0%
Two years, but less than three years of service	20%
Three or more years of service	100%

Participants become fully vested upon death or disability.

#### f. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to a participant, or their beneficiary, who has reached the age of 65, with no option for early retirement. Upon termination of service, a participant may elect to receive an annuity, installment payments, or a lump-sum amount equal to the value of their account. There are also retirement benefits available upon disability and death, as provided for by the Plan's provisions. Separated participant account balances of less than \$5,000 are automatically distributed by the Plan Administrator without the participant's consent, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover, or to receive the distribution directly. Effective July 1, 2024, an amendment was executed to increase the involuntary cash-out amount from \$5,000 to \$7,000.

The Plan allows in-service withdrawals upon attainment of age 59½. A participant may also request a withdrawal from their elective deferral account balance upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

#### g. Notes Receivable from Participants

The Plan allows for participants to borrow against their accounts a minimum of \$1,000 up to a maximum of \$50,000, or one-half of the current value of the participant's vested interest in their account. Participants are allowed to have two loans outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates at the time of issuance, as determined by the Plan Administrator. Repayment of the loan must be made over a period not to exceed five years, unless the loan's purpose is to purchase a primary residence, in which case the repayment term is up to ten years. Principal and interest are paid ratably through payroll deductions.

#### h. Forfeitures

Forfeitures represent non-vested Plan Sponsor contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures are retained by the Plan and are used to reduce future Plan Sponsor discretionary matching or discretionary non-elective contributions or may be used to pay administrative expenses of the Plan. As of September 30, 2024 and 2023, there were \$16,811 and \$1,967, respectively, of unallocated forfeitures. There were \$5,208 of forfeitures used during the plan year ended September 30, 2024 to reduce employer contributions and pay plan expenses.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure and changes therein, as well as disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Investment contracts held by the Plan are required to be reported at fair value, except for fully-benefit-responsive investment contracts. Contract value is the relevant measurement attribute for fully-benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's interest in the guaranteed investment contract is stated at contract value based on information reported by the qualified institution (see Note 5).

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses are recognized as incurred upon sale or maturity of investments or based on market value changes during the period. Net appreciation of investments includes realized and unrealized gains and losses.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowances for credit losses have been recorded as of September 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of September 30, 2024, there were \$7,095 of defaulted loans that have been deemed distributed and included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

#### Contributions

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. The Plan Sponsor's discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor's Board of Directors.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to recordkeeping, investment advisory and the processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through June 25, 2025, which is the date the financial statements were available to be issued. Except for what was disclosed in Note 1c, there were no other events that met the criteria for recognition or disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (Voya), a qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of September 30, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended September 30, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs).

The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are presented within the fair value hierarchy using Level 1 inputs.

There has been no change in the valuation methodology used at September 30, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. GUARANTEED INVESTMENT CONTRACT

The Plan has a guaranteed investment contract with Voya. Voya maintains the contributions in a general account. The account is credited with participant contributions and investment income or losses and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

### 5. **GUARANTEED INVESTMENT CONTRACT** (Continued)

Because the guaranteed investment contract is fully-benefit-responsive, contract value is the relevant measure attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported by the qualified institution, represents contributions made under the contract, plus earnings or losses, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value. The contract limits the percentage of the investment for periodic elective transfers to variable investments within the Plan during any twelve-month period.

The contract is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments. The guarantee is based on the ability of the qualified institution to meet its financial obligations from the general assets of the qualified institution. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

### 6. **TAX STATUS**

The Plan Sponsor has obtained an opinion letter dated March 31, 2017, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 7. **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Health Center has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### **8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, notes receivable from participants and transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions. Fees paid by the Plan for recordkeeping and investment advisory services were \$65,398 for the year ended September 30, 2024.

### **9. RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in a number of investments. Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the accompanying statements of net assets available for benefits.


