### *Opinion on the Financial Statements*

## **NOTES TO FINANCIAL STATEMENTS**

### **DESCRIPTION OF PLAN**

The following description of the Crutchfield Corporation Employee Health Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### ***General***

The Plan provides health benefits covering substantially all active employees of Crutchfield Corporation (the Sponsor or Company).

It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### ***Benefits***

The Plan provides health benefits (medical, hospital, surgical, vision, mental health, and prescription medication) to full-time employees of the Sponsor (with at least 30 hours of service each week) and to their beneficiaries and covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

#### ***Stop Loss Coverage***

The Company has entered into a stop-loss insurance agreement in an effort to limit its exposure for self-insured benefits (individual per-participant claims over a specific dollar amount). The current stop-loss limit is set at \$100,000.

#### ***Reinsured Self-Funded Benefits***

Current health claims of active participants and their dependents and beneficiaries are provided for under reinsured self-funded arrangements. The claims for these self-funded benefits are processed by third-party administrators. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the general assets of the Company. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the plan.

#### ***Contributions***

The majority of the contributions are from the Sponsor; however, employees are also required to contribute a specified amount for the basic Plan. Employees may contribute specified amounts, determined periodically, to upgrade coverage or to add eligible dependents. The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

### **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the cash basis of accounting.

#### ***Payment of Benefits***

Claim payments are recorded when paid by the third-party processor.

#### ***Use of Estimates***

The preparation of financial statements in accordance with the cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Stop Loss***

Premiums for stop loss insurance are included in reinsurance fees in the accompanying statement of changes in net assets available for benefits (cash basis). Stop loss refunds have been netted with claims paid in the accompanying statement of changes in net assets available for benefits (cash basis).

#### ***Rebates***

Pharmacy rebates totaling \$348,938 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits (cash basis) for the year ended September 30 2024.

#### ***Subsequent Events***

Management has evaluated subsequent events for the Plan through July 1, 2025, the date the financial statements were available to be issued.

#### **CASH**

The Plan maintains its cash in bank deposit accounts which, at times, may exceed federally-insured limits. The Plan has not experienced any losses in such accounts.

### **PLAN BENEFIT OBLIGATIONS**

Plan benefit obligations incurred but not reported are estimated by Plan Sponsor and are derived from claims with service dates prior to October 1 that have not been paid as of year end. Plan benefit obligations as of September 30, 2024 and 2023 are \$739,515 and \$568,619, respectively.

Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in this estimate and assumption in the near term would be material to the financial statements.

### **ADMINISTRATIVE EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claim administrator. These expenses are reported on the statement of changes in net assets available for benefits (cash basis). All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

### **RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

### **TERMINATION OF THE PLAN**

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.
