Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

Sakura Finetek USA, Inc. 401(k) Retirement Savings Plan (the Plan) is a defined-contribution plan covering substantially all employees (Participants) of Sakura Finetek USA, Inc. (the Company). This Plan was established on January 1, 1994, to provide employees an opportunity to save for retirement by allowing them to make contributions on a tax-favored basis. The Plan was amended and restated effective May 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the Fiduciary Committee appointed by the Board of Directors of the Company.

The summary of significant provisions of the Plan presented below provides general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: All employees of an employer who has adopted the Plan can generally join the Plan, except as noted in the plan document. For making elective deferrals to the Plan or to be subject to the automatic enrollment feature of the Plan, employees are eligible after they have been employed for three months, provided they are at least 21 years of age. Actual enrollment in the Plan will occur on the first day of the month immediately following or concurrent with the date the employee satisfies those conditions, provided they are still employed with the Company on that date.

Contributions: Each participant may elect to defer up to 80% of their annual compensation. Elective deferrals can be in the form of pre-tax contributions, or special after-tax contributions known as Roth deferrals, or a combination of both. In addition, certain employees can make a special type of elective deferral known as a catch-up contribution, provided they are age 50 or older by the end of the taxable year. Elective deferrals in any year may not exceed the dollar limit set by law. Participants may change their pre-tax elective deferral rate and investment funds election at any time.

Participants may make voluntary, non-deductible, after-tax employee contributions to the Plan. The contribution limit for such contributions is 15% of compensation.

If a participant does not submit an elective deferral agreement or does not specifically decline to make elective deferrals within three months following their first day of eligible employment, the Company will automatically withhold 6% from their pay and contribute it to the Plan on the participant's behalf in the form of an automatic elective deferral. Each year, the Plan automatically increases the elective deferral rate of participants who are enrolled in the automatic deferral program. If a participant has not made an affirmative election to make or stop pre-tax or Roth elective deferrals, the Company will automatically increase their deferral percentage each year by 1% until the automatic deferral percentage has reached 10%. Participants can opt out of the automatic deferral program at any time. All highly compensated employees are excluded from the Plan's automatic deferral program, and any automatic increases thereof.

Discretionary matching contributions are contributions made to the Plan by the Company and allocated to a participant's account because they make elective deferrals. For the fiscal year ended September 30, 2024, the Company's matching contribution was 75% of participants' contributions, limited to 4% of each participant's eligible compensation.

The Company may also make qualified nonelective contributions to the Plan, which are special contributions made by the Company to help the Plan pass special discrimination tests established by ERISA and the Internal Revenue Service (IRS).

In addition, the Company may make discretionary nonelective contributions to the Plan. These contributions are made solely within the discretion of the Company. For the fiscal year ended September 30, 2024, the Company made a nonelective contribution in the amount of \$-0-.

Eligible employees can make rollover contributions to the Plan any time after they start working for the Company, regardless of their age and years of service.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are always 100% vested in their elective deferral accounts, qualified nonelective contributions account, and any rollover account they may have in the Plan.

Employer contributions are subject to a graduated vesting schedule. A participant receives a 20% vesting of their nonelective account after two years of vesting service and an additional 20% vesting for each additional year of service. Participants become 100% vested after six years of service.

Payment of Benefits: A distribution can be made to a participant if they request one due to disability, retirement, or termination of employment from the Company or any related employer. A participant's beneficiary or beneficiaries may request a distribution of their vested account balance in the event of death.

Participants may defer receipt of their distribution until a later date. However, a participant cannot postpone it if their vested account balance is \$7,000 or less in which case the Plan will direct Fidelity Management Trust Company (Fidelity), that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity (IRA) for the participant's benefit. If a participant's vested account balance is \$1,000 or less, the Plan will direct Fidelity to distribute it to the participant as a lump sum distribution without consent. Prior to such distribution participants have the right to request that the amount be distributed directly to them as a lump sum payment or to request that it be rolled-over to a different IRA provider or another retirement plan eligible to receive rollover contributions.

Participants can request an in-service distribution from certain deferrals and their earnings for any reason once they attain age 59½. The Plan also allows hardship distributions in the event of an immediate and heavy financial need.

Notes Receivable From Participants: Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their total vested account balance, reduced by their highest combined outstanding loan balance at any time during the prior 12-month period. Loans are adequately secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid ratably through regular payroll deductions over a period not to exceed five years, unless the loan is obtained to purchase a principal residence, for which the Company may permit a longer repayment period not to exceed 10 years.

Forfeitures: If a participant terminates employment with the Company and is less than 100% vested in their employer account, the participant may forfeit the non-vested portion of their employer account. Forfeitures are retained in the Plan and may first be used to pay administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the Plan. During 2024, approximately \$22,000 of forfeitures were used to offset Company matching contributions. At September 30, 2024 and 2023, forfeited accounts totaled \$55,270 and \$4,273, respectively.

Plan Termination: The Company reserves the right to terminate the Plan at any time by taking appropriate action as circumstances may dictate, with the approval of the Board of Directors. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%. The Plan administrator will facilitate the distribution of account balances in single lump-sum payments to each participant in accordance with Plan provisions until all assets have been distributed by Fidelity.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through May 30, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. If a participant ceases to make loan payments and the Company deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at September 30, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the fiscal year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Money Market Account: Fair value is estimated to approximate the cost basis of the deposit account balance, based upon the liquidity of the account and the credit quality of the issuer (Level 1 inputs).

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Fund: Valued by Fidelity using the net asset value (NAV) of the collective trust times the number of units held by the Plan. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying assets held by the fund less its liabilities.

There are no unfunded commitments related to its investments, or significant restrictions on redemptions. The Plan may redeem its investment on a daily and immediate basis.

NOTE 5 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original non-standardized pre-approved document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain other third parties. Administrative fees paid to third-party providers are considered party-in-interest transactions. Certain professional fees for the administration and audit of the Plan are paid by the Company. Various administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan held investments managed by Fidelity. Fidelity is a service provider of the Plan, and, therefore, these transactions and the Plan's payment of fees to the service provider qualify as party-in-interest transactions. Notes receivable from participants are also party-in-interest transactions.
