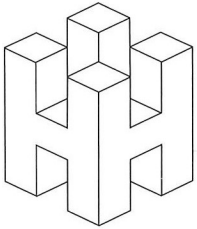

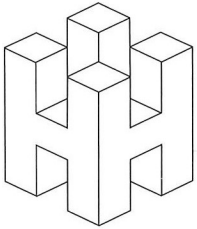

Note 1 - DESCRIPTION OF PLAN

The following description of the Morningside University Defined Contribution Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a money purchase pension plan covering all full-time employees of Morningside University (the Employer), who have one year of service, complete 1,000 hours of service during the Plan year, and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - There are no more employee contributions into the plan due to not having any active employees. Participants may contribute amounts representing distributions from other defined contribution plans (rollovers). Morningside declines to make any further contributions, and no employee contributions are allowed.

Participant Accounts - Each participant's account is credited with Employer's contributions, as well as an allocation of Plan earnings and charged with withdrawals and an allocation of Plan losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting - Participants are immediately vested in the employer's contributions plus actual earnings thereon.

Payment of Benefits - On termination of service due to death, disability or retirement on or after age 65, a participant may elect to receive a lump-sum distribution. Partial withdrawals are only permitted for required minimum distribution purposes.

Recent Legislative Update - On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

Note 2 - SUMMARY OF ACCOUNTING POLICIES

The Plan follows accounting standards set by the Financial Accounting Standards Board, commonly referred to as the FASB. The FASB sets generally accepted accounting principles (GAAP) that the Plan follows to ensure we consistently report Net Assets Available for Benefits and Changes in Net Assets Available for Benefits. References to GAAP issued by the FASB in these footnotes are to the *FASB Accounting Standards Codification*, sometimes referred to as the Codification or ASC.

Note 2 - SUMMARY OF ACCOUNTING POLICIES

(Cont.) The following are the significant accounting policies followed by the Plan.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition - The plan's investments are reported at fair value, except for fully benefit-responsive investments contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The investment committee determines the Plan's valuation policies. Net appreciation (decline) in the fair value of investment is based on the fair value of investments at the beginning of the year, or cost if purchased during the year. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Investment trade-related expenses are included in net appreciation of fair value of investments.

Reclassifications - Certain items from the prior year have been classified to enhance comparability with current year information.

Note 3 - INVESTMENTS (UNAUDITED)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from the trustees of the Plan that all of the information is complete and accurate. Information included in the accompanying financial statements as to investments, investment income, and all information in the supplemental schedule is presented in reliance solely upon those certifications.

Note 3 - INVESTMENTS (UNAUDITED)

(Cont.) Fair Value Measurements - FASB Accounting Standards Codification 820 defines fair value, establishes a framework for measuring fair value in Generally Accepted Accounting Principles and establishes a hierarchy that categorizes and prioritizes the inputs to be used to estimate fair value. The three levels of inputs used are as follows:

- * Level 1 - Quoted prices in active markets for identical assets or liabilities.
- * Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly such as outside comparable sales.
- * Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Traditional Annuity: Valued using a discounted cash flow model.
Mutual Funds: Valued at the daily closing price as reported by the fund.

Note 4 - STABLE VALUE INVESTMENT CONTRACTS

The plan invests in a guaranteed Stable Value investment issued by TIAA Cref Financial Services. TIAA Cref maintains the contributions in a general account. The objective of a stable value fund is to preserve capital and achieve a competitive level of income over time. In addition, it strives to maintain a \$1 per unit price, but cannot assure it will do so. A stable value fund returns to its shareholder's income earned by the fund's investments after expenses. Although individual investment contracts within the Portfolio represent credit obligation of the issuer, units of the Portfolio are neither guaranteed by TIAA Cref Financial Services or the Plan Sponsor, nor are they insured by the FDIC or any other state or federal agency.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, the contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, is reported to the Plan by TIAA Cref, represents the sum of benefits owed to participants in the fund. For a particular participant in the fund, the contract value is equal to the sum of the participant's invested principal plus all accrued interest. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024, and 2023, was \$159,736 and \$153,205 respectively. The portfolio invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements), enter into "wrap" contracts issued by third parties, and invests in cash equivalents represented by shares in money market funds. TIAA Cref seeks to minimize the exposure of the portfolio to wrap credit risk through among other means, diversification of the wrap contracts across an approved group of issuers. The Portfolio's ability to receive amounts due pursuant to these contracts is dependent upon the issuer's ability to meet their financial obligations.

Certain events might limit the Plan's ability to transact at contract value with TIAA Cref. Such events include the following: (a) Amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that an event that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Note 5 - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan pays several vendors for record keeping, administrative services, claims processing, custodianship of its investments, benefit consulting services, legal services, and audit services. Transactions with the providers of these services would be considered to be transactions with parties in interest. Further, the Plan receives contributions from the participants' employers and those contributions would also constitute transactions with parties in interest.

Note 6 - FEDERAL INCOME TAX STATUS

The Plan obtained its latest determination letter on October 7, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management has concluded that any uncertain tax positions would be immaterial to the financial statements taken as a whole. Accordingly, the accompanying financial statements do not include any provision for uncertain tax positions, and no related interest or penalties have been recorded in the statement of changes in net assets available for benefits or accrued in the statement of net assets available for benefits.

Note 7 - TERMINATED PARTICIPANTS

Account balances allocated to terminated participants that had not been paid at December 31, 2024 and 2023 totaled \$9,732,543 and \$9,586,717, respectively. These amounts represent terminated participants' vested account balances that had not yet been paid at year end. For financial statement purposes, these amounts are included in net assets available for benefits.

Note 8 - SUBSEQUENT EVENTS

In preparing the financial statements, the Plan has evaluated all subsequent events, for potential recognition or disclosure, through June 26, 2025, the date the financial statements were available to be issued.
