## INDEPENDENT AUDITORS' REPORT

To the Retirement Plan Committee of

### HEALTH SERVICES ADVISORY GROUP 401(k) PLAN

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of *Health Services Advisory Group 401(k) Plan* (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

#### Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

December 31, 2024 and 2023

### (1) Description of the Plan

The following description of the *Health Services Advisory Group 401(k) Plan* (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General** - The Plan is a prototype defined contribution plan which covers all employees who meet specified service requirements of Health Services Holdings, Inc. (the "Sponsor"). The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective January 1, 2024, the Plan was amended to change the Plan name from Health Services Holdings, Inc. 401(k) Plan to Health Services Advisory Group 401(k) Plan.

- B. Eligibility** - Employees who have completed three months of service and have attained 21 years of age are eligible to participate in the Plan. Employees who have completed 1,000 or more hours of services in a period of twelve consecutive months and have attained 21 years of age are eligible to receive employer contributions.

- C. Contributions** - Contributions to the Plan are made as directed by the participants. Participants may contribute from 1% to 100% of their compensation on a pre-tax or after-tax (Roth) basis, as defined by the Plan, subject to certain limitations prescribed by the Internal Revenue Service ("IRS"). Roth elective deferrals are treated in the same manner as elective deferrals for all Plan purposes. Participants may also contribute amounts representing distributions from other qualified pension plans.

Effective January 1, 2024, the Plan was amended to change the employer matching contributions from a discretionary to a stated match formula equal to 100% of the first 4% of compensation deferred. The Plan also contains provisions for profit-sharing contributions. Contributions under the profit-sharing portion of the Plan are made at the discretion of the Sponsor. There were no profit-sharing contributions authorized for 2024.

- C. Participant accounts** - Each participant's account is credited with the participants' contributions, the Sponsor's matching contributions, and an allocation of the Sponsor's profit-sharing contributions, Plan earnings, and forfeitures. Allocations are based on participant contributions or account balances. Allocations of the Sponsor's profit-sharing contributions are made to participants employed on the last day of the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- D. Vesting** - Participants are immediately vested in their voluntary and rollover contributions, plus accrued earnings thereon. Participants vest in the Sponsor's matching and profit-sharing contributions, plus actual earnings thereon, based on years of service as follows:

The Plan defines a year of credited service to be a Plan year with the participant rendering at least 1,000 hours of service.

**E. Payment of benefits** - In general, distributions from the Plan will be made in one lump-sum payment in cash. If the value of a participant's vested benefit is more than \$7,000 on termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum payment amount equal to the value of his or her account, or annual installments over a certain period, and in no event exceeding the life expectancy of the participant as determined at the time of distribution. If the value of a participant's vested benefit is \$7,000 or less, a lump sum payment will be made to the participant.

The Plan provides for the payment of benefits in amounts up to the entire vested balance in a participant's account upon one of the following:

- a. Termination of employment
- b. Death or disability of participant
- c. Attainment of age 59½
- d. Demonstrated hardship

**F. Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable must be repaid over a term not to exceed five years from the date the proceeds are received unless the entire proceeds are used to purchase the participant's primary residence, in which case the repayment period may extend to 10 years or the repayment period currently in effect for a commercial home loan. Notes receivable are secured by the balance in the participant's account and bear interest at a rate comparable to rates available at commercial lending institutions. Generally, notes receivable from participants are repaid through payroll deductions.

**G. Forfeitures** - Forfeitures of nonvested accounts are utilized to pay administrative expenses and employer contributions as required by the Plan agreement. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$46,370 and \$7,767, respectively. During the year ended December 31, 2024, \$351 and \$91,457 of forfeited nonvested accounts were used to pay administrative expenses and fund employer contributions, respectively.

**H. Administrative expenses** - The Sponsor has elected to pay certain administrative expenses on behalf of the Plan. The Plan has no obligation to reimburse the Sponsor for such expenses. Participant loan origination fees are charged to the account of the participant requesting the loan.

**I. Plan termination** - Although it has not expressed any intent to do so, the Sponsor has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event the Plan is terminated, each participant's account becomes 100% vested.

### (2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** - The accompanying financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

**Management's use of estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management of the Plan to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Actual results may differ from those estimates.

### (2) Significant accounting policies (continued)

**Risks and uncertainties** - The Plan provides for various investment fund options which, in turn, invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. The Plan's exposure to credit losses in the event of nonperformance of investments is limited to the carrying value of such investments. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Investment valuation and income recognition** - Mutual funds are reported at fair value, and the pooled separate accounts and common/collective trusts ("CCTs") are reported at net asset value ("NAV") as a practical expedient. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Following is a description of the valuation methodologies used for the investments held by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds - Stated at net asset values, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.
- CCTs and pooled separate accounts - CCTs and pooled separate accounts are based upon the current fair values of the underlying assets of the funds, or the equivalent of net asset value, which is a practical expedient for estimating fair value. These investments have no unfunded commitments as of December 31, 2024 and 2023 and can be redeemed daily with no redemption notice period or other redemption restrictions.

**Fair value measurement** - The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. If a Level 1 input is available, it must be used.
- Level 2: Inputs other than quoted prices that are observable for assets or liabilities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means.
- Level 3: Unobservable inputs, which contain assumptions by the party valuing those assets or liabilities. For Level 3 inputs, there is no market data or correlations with market assumptions. Examples would include limited partnership interests, closely held stock, etc.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest.

**Payment of benefits** - Benefits are recorded when paid.

**Subsequent events** - Plan management has evaluated subsequent events through July 7, 2025, which is the date the financial statements of the Plan were available to be issued.

**(3) Income tax status**

The IRS issued an opinion letter dated June 30, 2020 stating that the Plan was designed in accordance with the applicable Internal Revenue Code ("IRC") requirements as of that date. The Plan administrator and the Company believe that the Plan is currently operated in compliance with the applicable requirements of the IRC and that the Plan was qualified and the related trust was tax exempt as of and for the year ended December 31, 2024.

### (5) Party-in-interest transactions

Certain Plan investments are managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal"), the Plan's trustee, as defined by the Plan. Principal provided the Plan with contract administration and investment management services, which qualify as party-in-interest transactions.

Total administrative fees and expenses paid by the Plan to parties-in-interest for the year ended December 31, 2024 totaled \$146,880 and related to investment management and record keeping services.

### (6) Information certified by the trustee

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments
- Notes receivable from participants
- Interest income on notes receivable from participants
- Interest and dividends on investments
- Net appreciation in fair value of investments
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.
