Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 - Description of Plan:

The following brief description of the Pioneer Farm Equipment Co. 401(k) Profit Sharing Plan is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

General

Pioneer Farm Equipment Co. 401(k) Profit Sharing Plan is a trustee, defined contribution plan established for the benefit of eligible employees of Pioneer Farm Equipment Co. (the Company). The Plan was originally effective January 1, 1995, and has been amended and restated to conform to new tax laws and provisions. Employee participation in the Plan is voluntary. Employees who have reached the age of 21 and are not covered by a collective bargaining agreement are eligible to participate in the Plan. Plan entry dates are January 1, April 1, July 1 or October 1 following their dates of hire.

Participants may elect to contribute a percentage of their before-tax compensation, as defined, not to exceed a certain dollar limit as set by law. The Company makes a matching contribution in an amount equal to 50 percent of the participant's contribution, not to exceed 2 percent of the participant's compensation, as defined. Plan income or loss is allocated to the participant's account based on the participant's account balance as specified in the Plan. The Plan also provides that the Company, at its discretion, may make additional profit-sharing contributions which, if made, will be allocated among all active participants based upon each participant's compensation for the year. During 2024 and 2023, the Company did not make an additional profit-sharing contribution.

Participant contributions and profit-sharing contributions made by the Company to the Plan and earnings thereon are fully vested at all times. Company matching contributions to the Plan and earnings thereon vest to the participants based upon their years of service as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 - 3	50%
4	60%
5	100%

Participants are 100 percent vested upon reaching age 65, upon death, in the event they are totally and permanently disabled or upon Plan termination, regardless of the participants' years of service. Forfeited non-vested Company matching contributions of terminated participants may be used to fund a portion of Company contributions but will, under certain circumstances, be restored to the participants who previously forfeited the contribution upon re-employment. During 2024 and 2023, \$5,170 and \$6,401 of the forfeited amounts were utilized by the Plan to reduce Company contributions, respectively. The amount available to fund future Company contributions included in Plan assets was \$5,548 and \$5,202 at December 31, 2024 and 2023, respectively.

Upon termination of employment or retirement, a participant may elect to receive benefit payments through any one of the several methods provided by the Plan. Under circumstances defined by the Internal Revenue Service (IRS), the Plan allows, subject to approval by the Company, the withdrawal of an employee's account due to an immediate and heavy financial need.

Net assets available in the amount of \$3,259,526 and \$1,950,071 have been allocated to the accounts of employees who have withdrawn from the Plan but have not yet been paid out at December 31, 2024 and 2023, respectively.

### Amendment and termination of Plan

The Company shall have the right to amend the Plan by resolution of the Employer's Board of Directors, provided that no amendment shall attempt to cause any of the assets of the Plan to be used for or diverted to purposes other than for the exclusive benefit of participants or their beneficiaries.

In the event the Employer elects to terminate the Plan or discontinue operation of its business, the entire interest of the participants shall vest 100% immediately and be non-forfeitable.

### Administrative expenses

The majority of administrative expenses relating to the Plan for the years ended December 31, 2024 and 2023, were paid by the Company.

### Reclassifications

Certain reclassifications have been made to the prior year financial statements in order for them to conform to the current year presentation.

### Subsequent events

Management has evaluated subsequent events through July 7, 2025, the date on which the financial statements were available to be issued.

### NOTE 2 - Summary of significant accounting policies:

#### Basis of accounting

The accounts of the Plan are maintained on the cash basis of accounting. For financial reporting purposes, however, the financial statements have been prepared on the accrual basis of accounting using information provided by the Trustee and present the net assets available for Plan benefits and changes in those net assets at current values. The difference between the current value and the cost of the investments is reflected in the statement of changes in net assets available for Plan benefits as appreciation (depreciation) in fair value of investments.

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Trustees to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### Fair value of financial instruments

Unless otherwise indicated, the fair value of all reported assets and liabilities that represent financial instruments (none of which are held for trading purposes) approximates the carrying value of such amounts.

#### Concentration of credit risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of investments, which are subject to market fluctuations.

#### Investments

All contributions to the Plan are invested by American Trust Company (the Trustee) in certain mutual funds or common collective trusts. Plan participants may allocate their account balances held by the Trustee among various mutual funds or common collective trusts.

#### Related party transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employer or employee association, or relatives of such person.

Certain Plan investments are shares in funds managed by the Plan's custodian which is a party-in-interest. At December 31, 2024 and 2023, the Plan had investments in related funds of \$6,972,443 and \$7,367,704, respectively. Fees paid indirectly by the Plan to the custodian and broker were \$46,927 and \$43,293 for the years ended December 31, 2024 and 2023, respectively.

Federal income tax status

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no significant uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The plan administrator believes it is no longer subject to income tax examinations for the years prior to December 31, 2021.

Information certified by the Plan's Trustee

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's Trustee has certified that the following data included in the accompanying financial statements is complete and accurate: (a) investments as shown in the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and (b) investment income (loss) as shown in the statement of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023. The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

NOTE 3 - Investments:

The Plan's investments are reported at fair value on a recurring basis in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses the appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Level 1 fair value measurements: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be activity traded.

The Fund's investment in the fully benefit-responsive guaranteed investment contract (GIC) with American Trust Company through Metropolitan Tower Life is measured at contract value.

NOTE 4 – Investment in fully benefit-responsive fund:

The Plan has entered into a fully benefit-responsive guaranteed investment contract (GIC) with American Trust Company through Metropolitan Tower Life. Traditional GICs represent deposits which guarantee a stated interest rate (Interest Crediting Rate) for the term of the GICs.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value as reported by the Plan by American Trust Company, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$363,714 and \$645,415, respectively, and is considered Level 3. The average yield and crediting interest rates was approximately 3.26% at December 31, 2023, the most recent audited financial statements. The crediting interest rate is based on a formula taking into consideration a number of factors.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
