**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Computer Marketing Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## 1. Description of Plan

The following brief description of the Computer Marketing Corporation (the “Company”) 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General.* The Plan is a defined contribution plan covering all qualified employees of the Company who have completed three months of service and are 21 years of age. An eligible employee may become a participant on the first day of each calendar quarter coinciding with or following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of ERISA. Plan Management is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to Plan Management.

*Contributions.* Each year, participants may contribute up to 75 percent of their annual compensation, as defined in the Plan. Contributions can be made on a pre-tax or after-tax (Roth) basis, through payroll deductions. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions to various investment options offered by the Plan.

The Company matches 100 percent of participant contribution to the Plan up to \$5,400 each year. Additional amounts may be contributed at the discretion of the Company’s board of directors. During the year ended December 31, 2024, the Company made matching contributions of \$468,741 and additional discretionary contributions of \$71,776.

Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

*Participant Accounts.* Each participant’s account is credited with the participant’s contribution and Company contributions, as well as allocations of the Company’s discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting.* Participants are immediately fully vested in their contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

## 1. Description of Plan (continued)

*Payments of Benefits.* Distributions and withdrawals generally are payable upon retirement, termination of service, death, or disability. A terminated participant may elect to receive either a lump sum distribution or installment payments. The designated beneficiary is entitled to a death benefit distribution equal to the participant's vested account balance.

*Forfeitures Accounts.* At December 31, 2024 and 2023, the Plan had forfeited non-vested account balances of \$1,285 and \$6,797, respectively. During 2024, forfeited non-vested funds totaling \$16,498 were used to offset company matching contributions.

## 2. Summary of Significant Accounting Policies

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

### *Subsequent events*

The Plan has evaluated subsequent events through June 13, 2025 the date the financial statements were available to be issued.

## 3. Information Certified by the Plan's Trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net depreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan.)

## 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash:* Valued at the account balance at year end.

*Mutual funds:* Valued at fair value based on quoted net asset value of shares held by the Plan at year end.

*Common/collective trusts:* Valued at carrying value based on the net asset value (NAV) of the observable market prices of the underlying assets within that account, less liabilities.

## 6. Investment Contract

The Fidelity Advisor Stable Value Portfolio, a common/collective trust, has entered into fully benefit-responsive investment contracts to provide preservation of principal and to provide a level of income over time that is consistent with the preservation of capital. The portfolio is valued daily and will seek to maintain a stable net asset value. The crediting rate of the contract will track current market yields on a trailing basis.

## 7. Party-in-Interest Transactions

Certain Plan investments are shares of funds managed by Fidelity Management Trust Company, the Plan trustee, and, therefore, these transactions qualify as party in interest transactions. Any purchases and sales of these funds are open market transactions at fair market value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party in interest transactions under ERISA.

Certain accounting and administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. In addition, the Company pays certain outside administrative expenses of the Plan.

## **8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

## **9. Tax Status**

The Plan uses a pre-approved plan document sponsored by Fidelity Management & Research Company, which received an advisory letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Department of Labor ("DOL"). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021.

## **10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.

## **11. Reconciliation of Financial Statements to Form 5500**

Form 5500 for the Plan year ended December 31, 2024 has been prepared on the cash basis of accounting and does not include all receivables due to the Plan as of December 31, 2024.
