Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Davis Selected Advisers, L.P. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets held at end of year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS**NOTE A. DESCRIPTION OF PLAN**

The following description of the Davis Selected Advisers, L.P. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

GENERAL

The Plan is a defined contribution plan, which was established on August 1, 1979, and amended and restated effective January 1, 1998, and most recently amended February 22, 2022, as a defined contribution plan for the benefit of eligible employees of Davis Selected Advisers, L.P.; Davis Distributors, LLC; and Davis Selected Advisers-NY, Inc. (collectively, the “Company”).

To be eligible to join the Plan, an employee must be at least 18 years of age; must have completed three months of service; and must not be a temporary employee, a non-resident alien, or a member of a union. Fidelity Management Trust Company serves as the Trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended, and the Internal Revenue Code (the “Code” or “IRC”).

CONTRIBUTIONS

Each year, participants may contribute up to 50% of their total compensation, subject to the limitations prescribed by the IRC. Contributions may be made on a pre-tax or after-tax basis. The Company contributes to the Plan on behalf of each participant an amount equal to 100% of the participant’s contributions up to 10% of the participant’s compensation, not to exceed \$10,000. The Company’s matching contributions, as well as employee contributions, are invested at the direction of each individual participant into various mutual funds offered by the Plan. Participants may change contribution rates at the beginning of each pay period and may change investments and transfer between funds daily. Contributions determined to be excessive in accordance with discrimination rules of the IRC are refunded annually.

INVESTMENT OPTIONS

The Plan provides for participant-directed investment elections among different types of money market funds and mutual funds. Participants may change their investment elections on any business day and as often as desired by communicating directly with the Plan’s third-party administrator.

PARTICIPANT ACCOUNTS

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, and Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

VESTING

The balance in each participant’s account is immediately 100% vested and non-forfeitable.

NOTES RECEIVABLE FROM PARTICIPANTS

The Plan is permitted to make loans to participants. Participants may borrow the lesser of \$50,000 or 50% of their account balance from their fund accounts, subject to certain restrictions. The loans are secured by the vested balance in the participant’s account and bear interest at the prime rate at origination, plus 1%. Note receivable terms range from one to five years, or up to 10 years for loans to purchase a primary residence. Principal and interest are paid ratably through payroll deductions. A loan is considered in default if amounts due remain outstanding at the end of the quarter following the quarter the amounts became due. Loans predating amended Plan provisions may maintain the original loan terms that were in place at origination.

PAYMENT OF BENEFITS

Upon termination of employment, death, disability, or attainment of normal retirement age, a participant or his or her beneficiary may elect to receive a lump-sum or partial cash distribution or a rollover of the account balance to another eligible retirement plan.

The Plan also provides for withdrawals during employment for participants over age 59½ or hardship withdrawals for participants with specific heavy financial needs as defined in the Plan. A hardship withdrawal may come from a participant's vested account balance and must be for an amount greater than \$500. The withdrawal may not be for an amount greater than that which is necessary to satisfy the immediate financial need.

Withdrawals are generally subject to 20% federal income tax withholding and any applicable state income tax withholding, unless the participant elects not to have taxes withheld. Additionally, withdrawal prior to the age 59½ may be subject to a 10% early withdrawal penalty tax.

ADMINISTRATIVE EXPENSES AND FEE REBATES

Certain administrative expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense in the accompanying statement of changes in net assets available for benefits. The Plan participates in a participant revenue credit program whereby the Plan receives a return of certain record-keeping revenue received by the Trustee. In the event that the Trustee's record-keeping revenue received in connection with plan services exceeds agreed upon compensation levels, such excess revenue is deposited to a suspense account and allocated to accounts of eligible participants. The Plan reports administrative expenses net of the record-keeping fee rebates on the statement of changes in net assets available for benefits. For the year ended December 31, 2024, net fee rebates of \$67,159 were reimbursed to the Plan.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The significant accounting policies followed by the Plan in the preparation of its financial statements are as follows:

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Receivables and liabilities, other than for benefits, are accrued in accordance with the American Institute of Certified Public Accountants Audit and Accounting Guide, *Audits of Employee Benefit Plans*.

NET APPRECIATION (DEPRECIATION) IN FAIR VALUE OF INVESTMENTS

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported assets, revenues, and expenses and disclosure of any contingent assets at the date of the financial statements. Actual results could differ from estimates.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance. Loan fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded upon the occurrence of a distributable event.

INVESTMENT VALUATION AND INCOME RECOGNITION

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Accounting principles generally accepted in the United States of America establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liabilities;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan's policy is to recognize significant transfers between levels at the end of the reporting period.

BENEFITS

Benefit payments to participants are recorded upon distribution. There were no participants who had elected to withdraw from the Plan but had not yet been paid as of December 31, 2024.

INCOME TAX STATUS

The Plan participates in a defined contribution prototype plan and trust offered by Fidelity Management Trust Company (the "Trustee"), which is intended to meet the requirements of the Internal Revenue Code as a qualified Prototype Retirement Plan and Trust/Custodial Account. The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since the application of the determination letter was filed. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan Sponsor believes the Plan has maintained its tax-exempt status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP clarifies the accounting for uncertainty in income taxes by creating a framework to recognize, measure, present, and disclose in financial statements uncertain tax positions that have been taken or expect to be taken in a tax return. The Plan administrator and Company management believe that there are no uncertain tax positions for which it is reasonably possible that reported total amounts could significantly differ from amounts that may be determined upon examination by taxing authorities. Additionally, the Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status. In general, the Plan's tax returns remain subject to examination by taxing authorities for three years, unless specific conditions are met, from the filing date. Accordingly, the Form 5500 for the period ending December 31, 2020 is no longer subject to examination.

NOTE C. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no significant transfers between levels or changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Money market accounts are considered cash equivalents and are valued at net asset value (“NAV”) with underlying assets primarily valued at amortized cost.

Mutual funds: Valued at the daily closing price, as reported by the fund, of shares held by the Plan at year end. Mutual funds held by the Plan are open-end, actively traded mutual funds registered with the Securities and Exchange Commission and are required to publish their daily NAV and transact at that price.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s mutual funds and money market funds are all Level 1 investments within the fair value hierarchy as of December 31, 2024 and 2023.

NOTE D. PLAN TERMINATION

Although it has not expressed any interest to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE E. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and money market funds managed by the Company and the Trustee. Certain Plan expenses are paid by the Company. The Company is the Plan administrator and Fidelity Management Trust Company is the trustee and record keeper as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. Of the mutual and money market funds in the Plan’s assets, \$56,785,871 is managed by the Company, \$25,878,285 is managed by Fidelity, and \$4,826,004 is managed by others. Fees paid by the Plan for investment management services, 12b-1 fees, and other expenses were included as a reduction of the return earned on each fund. For its own mutual and money market funds, the Company charges total annual expenses of 0.35% to 0.75% of each fund’s assets.

NOTE F. UNAUDITED INFORMATION CERTIFIED BY THE TRUSTEE

The following unaudited information in the Plan’s financial statements and supplemental schedule was certified to be complete and accurate by the Plan’s trustee, Fidelity Management Trust Company, within the meaning of 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA:

- All amounts reported as money market funds, mutual funds, and notes receivable from participants in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- All amounts reported as net appreciation (depreciation) in fair value of mutual funds and dividends and interest in the statement of changes in net assets available for benefits as of December 31, 2024.
- All amounts reported in the supplemental schedule of assets held at end of year.

NOTE G. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

NOTE H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account and the amounts reported in the financial statements.

Financial instruments that potentially subject the Plan to concentrations of credit risk consist primarily of money market funds. The total loss that could occur if the accounts became uncollectible is the stated fair value of the financial instruments reported in the accompanying statements of net assets available for benefits.

NOTE I. SUBSEQUENT EVENTS

GAAP requires the disclosure of the date through which subsequent events were evaluated when determining whether adjustment to or disclosure in the financial statements is required. A subsequent event is an event or transaction that occurs after the balance sheet date but before the financial statements are issued. The Plan administrator has evaluated subsequent events through July 8, 2025, which represents the date the accompanying financial statements were available to be issued.
