Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AMSTED Industries Incorporated Employees' Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2024 and 2023, and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 2, investments amounting to \$4,398,982,337 and \$3,713,811,480 as of September 30, 2024 and 2023, respectively, have been reported at estimated fair values as determined by independent appraisals which have been reviewed and approved by Plan management. These amounts represent approximately 99% of net assets available for benefits as of September 30, 2024 and 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – GENERAL DESCRIPTION OF THE PLAN

The following description of the AMSTED Industries Incorporated Employees' Stock Ownership Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a non-contributory defined contribution plan covering all United States-based employees of AMSTED Industries Incorporated and its affiliates, together referred to as the "Company," except those who are members of a collective bargaining unit. All eligible employees immediately become participants in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on October 1, 1984.

Contributions: The Company's contributions to the Plan are discretionary in any plan year. The discretionary contribution to the Plan for the year ended September 30, 2024 was equal to 10% of total eligible compensation. The Company's contribution was reduced by \$3,002,557 of forfeitures from terminated participants' nonvested accounts during the year ended September 30, 2024. Contributions for the year ended September 30, 2024 were made in the form of Company stock.

Plan Termination: Although there is no intent to do so, the Plan can be terminated by the sponsor at any time. In the event the Plan terminates, all accounts shall become 100% vested and the accrued benefits in an employee's individual account will be distributed in accordance with the terms of the plan document. Also, upon termination of the Plan, the Board of Directors shall direct the trustees to pay all liabilities and expenses of the trust fund.

Participant Accounts: Under the terms of the Plan, separate participant accounts are maintained for the purpose of allocating employer contributions, dividends, gains or losses, interest income, and forfeitures. Company contributions and forfeitures are allocated to the participants' accounts based upon the ratio of the participants' eligible compensation to the total eligible compensation. Dividends and gains or losses for the plan year are allocated to the participants' accounts based on respective account balances as of the end of the plan year. All shares held by the Plan are allocated to participant accounts.

Forfeitures: The non-vested portion of terminated participants accounts plus earnings thereon are forfeited and can be used by the Plan to reduce the amount of future employer contributions to the Plan or can be reallocated to participants. As of September 30, 2024 and 2023, shares of Company stock held in the forfeiture account were 1,282 and 1,150, respectively.

Vesting: The employer discretionary portion of the participant's accounts vest at the rate of 20% per year of service, beginning with the date of hire. Participants are 100% vested after five years of service or upon death, disability, or retirement.

Benefit Payments: Benefits are payable to participants upon termination of employment either through retirement, termination, disability, or death. Participants with account balances greater than \$5,000 who separate service and request a distribution will receive their vested balance in five equal installments in a frequency of no less than once per year. A lump-sum payment in cash can be made for a distribution less than \$5,000. If a participant's vested benefit is less than \$5,000 and they fail to make an election for the form of their distribution, the Plan Administrator will direct the benefit to be paid directly to an individual retirement account established for the participants. Effective January 1, 2024, the Plan was amended to increase the account balance threshold for mandatory cashouts from \$5,000 to \$7,000.

Put Options: The employer stock that is held by the Plan and its participants is not readily tradable on an established market. As the Company is an S corporation, the administrator directs the Trustee to distribute a participant's accounts entirely in cash without granting the participant the right to demand a distribution in shares of stock. The foregoing cash distribution can be accomplished by a distribution of Company stock subject to a requirement that the Company immediately repurchase such shares.

Voting Rights: Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee has the right under the applicable law to vote the shares contrary to the direction of the participants if required by applicable fiduciary principles.

Diversification: Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants in the Plan who are at least age 55 may elect to diversify a portion of their account, up to 25%. Any time after the participant attains age 60, they may diversify up to 50% of the number of shares allocated to his or her account, less any shares previously diversified. Diversification is accomplished by a distribution of shares from the trust, which must be immediately sold to the Company. Participants may keep the cash proceeds or immediately roll them over to the AMSTED Industries Employees' Capital Accumulation Plan (CAP Plan) or an individual retirement account. The Company may also grant participants the right to elect a supplemental diversification up to 5% each year. For the year ended September 30, 2024, total transfers of \$12,906,942 were directed to the CAP Plan and \$104,038,310 were directed to IRAs by individual participants.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments: The Plan is required to invest primarily in the Company's stock, which is reported at an estimated fair value determined by independent appraisal. The Plan owns 100% of the Company's outstanding stock.

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to determine the fair values of investments apply to investments held directly by the Plan.

Company common stock: Investments in Redeemable Class A Company common stock are valued by independent appraisal as of the last day of the Plan's year. The appraisal was performed using the market approach based upon valuation multiples of guideline public companies (Level 3 inputs). The guideline public companies method identifies pricing multiples of public companies deemed to be comparable to the Company. Under the market approach, a discount for a lack of marketability is applied since the Company's stock is not readily traded on an organized exchange. The historical and projected financial information of the Company used by the appraiser is provided to the appraiser by the Senior Manager of Accounting and Financial Reporting, who reports to the Controller, in addition to all executive level employees. For the year ended September 30, 2024, the Plan's investment in the Company common stock did not have any purchases or issuances activity since all transactions done are in-kind.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Net Appreciation/(Depreciation) in the Fair Value of Investments: The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation/(depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments based on the estimated fair values as determined quarterly by the independent appraiser.

Payment of Benefits: Benefit payments and diversification transfers are recorded when paid.

Use of Estimates: The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. The Plan's value of its investment in the Company's Redeemable Class A common stock is an estimate that is particularly subject to change in the near term.

Risks and Uncertainties: The Plan invests in the Company's stock. Due to the level of uncertainty related to changes in the value of this stock and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in fair value will occur in the near term and would materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits. As of September 30, 2024 and 2023, approximately 99% of the Plan's net assets were invested in the Company's Redeemable Class A common stock.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation (depreciation) in fair value of investments for the year ended September 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by GreatBanc Trust Company (trustee of the Plan).

NOTE 4 – TAX STATUS OF THE PLAN

The Internal Revenue Service has determined and informed the Company by a letter dated November 20, 2017, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended and restated since applying for the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Professional fees for the audit of the Plan and all fees for the administration of the Plan were paid by the Company and are excluded from these financial statements.
