INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
South Carolina Bankers Employee Benefit Trust

Opinion

We have audited the accompanying consolidated financial statements of South Carolina Bankers Employee Benefit Trust and subsidiary (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the consolidated statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related consolidated statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the consolidated financial statements.

In our opinion, the consolidated financial statements referred to above present fairly, in all material respects, the consolidated net assets available for benefits and benefit obligations of the Plan as of December 31, 2024 and 2023, and the consolidated changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Note 1. Description of Plan:

The following description of South Carolina Bankers Employee Benefit Trust (“SCBEBT”) provides only general information about the plan’s provisions. SCBEBT, LLC was established by SCBEBT to function as an agency which is licensed by the South Carolina Department of Insurance and to engage in any other lawful businesses and activities. SCBEBT, LLC is wholly-owned by SCBEBT. The Plan refers to SCBEBT and its consolidated subsidiary company.

Participants should refer to the plan agreement for a complete description of the Plan’s provisions, copies of which may be obtained from the Plan sponsor.

General – The Plan provides health and other benefits covering substantially all employees of the participating employers, who are banks located in the state of South Carolina that are members of either South Carolina Bankers Association (“SCBA”) or Independent Banks of South Carolina (“IBSC”).

Certain Plan assets are held in a voluntary employees’ beneficiary association (“VEBA”) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Benefits – The Plan provides health benefits (medical, dental, vision, and prescription drugs), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits to full-time participants and to their beneficiaries and covered dependents. A full-time participant is an employee who works at least 30 hours per week and at least 48 weeks per year. The Plan also covers retirees who are at least 55 years of age but less than 65 years of age, with a minimum of 10 years continuous employment with their bank, and who are eligible under their bank’s retirement plan to take early retirement. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (“COBRA”).

Insured Benefits – The Plan fully insures the dental, vision, life insurance (basic, supplemental, and dependent), short and long-term disability, and accidental death and dismemberment benefits. The Plan purchases annual insurance contracts for these insured benefits. Premiums for these insured benefits are paid from the assets of the VEBA trust.

Stop Loss Coverage – The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits on individual participant claims over \$300,000.

Self-insured Benefits – All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (“ASO”) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (“PBM”) who periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.

Contributions – Participating employers make monthly contributions to the Plan based on rates approved by the trustees of the Plan.

Participating employers who exit the Plan are required to pay for actual claims incurred during the 6-month period immediately following their exit. Run-out premiums are calculated based on 2.5 times the average premiums paid for the preceding 12 months. The exiting employer can either pay the run-out premium in a lump sum or in 6 equal installments over the first 180 days after withdrawal from the Plan. The run-out premiums are used to pay claims received after the employer leaves the Plan. Prior to September 1, 2024, the former employer received a refund to the extent that run-out premiums exceeded claims paid at the end of the 6-month run-out period, and was not liable if the claims paid exceeded the run-out premium paid. Effective September 1, 2024, the Plan ceased refunds of any such differences

Note 2. Summary of Accounting Policies:

Basis of Accounting and Use of Estimates – The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Principles of Consolidation – The consolidated financial statements include the accounts of SCBEBT and its wholly-owned subsidiary after elimination of all significant intercompany accounts and transactions.

Payment of Benefits – Premiums paid by the VEBA trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when reimbursed by the Plan to the third-party claims processor.

Stop Loss – Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop loss credits totaling \$253,161 and \$457,356 in 2024 and 2023, respectively, have been netted with claims paid in the accompanying statements of changes in net assets available for benefits.

Rebates – Rebates due from the Plan’s PBM are recorded when earned. Rebates due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$1,359,698 and \$1,167,375 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s board of trustees (“Trustees”) determines the Plan’s valuation policies and procedures. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Claims Incurred but not Reported – Plan obligations at December 31 for health claims incurred by active participants but not reported at that date are estimated by the Plan administrator on the basis of past loss experience using claims data provided by the Plan’s third-party claims administrator. These amounts are reported in the accompanying statements of the Plan’s benefit obligations and are paid by the Plan only if claims are submitted and approved for payment.

Administrative Expenses – The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, professional fees, and investment fees. These expenses are separately reported on the statements of changes in net assets available for benefits.

Note 3. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash – Valued at cost, which approximates fair value, due to its short-term maturity.

Certificates of deposit – Valued at cost plus accrued interest.

U.S. Government securities – Valued at the closing price reported in the active market in which the security is traded, if available. If such information is not available, securities are valued based on yields currently available on comparable securities for issuers with similar credit ratings.

Note 4. Line of Credit:

The Plan has a \$2,000,000 line of credit with The Citizens Bank that matures October 22, 2025, and bears interest at 7.50%. There was no balance outstanding on the line of credit at December 31, 2024 and 2023.

Note 5. Tax Status:

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (“IRS”) dated December 5, 1984, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (“IRC”). However, as a result of the Plan’s funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in December 31, 2024 and 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator and the Plan’s tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the related trust is tax-exempt.

The plan administrator has determined that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the Plan’s tax returns remain open for three years to federal income tax examination.

Note 6. Termination of the Plan:

Although they have not expressed any intention to do so, the Trustees and the participating employers have the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue their contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Trustees and the participating employers or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 7. Related Party and Party-in-Interest Transactions:

The Plan maintains bank accounts and certificates of deposit with The Citizens Bank, Carolina Bank and Trust Company, and Pickens Savings and Loan Association. All of these institutions are participating employers in the Plan. The Plan also maintains a line of credit with The Citizens Bank, as further described in Note 4. The Trustees and the Plan's executive director are currently participants in the Plan.

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

Note 8. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The value of benefit obligations is reported based on certain assumptions pertaining to past loss experience and employee demographics, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
