### NOTES TO FINANCIAL STATEMENTS

For the Years Ended December 31, 2024 and 2023

#### 1. Description of Plan

The following description of the APHL 401(k) Pension Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution plan established October 1, 2006, and as restated January 1, 2022. The Plan covers all employees, excluding non-resident aliens, employees classified as interns, employees of foreign branches or subsidiaries and "special contract" employees which are defined as employees hired for a term not to exceed 30 months, of Association of Public Health Laboratories (the Organization or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The investment committee is responsible for oversight of the Plan. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to governance of the Organization.

In December 2022, Securing a Strong Retirement Act (Secure 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act Secure Act 2.0. Most of the provisions will become effective in 2024 and forward, therefore there is no current impact to the Plan. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

##### *Eligibility*

Employees are eligible to participate in the Plan on the first day of the calendar month coincident with or next following the date he or she attains age 18 and completes 250 hours of service in a three-month period, or if later, when 1,000 hours is reached in a 12-month period, beginning at the employee's date of hire or the first day of the Plan year.

##### *Contributions*

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

## APHL 401(K) PENSION PLAN

### NOTES TO FINANCIAL STATEMENTS For the Years Ended December 31, 2024 and 2023

#### 1. Description of Plan (Continued)

##### *Contributions (continued)*

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by one percent on the anniversary of their enrollment date until their deferral rate reaches 3%.

The Organization will make qualified nonelective contributions to the Plan in an amount not less than 3% of participant's eligible compensation on behalf of each employee who is eligible to make elective deferrals during the year. For the years ended December 31, 2024 and 2023, the employer qualified nonelective contribution was 3% of each eligible participant's compensation.

Additional profit sharing amounts may be contributed at the option of the Board of Directors. For the years ended December 31, 2024 and 2023, the Organization approved a profit sharing contribution of 7% of eligible compensation for participants.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

##### *Participant accounts*

Each participant's account is credited with the participant's contributions, allocations of the Employer's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### *Vesting*

Participants are fully vested in their elective deferral contributions, employee rollover contributions, and employer qualified nonelective contributions, plus actual earnings thereon. Vesting in the employer profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. Participants are vested at 50% after one year, 75% after two years, and 100% after three years of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or disability.

## APHL 401(K) PENSION PLAN

### NOTES TO FINANCIAL STATEMENTS For the Years Ended December 31, 2024 and 2023

#### 1. Description of Plan (Continued)

##### *Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined daily, is set at 2 percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range from one to five years or greater for the purchase of a primary residence.

##### *Payment of benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

##### *Forfeited accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,616 and \$25,878, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, plan administrative expenses were reduced by \$39,494, from forfeited nonvested accounts, in accordance with plan provisions. During 2023, no forfeitures were used.

#### 2. Summary of Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

##### *Investment Valuation and Income Recognition (continued)*

Certain Plan assets are invested in stable value funds and common/collective trusts (CCTs). Under this investment concept the Custodian accounts for the Plan's share of the total portfolio on a unit basis and reports the stable value funds and common/collective trusts at net asset value (NAV).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through June 27, 2025, the date the financial statements were issued.

#### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- *Stable Value Funds and Common/Collective Trusts* - These accounts are valued on the basis of the relative interest of each participating investor in the fair value of the underlying assets of each of the respective stable value fund and common collective trust. The underlying assets are valued based on the NAV as provided by the investment account manager.

#### **4. Information Certified by Custodian**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Custodians of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statements of Changes in Net Assets Available for Benefits for the years then ended.

#### **5. Related-Party and Party In Interest Transactions**

Certain Plan investments are managed by the Custodians, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

The Plan made direct payments to the third party administrators of \$16,588 and \$15,015, which were not covered by revenue sharing, for the years ended December 31, 2024 and 2023, respectively. Additionally, the Plan made direct payments to the third party administrators of \$69,657 and \$52,302, which were covered by revenue sharing, for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

#### **7. Tax Status**

The Plan adopted a prototype plan offered by Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

The prototype plan received an IRS Determination Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Determination Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
