## Independent Auditors' Report

**1. Description of Plan**

The following brief description of the Continental Grain Company Salaried Employees' Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and is administered by the Administrative Committee of the Employee Benefit Plans of Continental Grain Company (the "Company" or "Employer"). All full-time salaried employees of the Company are eligible to participate in the Plan.

***Contributions***

Participation is automatic beginning with the first payroll period following 60 days of employment at which time participants will also be eligible for Employer matching contributions. For employees hired before January 1, 2024, default enrollments include an employee contribution of 3% of pay on a pre-tax basis into the appropriate "Target Retirement Fund" based on an anticipated retirement at age 65. Such contributions will be automatically increased by 1% on July 1<sup>st</sup> of the following year until reaching 10% of the participants' eligible compensation. Effective January 1, 2024, the Plan was amended to change the default enrollment employee contribution from 3% to 4% of pay on a pre-tax basis. In addition, as a result of the amendment, employees who were auto enrolled in the Plan before January 1, 2024, will have a one-time increase in their deferral rate of 2% on July 1, 2024. Employees may modify their elections to have payroll deductions of up to 50% of salary plus bonus ("compensation") not to exceed the Internal Revenue Service ("IRS") limit on elective deferrals. Employee contributions may be pre-tax and/or Roth after-tax contributions at the election of the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from another qualified plan.

The Company will contribute \$1.00 for each dollar the participant contributes up to 4% of compensation.

***Investment Options***

Plan participants may direct their investments in any of the various investment options offered by the Plan.

***Vesting***

Participants are fully vested in their contributions and earnings thereon. Vesting in the Company's contributions is at a rate of 50% for each full year of vesting service in the Plan. A participant becomes fully vested in the Company's contributions and the earnings thereon after completing two years of vesting service as defined in the Plan.

A participant also becomes fully vested in the Company's contributions upon involuntary termination without cause, total and permanent disability, and retirement at or after age 65, death, or termination of the Plan, regardless of years of vesting service.

Effective January 1, 2023, the Plan was amended as follows: a participant will have a 100% nonforfeitable interest in their Company contributions on the earliest to occur of: (i) his attainment of age 65; (ii) solely for a participant first hired before January 1, 2023, including a participant rehired after December 31, 2022, their termination of employment for any reason other than voluntary termination by the participant or involuntary termination with cause; (iii) the second anniversary of the date on which the participant incurs a disability, provided that the participant is still disabled on such second anniversary; and (iv) their death while employed by the Company.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and withdrawals, as applicable, the Company contributions, and allocations of Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Benefit Payments***

Upon termination of service, participants may elect for payment to be made in a lump sum or installments. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, may not exceed the amount of the participant's immediate and financial need. A participant may also withdraw all or any portion of their vested account balance after attaining age 59 ½. If a participant is on active military duty for more than 30 days, they may withdraw all or a portion of their elective deferral accounts. If a participant is disabled and qualifies under the Continental Grain Company Long Term Disability Benefit Plan, they may elect to withdraw all or a portion of their vested account balance on the second anniversary of the commencement of disability payments under such plan.

***Notes Receivable from Participants***

Participants may borrow from their account balance a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Loan terms range from one to five years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the plan administrator may permit a longer repayment period. Principal and interest is paid ratably through semi-monthly payroll deductions.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,716 and \$9,232. These accounts will be used to pay the Plan's administrative expenses or to reduce future Employer contributions. During 2024, no forfeitures were used to reduce Employer contributions or were used to pay Plan expenses.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than unadjusted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustees of the common/collective trusts, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission and are deemed to be actively traded. These funds are required to publish their daily NAV and to transact at that price.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are allocated to the participants' accounts, recorded as administrative expenses, and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payments of Benefits***

Benefits are recorded when paid.

***Expenses***

All fees and expenses of the Plan are paid by the Plan. These include quarterly administrative fees charged by the trustee and legal expenses of the Plan. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

In connection with the preparation of the financial statements, the Plan evaluated subsequent events from December 31, 2024 through July 7, 2025, which was the date the financial statements were available for issuance, and concluded that no additional disclosures were required.

**5. Investment in Common/Collective Trusts**

***Vanguard Retirement Savings Trust III***

The Vanguard Retirement Savings Trust III (the "Trust") is a common/collective trust that provides for the collective investment of assets of tax-exempt retirement plans. The Trust invests solely in the Vanguard Retirement Savings Master Trust ("VRS Master Trust"). The underlying investments of VRS Master Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond funds.

The Trust intends to maintain a constant NAV of \$1 per share. Distributions of net investment income to unitholders are declared daily and paid on the first business day of the following month.

The trustee does not charge any fees to the Trust; instead, each unitholder trust and qualified plan is charged its own trustee fee. Withdrawals may be initiated by the unitholder trusts or qualified plans for the primary purposes of funding an authorized distribution, withdrawal, or loan disbursement by a participating pension or profit-sharing plan to an employee or beneficiary covered there under, or for the purpose of the participating plan making an employee-directed transfer to another investment election of the employee's interest in the plan. Certain plan-directed withdrawals may be subject to market value adjustments calculated in accordance with the provisions of the investment contracts. As of December 31, 2024, the occurrence of an event outside the normal operation of the Trust that would cause an adjustment is not considered to be probable.

The Trust represents approximately 10% and 13% of the Plan's net assets available for benefits at December 31, 2024 and 2023.

***flexPATH Single Box Large Cap Growth Fund III***

During 2024, the Plan's investments included the flexPATH Single Box Large Cap Growth Fund III (the "Fund"), which is a collective investment trust. The purpose of the Fund is to allow collective investments by plan sponsors of retirement plans which qualify for exemption from federal income taxation pursuant to Section 501(a) of the Internal Revenue Code ("IRC"). Great Gray Trust Company, LLC is the trustee of the Fund.

Units of the Fund are valued each day on which the New York Stock Exchange ("NYSE") is open for trading in accordance with the valuation procedures established by the trustee. The NAV per unit is calculated as of the close of trading on the NYSE (generally, 4:00 p.m. U.S. Eastern time). The NAV per unit is computed by dividing the total fair value of the assets of each Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in each Fund and included in the determination of unit values.

The Fund sells new units and repurchases outstanding units on a daily basis. Unit purchases and redemptions are transacted at the NAV per fee class of the Fund determined as of the close of business each day.

At December 31, 2024 and 2023, the Trust and the Fund have no unfunded commitments.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

**7. Party-in-Interest Transactions**

Certain Plan investments are managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

**8. Income Tax Status**

The IRS has determined and informed the Plan by a letter dated December 29, 2016, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Plan has been amended since receiving the determination letter, however the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
