INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
SREB Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the SREB Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued. Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

1. DESCRIPTION OF THE PLAN

The following description of the SREB Retirement Plan (the Plan) provides only general information. Participating members (participants) should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is sponsored by the Board of Control for Southern Regional Education (Sponsor or the Board).

General

The Plan is a defined contribution plan available to eligible employees who have attained age 21. Enrollment is available to eligible employees on their hire date for elective deferrals and the month after completion of 90 days of service for mandatory deferrals and employer contributions. Ineligible employees consist of temporary or part-time workers, students who work less than 1,000 hours per year and independent contractors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Mandatory employee deferrals of 4% of compensation are made on a pre-tax basis by the participants. Eligible employees are also allowed to make voluntary contributions to the Plan on a pre-tax basis in an amount not to exceed certain Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan Sponsor contributes 9.5% of eligible compensation each month.

Participants may direct the investment of their contributions and the Board's contributions into various investment contracts, annuity options and mutual funds offered by the Plan. Participants may also contribute amounts representing distributions from other qualified benefit plans.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related Sponsor contributions, as well as the participant's share of the Plan's income (loss). Allocations of income (loss) are based on the proportion that each participant's account balance has to the total of the participants' account balances.

Vesting

Participants are immediately vested in all contributions.

Notes Receivable from Participants

Notes receivable are available upon approval of application for up to 50% of the participant's accumulated employee deferral (mandatory and elective) and rollover balance or a maximum of \$50,000 and a minimum of \$1,000. Notes bear a reasonable rate of interest as provided in the Plan document and are repaid directly through automatic draft from the employee's checking account over periods ranging up to 60 months unless the loan is used to purchase a primary residence which requires repayment within ten years.

Payment of Benefits

Upon termination of service due to death, disability, retirement or separation from service, a participant or his/her beneficiary may elect to receive a single lump-sum payment, installments over a period of time not to exceed assumed life expectancy of the participant or their beneficiary, an annuity contract or ad-hoc distributions. Unless the participant elects an alternative form of payment, the participant will receive a life annuity or joint and survivor annuity depending on their marital status. Terminated participants with a balance less than \$5,000 will receive a lump-sum payout.

The Plan provides for in-service and hardship withdrawals under conditions that are specified in the Plan document.

Revenue Credit Account

The Plan holds a revenue credit account (Revenue Credit Account) which is credited by Teachers Insurance and Annuity Association of America (TIAA) with the return of certain excess revenue generated by certain investments. The Revenue Credit Account may be used to pay reasonable Plan expenses or be allocated to participants. As of December 31, 2024 and 2023, the Plan had \$12,729 and \$1,353 in the Revenue Credit Account, respectively; these funds were held in the College Retirement Equities Fund (CREF) Money Market fund. The Plan Sponsor paid expenses of \$12,113 out of the Revenue Credit Account during the year ended December 31, 2024.

Forfeitures

All participants of the Plan are 100% vested in contributed funds as soon as they are eligible and enrolled in the Plan. Consequently, there are no forfeited funds and the forfeiture account did not have a balance at December 31, 2024 or 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and insurance

companies. See Note 3 for discussion of fair value measurements and Note 4 for discussion of contract value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate a permitted transaction under the terms of the Plan. Certain TIAA Traditional Annuity contract types including the Group Supplemental Retirement Annuities (GSRA) and the TIAA Stable Value Fund are considered fully benefit-responsive.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Distributions to participants are recorded when payment is made.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor or directly through a revenue credit account arrangement with TIAA. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Reclassifications

Certain reclassifications have been made to the 2024 financial statements presentation to correspond to the current year's format.

Subsequent Events

The Sponsor has evaluated events and transactions that occurred between December 31, 2024 and June 24, 2025, which is the date that the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under the Subsequent Events topic of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 855, *Subsequent Events*.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

Mutual funds: These investments are valued by obtaining quoted prices on nationally recognized securities exchanges.

Fixed annuity contracts: As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs. The fair value is determined based on discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. See also Note 4 for discussion of the TIAA Traditional Annuity.

Variable annuity accounts (registered investment companies held as variable annuities): These investments are valued based on each account's daily net asset value (NAV) of the underlying investments, which is considered by Plan management to be the best approximation of fair

value. The accounts are held in a TIAA separate account. Data for NAVs are distributed to Plan administrators and client investors on TIAA's website and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of the individual underlying holdings. Underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts.

Real estate account (the Account): A separate account of TIAA is valued based on the fund's daily NAV, which is considered by Plan management to be the best approximation of fair value. The unit value of the fund is calculated daily and available to Plan administrators and client investors on TIAA's website. The Account is also a variable annuity. Underlying holdings are primarily valued using independent appraisals or independent pricing sources. Although the underlying assets of the Account cannot be quickly sold and converted to liquid assets, the TIAA general account provides the fund with a liquidity guarantee whereby TIAA ensures that the fund has monies available to meet participant redemption, transfer or cash withdrawal requests. There are no unfunded commitments from participants in the Plan who invest in the Account.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. TIAA TRADITIONAL ANNUITY AND STABLE VALUE CONTRACT

The TIAA Traditional Annuity and the TIAA Stable Value Contract are guaranteed fixed annuity contracts available as investment options to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (RA) and Group Retirement Annuities (GRA), and GSRAs. The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement. The RA and GRA are non-benefit responsive investment contracts and are reported at fair value. See Note 3 for discussion of fair value measurements.

As described in Note 2, because the contracts are fully benefit-responsive contracts, contract value is the relevant attribute for that portion of the net assets available for benefits attributable to the investment contracts. Contract value, as reported to the Plan by TIAA, represents contributions made under the contracts, plus earnings less participant withdrawals and administrative expenses.

When participants choose to allocate a portion of their retirement savings to the Traditional Annuity during the accumulation phase of the contract, their contributions purchase a guaranteed amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal plus a specified minimum rate of interest is guaranteed by TIAA's claims-paying ability. The Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

TIAA Stable Value is structured as a separate account of TIAA. All premiums applied to the contract are allocated to the separate account. If the separate account assets are insufficient to meet the guarantees in the accumulation phase, claims are guaranteed by TIAA's claims-paying ability. The contributions to the TIAA Stable Value receive a minimum guaranteed interest rate always between 1% and 3%. The minimum guaranteed rate is subject to change every six months.

5. CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and the ERISA required supplemental schedule, including investments as of December 31,

2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA, CREF and TIAA, FSB, the custodians of the Plan.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by TIAA and CREF. TIAA and CREF are the insurance companies, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to insurance companies for administrative expenses and Plan advisors amounted to \$44,663 for the year ended December 31, 2024. During 2024, fees paid from the Revenue Credit Account of \$12,113 were paid to Plan advisors. The Sponsor pays directly any other fees related to the Plan's operations.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Board reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

8. TAX STATUS

The Sponsor has adopted a pre-approved plan document that has received a prep-approved plan document that has received an opinion letter from the Internal Revenue Service dated August 7, 2017, stating the form of the pre-approved plan document was in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
