Opinion

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of CMTA - Glass, Molders, Pottery, Plastics and Allied Workers (Local 164B) Welfare Plan (the "Plan"), are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for the Plan's investment classes are presented below.

Certificates of Deposit: Certificates of deposit are carried at fair value, which is determined based on inputs that may include interest-rate yield curves, which are similar to other certificates of deposit and fixed-income securities in terms of maturity and interest rates (Level 2).

Money Market Fund: The fair value of the money market fund is based on amortized cost, which approximates fair value. The fund seeks to maintain a net asset value of \$1.00 (Level 2).

Valuation Methods, Consistency - The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Contributions Receivable

Employer and employee contributions due but not paid at year-end are recorded as employer and employee contributions receivable. Contributions due as a result of payroll audits have been recorded net of an allowance equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received, with the exception of contributions due from one delinquent employer totaling \$107,507, which are recorded as a receivable as of September 30, 2024 and included in the total contributions receivable on the statements of net assets available for benefits. The amount due from the delinquent employer is recorded as a receivable as the Plan has a deed of trust in the real property of the employer for delinquent contributions due to the Plan. Management has evaluated the amount due and considers the amount fully collectible.

Benefit Obligations

The Plan's financial statements include obligations for the cost of benefits associated with participant eligibility earned as a result of work performed by participants through September 30 and paid for by the Plan subsequent to that date. Accumulated eligibility credits for insurance premiums are based on actual premiums paid to provide participants with October coverage based on work performed by participants in September. No benefits are provided to retirees.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in certificates of deposit and a money market mutual fund. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and of changes in net assets available for benefits.

Accounting Pronouncements Currently Adopted

In June 2016, the FASB issued an Accounting Standards Update ("ASU") 2016-13, *Financial Instruments - Credit Losses* (Topic 326) amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure and other financial instruments recorded at amortized cost.

The Plan adopted the new standard effective October 1, 2023, using the modified retrospective approach. Comparative prior periods were not adjusted upon adoption. Upon adoption, there was no cumulative-effect adjustment to the opening fund balance.

2. DESCRIPTION OF THE PLAN

The Plan was established under the terms of a Trust Agreement between California Metal Trades Association; International Molders and Allied Workers Union, AFL-CIO; and International Molders and Allied Workers Union, Local 164. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan is administered by a Board of Trustees.

The purpose of the Plan is to provide medical, dental, life insurance and substance abuse rehabilitation benefits for eligible participants and their dependents. The Plan provides medical benefits exclusively through health maintenance organizations, including Kaiser Foundation Health Plan. Dental benefits are provided to certain participants directly through insurance contracts with Delta Dental of California. Life insurance and accidental death benefits are provided through insurance policies with New York Life Insurance Company. Substance abuse rehabilitation benefits are provided directly by the Plan.

Plan participants can elect to participate in either a deductible plan with Health Reimbursement Accounts (“HRAs”) or a traditional HMO arrangement. On an annual basis, for participants in the HRA deductible plan, the participants’ HRAs are credited with an amount set by the Board of Trustees. The Trustees have set a funding amount of \$500 per eligible participant per year (\$1,000 per family per year).

Plan participants file HRA reimbursement requests directly with the third-party administrator. To the extent the Plan participants do not use the full HRA amount by the end of each calendar year, the remaining balances will remain as general assets of the Plan. The available HRA balances as of September 30, 2024 and 2023, totaled \$14,734 and \$39,270, respectively.

Participants are eligible for benefits after 90 days of consecutive employment. The Plan uses a method of providing eligibility to participants whereby employment in a one-month period beginning on the 16th day of the preceding month provides eligibility for benefits in the current month. Accordingly, the estimated cost of October coverage based on applicable hours worked in September is reflected as accumulated eligibility credits in the accompanying financial statements.

Participants should refer to the Summary Plan Description for more complete information.

3. PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

4. TAX STATUS

The Plan obtained its latest determination letter, dated April 16, 1965, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan’s administrator and the Plan’s counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

The Plan’s administrator has analyzed the tax positions taken by the Plan and has concluded that, as of September 30, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s administrator believes the Plan is no longer subject to income tax examinations for the fiscal years prior to 2021.

5. FUNDING POLICY

The Plan is funded by contributions from employers located in Northern California and from participants electing COBRA coverage. Depending on the participant's choice of benefits, the participant may be required to pay for a portion of their coverage. The monthly employer contribution rates are specified in the effective collective bargaining agreements. Certain employers are required to make additional contributions for Kaiser Foundation Health Plan participants in the HRA program who have dependents; the contribution rates are specified in the collective bargaining agreements. The participant contribution rates are determined annually by the Board of Trustees in consultation with the Plan's consultant.

6. CASH CONCENTRATIONS

The cash balance as of September 30, 2024 and 2023, consisted of the following:

The Plan has significant cash balances at financial institutions which throughout the year regularly exceed the federally insured limit of \$250,000. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan's financial condition, results of operations, and cash flows.

7. MAJOR EMPLOYER

The Plan has one employer that accounts for approximately 77% and 61%, respectively, of contributions for the years ended of September 30, 2024 and 2023 and contributions receivable as of September 30, 2024 and 2023. In the event this employer suspends contributions, the Plan would terminate coverage to the employers' participants, as required under the Plan Document. The Plan would retain the risk of current fixed administrative expenses until the appropriate adjustments were made.
