BMI COMPANIES RETIREMENT SAVINGS PLAN NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF PLAN

The following description of the BMI Companies Retirement Savings Plan, (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description and the plan and Trust Agreement for more complete information of the Plan’s provisions.

General

On January 1, 1997, BMI Financial Group, Inc. (“BMI” or “the Company”) adopted the BMI Companies Retirement Savings Plan. The Plan has been amended since its inception to change certifying entities and the investment option offered to participants and to reflect an increase under the permissible amounts allowed under Section 415. The plan is intended to be a qualified retirement plan under the Internal Revenue Code. BMI is the participating employer for the Plan.

The purpose of the Plan is to enable employees to save for retirement. It may also provide certain benefits in the event of death, disability, or other termination of employment. The Plan is a defined contribution plan for the exclusive benefit of eligible employees and their beneficiaries.

Employees are automatically enrolled into the Plan, a voluntary elective contribution of 2% will be deducted from the before-taxes pay and deposited into the retirement account in the Plan’s default. The employee must be 19 years of age and must have completed 3 months of service to be eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees can contribute a dollar amount up to the maximum established by law. The total maximum allowable contribution per participant to the Plan directly from the participant for the year ended December 31, 2024 was \$23,000, not including additional catch-up contributions of \$7,500 allowed for participants over the age of 50.

The matching percentage contributed by the Company is discretionary and is determined annually by the Company’s Board of Directors. The Company elected to match 25% of a participant’s compensation for the first 6% of each participant’s eligible compensation for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with all contributions made on behalf of the participant and any income, expenses, gain or losses, thereon. The benefit to which a participant is entitled is the balance that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their elective deferrals, rollover contributions, plus or minus any earnings or losses thereon, which cannot be forfeited for any reason. BMI matching and profit sharing contributions are vested based on the following schedule.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions, employer matching contributions and any related earnings in the investment options offered by the Plan. Reliance Trust Company (“Reliance”) is the appointed certifying entity of the Plan’s assets at December 31, 2024 and 2023. Contributions may be allocated in 1% increments and participants may change their investment elections at any time.

Notes Receivable from Participants

Participants may borrow from the fund accounts a minimum of \$1,000 up to 50% of their vested account balance. The Plan allows participants to have a maximum of two loans outstanding at any time. Loan terms typically range from one to five years.

The loans are secured by the balance in the participant’s account. Principal and interest is re-paid through payroll deductions. The interest rate on outstanding loans for years ended December 31, 2024 and 2023 varied. The interest rate applicable to loans originated on December 31, 2024 and 2023 was between 4.25% and 9.50%.

Payment of Benefits

The participant’s entire account balance is paid to the participant or the beneficiary, if the participant retires, becomes permanently disabled, dies, or terminates employment with BMI after completing six years of service. The entire amount may be paid in one lump sum or in installments.

A participant whose employment with BMI is terminated prior to retirement is entitled to receive benefits equal to the participant’s contributions plus the vested amount of BMI contribution. Forfeited amounts are used to pay administrative expenses and any remaining amounts are used to reduce future BMI contributions.

Forfeitures

Forfeitures relate to contributions made by BMI on behalf of employees terminated from the Plan which are not vested at the terminated date. These funds may be used by BMI to reduce future employer contributions and to pay administrative expenses incurred by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on a modified cash basis of accounting. Accordingly, investment income and contributions are recognized when received; and benefits and administrative expenses are recognized when paid.

Investment Valuation and Income Recognition

Investments are valued based on the quoted market prices of the underlying assets held in each fund by utilizing the practical expedient under the guidance set forth in ASC 820 that allows the use of Net Asset Value as its fair value measurement if certain criteria are met.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains (losses) on the sale of securities are computed under the current value method (sales proceeds less current value of asset at the beginning of the Plan year or acquisition cost if acquired during the year).

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan payments and the Plan administrator considers the participant loan to be in default, the loans are reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risk and Uncertainties

Financial instruments that potentially subject the Plan to risk of loss consist principally of investments. The Plan's investments are directed by each participant into one or more optional funds offered by the Plan and maintained by the certifying entity of the Plan. Each participant in the Plan bears the risk of market loss, if any. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits. No adjustments have been recorded in the accompanying financial statements as a result of this uncertainty.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

On occasion, certain administrative expenses of Reliance Trust, the Plan's certifying entity, and other professional fees (such as accounting and legal) are paid directly by BMI or through excess funds in the forfeiture account. BMI reserves the right to amend the Plan at any time, and allocate the administrative fees to the Plan participants. During the year ended December 31, 2024, administrative fees incurred by the Plan totaled \$10,790. Expenses that are paid by the Company are excluded from these financial statements.

Management's Review of Subsequent Events

Management has evaluated subsequent events through June 19, 2025, which is the date that the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY THE PLAN'S CERTIFYING ENTITY

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the certifying entity of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related net appreciation in value of investments and interest reflected in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

ASC 820 establishes a three-level valuation hierarchy for measurement and disclosure of fair value. The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 – asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 – other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.).

Level 3 – significant unobservable inputs (including management's own assumptions in determining the fair value of investments).

Registered Investment Companies: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common / Collective Trust: Valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the plan's certifying entity, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.
