Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of ZooTampa 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of September 30, 2024 and 2023 and for the year ended September 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Notes to Financial Statements

September 30, 2024 and 2023

(1) **Description of Plan**

The following description of the ZooTampa 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

(a) **General**

The Plan is a defined contribution plan sponsored by Lowry Park Zoological Society of Tampa, Inc. (the “Society”) for the benefit of its employees. All permissible employees of the Society, as defined in accordance with the universal availability rules, are eligible to enroll on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Variable Annuity Life Insurance Company (“VALIC”) serves as the custodian of assets held via group annuity contracts, which includes the guaranteed interest accounts and pooled separate accounts. VALIC Trust Company Inc. (“VTC”) serves as the custodian of assets held in mutual funds.

(b) **Contributions**

Each year, participants may contribute the maximum amount of annual compensation allowable by law as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. At its discretion, the Society may make employer matching contributions to the Plan. During the year ended September 30, 2024, the Society matching contribution was 100% up to 3% of eligible compensation through December 31, 2023, then 100% up to 4% of eligible compensation thereafter. In addition, the Society may make discretionary nonelective employer contributions to the Plan. Employees must be employed on the last day of the Plan year and must have worked 1,000 hours during the Plan year to be eligible for the discretionary nonelective contribution. The Society elected not to make a discretionary nonelective contribution for the year ended September 30, 2024. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

(c) **Participant Investment Account Options**

The Plan currently offers various mutual funds, pooled separate accounts and guaranteed interest accounts as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Notes to Financial Statements - Continued

(1) **Description of Plan - Continued**

(d) **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Society's matching contributions, as well as nonelective contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(e) **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Society's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited service.

Regardless of the vesting schedule, a participant becomes 100% vested upon attainment of normal retirement age (defined as age 65) or in the event of death or total and permanent disability.

(f) **Notes Receivable from Participants**

Participants may borrow from their mutual fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. Participants may not have more than one loan outstanding at any time. Loan repayment terms may not exceed five years unless the purpose of the loan is to acquire a principal residence.

Participant loans from group annuity contract fund options (i.e. guaranteed interest account and pooled separate account investments) are issued directly from the funds owned by VALIC, and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's account balance is reserved, or held in collateral, to cover the outstanding loan amount for the period of time the loan is outstanding. The loan collateral account is invested in a VALIC guaranteed interest account in an amount equal to the original principal of the loan plus the first quarter interest due and potential surrender charges. Participants had outstanding plan loan balances due to VALIC of \$44,360 and \$48,083 at September 30, 2024 and 2023, respectively.

(g) **Payment of Benefits**

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, annual installments over a specified period or partial withdrawals of less than the entire vested interest. If the vested interest in a participant's account is \$5,000 or less and a participant does not consent to a distribution of his or her vested balance, the vested balance will be automatically rolled over to an IRA selected by the plan administrator. The Plan also provides for in-service withdrawals for those age 59 ½ or older and for hardship withdrawals in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

(h) **Forfeited Accounts**

At September 30, 2024 and 2023, forfeited nonvested accounts totaled \$3,761 and \$1,069, respectively. The Society has discretion over how these accounts will be used. Also, for the year ended September 30, 2024, \$15,039 of forfeited nonvested accounts were used to pay plan expenses.

(2) **Summary of Significant Accounting Policies**

(a) **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

(b) **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

(c) **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(d) **Contributions**

Participant contributions and employer contributions are recorded in the year in which participant compensation is earned.

(e) **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

(2) Summary of Significant Accounting Policies - Continued

(f) Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in December 2024.

(g) Payment of Benefits

Benefits are recorded when paid.

(h) Administrative Expenses

Certain expenses of the Plan are paid by the Society and are not included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments.

(i) Reclassification

During the year ended September 30, 2024, management determined that the VALIC Fixed Account Plus and Short-Term Fixed Account were not fully benefit-responsive and should therefore be recorded at fair value. These investments were previously reported at contract value. Accordingly, the statement of net assets available for benefits as of September 30, 2023, has been revised to present \$258,873 previously reported as guaranteed interest accounts, at contract value to guaranteed interest accounts, at fair value. Additionally, the fair value leveling table as of September 30, 2023 in Note 4 has been updated to include these investments. This reclassification had no effect on the total net assets available for benefits.

(3) Information Prepared and Certified by the Custodians

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, VALIC and VTC, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Notes receivable from participants
- Net appreciation in fair value of investments
- Dividends
- Interest on guaranteed interest accounts

(3) Information Prepared and Certified by the Custodians - Continued

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Valued at the NAV of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.

(4) Fair Value Measurements - Continued

Guaranteed Interest Accounts: The VALIC Fixed Account Plus and Short-Term Fixed Account are investment options offered to participants through a fixed allocated annuity contract. As these investments are contract-based, observable prices for identical or similar investments do not exist, and accordingly, these investments are valued using unobservable inputs (Level 3). The fair value equals the accumulated contributions and interest credited to the contract, less any withdrawals and expenses. Each year, VALIC will declare and credit interest in the contract periodically, but not less than annually. The interest rate will be set in advance of the period to which it relates and will be at least 3.00% per year. The crediting interest rates ranged from 3.00% to 3.25% for the year ended September 30, 2024. For the year ended September 30, 2024, the average net return for the guaranteed interest accounts was 3.09%. Unobservable inputs are the composite crediting rates.

(5) Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive guaranteed investment contract with VALIC through which the Fixed Interest Option is offered to participants. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting interest rate is reviewed periodically for resetting, but no less frequently than annually and no more frequently than quarterly. The guaranteed investment contract does not have a scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if there were to initiate permitted transactions under the Plan. Contract value, as reported to the Plan by VALIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(5) Fully Benefit-Responsive Investment Contract - Continued

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

(6) Party-in-Interest Transactions

Certain Plan investments are units of pooled separate accounts managed by VALIC and guaranteed interest accounts which are held in the general accounts of VALIC. In addition, notes receivable from participants are managed by VALIC. VALIC is the custodian and recordkeeper for the Plan and therefore, these transactions qualify as party-in-interest transactions.

The Plan paid certain expenses related to the Plan's operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Society pays directly any other fees related to the Plan's operations.

(7) Plan Termination

Although it has not expressed any intent to do so, the Society has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(9) Tax Status

The Plan has adopted a volume submitter 403(b) plan document sponsored by VALIC. The IRS has determined that the volume submitter 403(b) plan document is designed in accordance with applicable sections of the IRC and informed VALIC of such in a letter dated April 5, 2018. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(11) Subsequent Events

The Plan was amended and restated effective October 1, 2024. The primary purpose of this restatement was to add an additional type of discretionary employer matching contribution to the Plan. This additional matching contribution will be made at the Society's discretion each year, will be funded on an annual basis, and will be determined based on the plan year.

Plan management has evaluated subsequent events through July 8, 2025, which is the date the financial statements were available to be issued.
