NOTES TO FINANCIAL STATEMENTS

Note A – Description of Plan

The following description of the Gordon Food Service, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing and 401(k) plan covering substantially all employees of Gordon Food Service, Inc., the Plan's sponsor, and the following related employers: Gordon Food Service Store LLC, GII Services, Inc., Limson Trading, Inc., GFSC Services, LLC, Gordon Restaurant Market, LLC, Pinnacle Realty Services, LLC, Perkins Paper, LLC (Texas Division, Mid Atlantic Division, and Carolinas Division), Relish Works, Inc., Halperns' Steak and Seafood Company, LLC, and NuProduce Solutions LLC (collectively, the Company). Employees may elect to become participants in the 401(k) and matching portion of the Plan upon employment. Also, after meeting employment criteria, employees become eligible to receive a discretionary contribution from the Company. Part-time employees must also have attained age 21 in order to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pre-tax and/or after-tax contributions to the Plan through payroll deductions from each participant's compensation, as defined, subject to certain limitations. A newly hired employee shall make an automatic deferral of 4% of eligible compensation which will increase annually by 1% of the participant's eligible compensation until the participant reaches a deferral rate of 10% unless the employee has instructed otherwise. The Plan also allows participants to transfer funds from other employer qualified plans into the Plan.

The Plan generally requires safe harbor matching contributions. For the years ended September 30, 2024 and 2023, the matching contribution was 100% of a participant's contribution up to 4% of compensation.

The Company may make a discretionary profit sharing contribution as determined by each employer or operating division of the employer. All divisions are eligible to receive the discretionary profit sharing contribution. To receive such a contribution, a participant must be employed by the Company on the last day of the plan year and have completed 90 days of service. If a participant terminates employment during the plan year as a result of retirement or death, that participant will still be eligible to receive a contribution.

Plan Operations

The Company has appointed Vanguard Fiduciary Trust Company (Trustee) to serve as Trustee and the Company to act as plan administrator. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan, ensures that all government and participant reporting requirements are fulfilled, and approves all distributions from the Plan to participants.

The Plan's fiduciary committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment strategy and monitors investment performance.

Participant Accounts

Individual accounts are maintained for each participant, with benefits limited to the amount contributed to the participant's account plus or minus any allocation of income, expenses, gains, or losses. Allocations to participant accounts are based on compensation or account balances, as specified by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose.

Vesting

Participants are immediately vested in their voluntary and matching contributions plus actual earnings thereon. Vesting in the discretionary profit sharing contribution accounts is based on years of continuous service, as follows:

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

Loans to Participants

Under certain conditions, a participant may obtain a loan from the Plan. A participant's loan cannot exceed the lesser of \$50,000 or one half of the participant's nonforfeitable interest in the Plan. The loan will bear a reasonable interest rate, be adequately secured, and not exceed a period of five years (15 years for purchase of primary residence). Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service a participant may elect to receive either a single lump sum amount equal to the value of the participant's vested interest in his or her account or installment payments. Payments of certain amounts from specific participants' accounts are to be paid by a joint and survivor annuity, if married, or a single life annuity, if single. With the proper waiver, a participant may elect to receive a lump sum payment of the vested interest in his or her account. In-service withdrawals are permitted upon attaining age 59½. Hardship withdrawals are permitted under certain circumstances.

Costs and Expenses

Certain transaction fees are charged to participant accounts and are based on reasonable and customary rates. Other costs and expenses incurred in connection with the operation of the Plan are borne by the Company.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to offset future employer contributions. The balance in the forfeiture account at September 30, 2024 and 2023 was approximately \$6,260,000 and \$4,931,000 respectively. During the plan years ended September 30, 2024 and 2023, forfeitures of approximately \$4,342,000 and \$2,048,000, respectively, were used to reduce employer contributions.

Note B – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Note B – Summary of Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported in the Plan's financial statements at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Income from interest is recorded as it is earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in mutual funds and common/collective trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document; therefore, an allowance for credit losses is not considered necessary at September 30, 2024 and 2023.

Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through June 27, 2025, which is the date the financial statements were available to be issued.

Note C – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note C – Fair Value Measurements (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets,
- quoted prices for identical or similar assets and liabilities in markets that are not active,
- other inputs that are observable or can be corroborated by observable market data,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies, and similar techniques that use significant unobservable inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual funds: Valued based on quoted net asset values of the shares held by the Plan on the last business day of the plan year.

Common/collective trust funds: Valued at net asset value (NAV) based on quoted market prices of underlying investments or the expected future cash flows for each underlying contract discounted to present value, as applicable. The funds held by the Plan provide for daily redemptions by the Plan at reported NAV.

Note D – Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statements of Assets Available for Benefits.

Note E – Information Certified by Trustee

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at September 30, 2024 and 2023, and net appreciation or depreciation in fair value of investments and interest and dividends and interest income on notes receivable from participants for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

Note F – Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and common/collective trusts managed by an affiliate of Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the Trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Note F – Party-in-Interest Transactions (Continued)

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were approximately \$1,989,000 and \$1,921,000 for the years ended September 30, 2024 and 2023, respectively. Such fees were based on reasonable and customary rates.

In addition, the Plan maintains notes receivable from participants. Those party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Note G – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

Note H – Tax Status

The Plan obtained its latest determination letter dated May 23, 2023, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has since been amended and restated and has requested an updated determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
