We have performed audits of the accompanying financial statements of Meridian Industries, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Meridian Industries, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1: Description of Plan

The following description of the Meridian Industries, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan was established on January 1, 1990, to provide retirement benefits to eligible employees of Meridian Industries, Inc. and its subsidiaries. The Plan qualifies as a defined contribution plan and is covered by the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Custodian and Recordkeeper of the Plan is John Hancock Trust Company LLC ("John Hancock").

#### Eligibility and Participation

The Plan includes all employees of Meridian Industries, Inc. (the "Company" or "Sponsor"), and participating subsidiaries, who have completed two months of service and who have attained the age of eighteen. Eligible employees become participants in the Plan on the first day of the month following attainment of these requirements. Employees who are covered by a collective bargaining agreement participate only as their bargaining agreement specifically provides for. All participants are entitled to receive their applicable share of annual discretionary Company match contributions made to the Plan as well as make voluntary contributions to the Plan.

#### Contributions

Annual voluntary contributions may not exceed 80% of the annual compensation paid to the participant, as defined, or Internal Revenue Service ("IRS") limitations.

Participants may also make rollover contributions to the Plan from other qualified retirement plans. Participant and rollover contributions are credited directly to participants' accounts. The Plan also includes an auto-enrollment provision whereby all newly-eligible employees who do not make a deferral election are automatically enrolled to contribute 4% of compensation. Participants will be increased 1% annually each November 1st to a maximum 10%, unless the participant elects differently.

Discretionary match contributions made by the Company to the Plan are determined annually at the discretion of the Board of Directors of the Company. The Company made discretionary match contributions to the Plan for 2024 and 2023 totaling \$1,671,549 and \$1,684,985, respectively. The amounts were offset by forfeitures of \$404 and \$45,680 in 2024 and 2023, respectively. Company discretionary match contributions are allocated to a participant's account based on the first 6% of compensation deferred.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, discretionary match contributions, and related plan earnings (losses) thereon, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The participant's vested account is the benefit to which the participant is entitled.

### Note 1: Description of Plan (Continued)

#### Notes Receivable from Participants

The Plan allows for participants to borrow up to 50% of their vested account balance up to a maximum of \$50,000. The principal amount of each note must be at least \$1,000. Only one note may be outstanding to a borrower at any time. Notes are repayable through payroll deductions over periods ranging from 12 to 60 months, or up to 15 years in the case of the purchase of a principal residence. The interest rate is based on the prevailing rates charged by commercial lenders for similar notes. At this time, the rate is equal to the prime rate plus 1% and is fixed over the life of the note. Interest rates on notes receivable from participants at December 31, 2024, ranged from 3.25% to 9.50%.

#### Vesting

Voluntary contributions and rollovers made by participants are fully vested. Participants receive a year of vesting service for each calendar year during which they complete at least 1,000 hours of employment. Company contributions also become fully vested in the event of death, permanent disability or the attainment of normal retirement age (65). Company contributions are subject to a five-year graduated vesting schedule as follows:

#### Participant Accounts and Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. These options consist of money market funds, mutual funds, common collective trust fund, or the choice to open a self-directed brokerage account. A common collective trust is an investment fund managed by a bank trust department and is similar to a mutual fund, but participation is limited to those with trust accounts. The PIMCO Stable Income Fund is a common collective trust fund within the Plan. The participant shares in the income of the trust fund based on their individual account balance. Each participant is able to allocate their account balances in 1% increments and change their investment elections daily.

#### Payment of Distributions

The Plan provides for a lump-sum distribution of the participant's total vested account as a result of death, disability, retirement or termination. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

#### **Forfeitures**

Forfeitures of former participants will first be used to pay administrative expenses of the Plan and any remaining forfeitures will be used to decrease the Company discretionary match. Forfeitures used to pay administrative expenses totaled \$53,555 and \$58,351 in 2024 and 2023, respectively. Forfeitures from unallocated accounts were used to reduce Company discretionary match contributions by \$45,680 and \$51,999 in 2024 and 2023, respectively. At December 31, 2024 and 2023, remaining unallocated forfeitures totaled \$112,747 and \$119,188, respectively.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Distributions**

Distributions are recorded when paid.

#### **Administrative Expenses**

Participants pay loan origination, individually directed account, distribution, recordkeeping, and investment related expenses. The administrative costs paid by the Plan include accounting and investment advisory services.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

#### Use of Estimates in Preparation of Financial Statements

GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of additions and deductions during the reporting period. Actual results may differ from these estimates and are subject to change in the near term.

#### Subsequent Events

The Plan has evaluated the impact of all subsequent events through June 27, 2025, which is the date the financial statements were available to be issued

### Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of money market funds, mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Common collective fund:* Valued at the NAV of the shares held by the Plan at year end. The NAV's share price is quoted on a private market that is not active; however, the unit price is based on underlying investments, which are traded on an active market. Investments can be purchased or sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 4: Information Certified by Plan Custodian**

Certain information in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the years then ended, were obtained or derived from information certified as complete and accurate by John Hancock, the Custodian of the Plan.

### **Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company contributions.

### **Note 6: Risk and Uncertainties**

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 7: Tax Status**

The Plan adopted a Prototype Plan with an IRS determination letter which states the Prototype Plan was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan's Sponsor believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC and the trust is tax-exempt.

### **Note 8: Party-In-Interest Transactions**

These transactions, previously described, are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.
