### **Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. We are required to be independent of the Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matters**

As explained in Note 5, the financial statements include investments valued at approximately \$1,664,000 (23 percent of net assets) at September 30, 2023, whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by fund managers. Our opinion is not modified with respect to this matter.

As discussed in Note 1 to the financial statements, the Fund has merged with the Operating Engineers' Local 324 Health Care Plan and terminated effective September 30, 2024. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Fund's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Fund; and determining that the Fund's transactions that are presented and disclosed in the financial statements are in conformity with the Fund's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

**Auditor's Responsibilities for the Audits of the Financial Statements**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of reportable transactions for the year ended September 30, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of the Fund's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Plan Description**

The following description of International Union of Operating Engineers Local 324 Health & Welfare Fund (the "Fund") provides only general information. A more complete description of the Fund's provisions is contained in the plan document and summary plan description, copies of which are available from the Operating Engineers Local 324 Union (the "Union") or the fund office.

The Fund is a multiemployer plan established as a result of collective bargaining agreements to provide health care, vision, prescription, and disability benefits for eligible participants employed in the state of Michigan and their dependents. The majority of the contributions to the Fund are made by participating employers at negotiated rates to provide the Fund with assets sufficient to meet the projected benefits to pay for wellness costs.

Eligibility under the Fund is established based on the participant's date of hire. If hired between the 1st day of the month and the 20th day of the month, the participant's eligibility commences on the first day of the next month following the month of hire. If hired between the 21st day of the month and the last day of the month, the participant's eligibility commences on the 1st day of the second month following the month of hire.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (COBRA), are provided by the Fund.

Participants should refer to the summary plan description for more complete information.

During 2023, the board of trustees directed and authorized a 15 percent increase in contribution rates, and another 25 percent increase was directed and authorized in March 2024. These increases were utilized to fund benefits on behalf of participants.

During 2024, the Trustees approved a merger agreement for the Fund to merge into the Operating Engineers' Local 324 Health Care Plan (the "Health Care Plan"), which was effective September 30, 2024 at which point the Fund was terminated. All assets, liabilities, and postretirement benefit obligations were transferred to the Health Care Plan as of September 30, 2024. The accounting policies disclosed were in effect prior to the merger.

**Note 2 - Summary of Significant Accounting Policies**

***Method of Accounting***

The financial statements were prepared using the accrual basis of accounting.

***Advance Employer Contributions and Contributions from Employers***

Advance employer contributions include contributions remitted prior to September 30 for coverage in a subsequent month.

Contributions from employers are recognized in the fund year in which participants provide services. Management would assess any receivables for an allowance for doubtful accounts. There was no allowance for doubtful accounts for the years ended September 30, 2024 and 2023.

***Investment Valuation***

The Fund's investments are stated at fair value.

**September 30, 2024 and 2023**

**Note 2 - Summary of Significant Accounting Policies (Continued)**

The limited liability company and pooled separate account are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. The money market fund is valued at fair value based on its outstanding balance. All other investments are valued based on quoted market prices. See Note 6 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Deposits***

Deposits represent amounts deposited in advance for health, dental, and other benefit payments processed by independent agencies.

***Claims Incurred But Not Reported***

The Fund's obligation for incurred but unreported claims is determined at the estimated ultimate cost of settlement at year end. The benefit obligations are determined using historical trend information and estimated amounts for claim payments after year end.

***Stop-loss***

Premiums for stop-loss insurance are included in insurance premium payments in the accompanying statement of changes in net assets available for benefits. There were no stop-loss refunds for the years ended September 30, 2024 and 2023.

***Self-funding of Benefits***

The Fund is self-insured for short-term disability, prescription, vision, dental, and a portion of health care benefits. Third-party claims administrators review, approve, and pay eligible benefits. The claims administrators provide estimates of benefits incurred but not reported as of each year.

Vision and dental benefits have maximum annual payments that can be made to any one participant; when these annual limits are reached, the benefit terminates for that year.

Short-term disability benefits have a maximum 26-week benefit period per claim.

The Fund is self-insured for prescription coverage for all eligible participants. The Fund charges its employers a premium rate comparable to premiums charged by insurance companies.

The Fund has an agreement with Blue Cross Blue Shield of Michigan to self-fund its health care coverage for some of its fund participants. The Fund has specific stop-loss insurance coverage. The stop-loss limit for per family was \$180,000 during 2024 and 2023.

***Risks and Uncertainties***

The postretirement benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions will occur in the near term and, due to the uncertainties inherent in setting assumptions, that the effect of such changes could be material to the financial statements. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. It is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the financial statements.

**September 30, 2024 and 2023**

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Party-in-interest Transaction***

Certain fund assets were in investment funds managed by Comerica. Comerica is the custodian of the Fund; therefore, these transactions qualify as party-in-interest transactions, as defined under the Employee Retirement Income Security Act of 1974 (ERISA) guidelines.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including June 17, 2025, which is the date the financial statements were available to be issued.

Subsequent to year-end, the Fund reached a settlement with a third-party related to an on-going eligibility review. The settlement of approximately \$400,000 was received by the Operating Engineers Local 324 Health Care Plan as it was subsequent to the merger.

**Note 3 - Priorities upon Termination**

As described in Note 1, the fund merged and terminated as of September 30, 2024. To safeguard against any unforeseen contingencies, the right to alter, amend, or terminate the Fund is reserved by the trustees. In the event of termination, the trustees shall first satisfy or make provisions to satisfy the obligations of the Fund. Any remaining fund assets will be distributed in such manner as will, in the opinion of the trustees, bring about the purpose of the Fund. Termination shall not permit any part of the Fund to be used for or diverted to purposes other than the exclusive benefit of the participants and beneficiaries.

**Note 4 - Tax Status**

The trust established under the Fund to hold the Fund's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"); accordingly, the trust's net investment income is generally exempt from income taxes. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service, and the plan sponsor believes that the trust continues to qualify and to operate in accordance with applicable provisions of the Code.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

The following table presents information about the Fund's assets measured at fair value on a recurring basis at September 30, 2023.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Fund has the ability to access.

**Note 5 - Fair Value Measurements (Continued)**

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Fund’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

(1) The Merganser Short-Term Bond Fund LLC's objective is to seek a high risk-adjusted return on capital invested by its members. The fund primarily invests in fixed-income securities, including debt securities, mortgage-related securities, and asset-backed securities.

**Note 6 - Postretirement Benefit Obligation**

The Fund provided retired participants with an opportunity to continue medical and life insurance coverage by self-paying contributions. Benefits related to this coverage are expensed as incurred, and contributions are recorded when received.

The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to participant service rendered through year end. Postretirement benefits include future benefits expected to be paid to or for currently retired participants and their beneficiaries and dependents and active participants and their beneficiaries and dependents after retirement from service. Prior to an active participant’s full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant’s service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost and participant payment data to estimate future annual incurred claims cost per participant and to adjust such estimates for time value of money and the probability of payment between the valuation date and the expected date of payment.

For measurement purposes, a 7.9 percent and 7.5 percent annual rate of increase in the per capita cost of covered health care benefits was assumed for the years ended September 30, 2024 and 2023, respectively. For 2024, the rate was assumed to decrease to a rate of 4.0 percent by a percentage point decrease ranging from 0.1 to 1.00 percent per year through 2040 and to remain at that level thereafter. For 2023, the rate was assumed to decrease to a rate of 4.0 percent by a percentage point decrease ranging from 0.1 to 1.00 percent per year through 2039 and to remain at that level thereafter.

The effect of a 1 percentage point increase in the assumed health care cost trend rate for each future year on the postretirement benefit obligation is \$11,121 and \$61,147 at September 30, 2024 and 2023, respectively. The Fund's current cost of providing postretirement benefits is approximately \$0 and \$13,500 at September 30, 2024 and 2023, respectively, net of the contributions made toward the benefits by participants receiving benefits.

In 2023, the increase in the Fund's postretirement benefit obligation was due to changes in actuarial assumptions related to the discount rate, updated mortality tables, and medical trend rates.

In 2024, changes in actuarial assumptions related to the discount rate and medical trend rates increased the Fund's postretirement benefit obligation.

The above assumptions are based on the presumption that the Fund merged with the Operating Engineers' Local 324 Health Care Plan as of September 30, 2024, as disclosed in Note 1.

### Note 7 - Retiree Health Reimbursement Account

Prior to the merger, the Fund entered into an agreement with several of its employers to provide funding for retirees to cover certain medical expenses. The Fund was funded by the employers based upon the respective collective bargaining agreements. The beneficiaries were subject to the terms and conditions of the Fund. The Fund had no obligation to pay any health benefits beyond the amount funded. The funded amount was included in the Fund's investments, which were transferred as part of the merger with the Operating Engineers' Local 324 Health Care Plan, as indicated in Note 1. As such, the obligation for the total amount funded is included in the statement of fund benefit obligations as \$0 at September 30, 2024.
