(1) Description of the Plan

The following description of the SRC, Inc. 403(b) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering substantially all employees of SRC, Inc. (SRC), who are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). SRC, Inc. is both the Plan sponsor and Plan administrator.

(b) Contributions

Each year, participants mandatorily contribute five percent of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, as well as additional salary deferrals, subject to certain limitations.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Participants who make elective deferrals over the mandatory five percent have the option to contribute to a Roth IRA fund.

(c) Participant Accounts

The Plan administrator maintains separate accounts in the name of each participant. Each participant's account is credited with the participant's contribution and respective allocations of net Plan earnings. The custodian's expenses are paid from each participant account, as a reduction of investment income, according to formulas established each year with the objective of keeping the reimbursements as close as possible to each account's actual expenses. Allocations are based on participant earnings or account balances, as defined. All other expenses are paid by the Plan Sponsor. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon.

(1) Description of the Plan, Continued

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from two to five years. Loans are secured by the balance in the participant's account and bear interest commensurate with local prevailing rates as determined quarterly by the Plan administrator, which range from 4.25% to 9.50%. Principal and interest is paid ratably through monthly payroll deductions.

(f) Loans to Participants

Prior to July 1, 2019, participants could borrow directly from Teachers Insurance and Annuity Association (TIAA), formerly known as Teachers Insurance and Annuity Association/College Retirement Equities Fund (TIAA-CREF), the Plan custodian, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 45 percent of the combined accumulations attributable to their retirement plan under the originating CREF Certificate and the companion TIAA contract. Collateral for the loan is held in the TIAA Traditional Annuity at 110% of the outstanding loan amount.

The loans are not shown in the Plan's statements of net assets available for benefits as the loans are not made from Plan assets and are, therefore, not considered assets of the Plan. Loan interest rates are fixed at prevailing interest rates. Principal and interest is paid ratably by the participant directly to TIAA over a maximum of 5 years (up to 10 years for the purchase of the participant's primary residence). On December 31, 2024 and 2023, loans to participants amounted to \$184,157 and \$215,484, respectively.

(g) Payment of Benefits

Upon retirement or disability at any age, the participant shall be entitled under the terms of the Plan to receive monthly or periodic income under one of the annuity options, or the participant may choose a lump-sum distribution.

In the event a participant dies prior to commencement of retirement benefit payments, the full current value of the annuity accumulation is then payable to the beneficiary or beneficiaries named by the participant in a single sum or under any one of the income options offered by TIAA.

A participant terminating employment for reasons other than retirement or disability may choose a lump-sum distribution or choose to wait until he or she reaches retirement age as defined in the Plan.

The Plan will make a mandatory distribution following severance of employment if the participant's accumulated benefit does not exceed \$5,000.

Benefits are recorded when paid.

(2) Summary of Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policy utilizing information provided by investment advisors and the custodian. See note 5 for discussion of fair value measurements.

Participants who have elected the Traditional Annuity contract have entered into benefit responsive contracts with TIAA, which consist of both fully benefit responsive and non-fully benefit responsive contracts. TIAA maintains contributions in general accounts and accounts are credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses. The non-fully benefit responsive contracts, consisting of fixed return contracts, are included in the financial statements at fair value as reported by TIAA. Contract value represents contributions made under the contract, plus earnings less withdrawals and administrative expenses. The contracts buy a contractual or guaranteed amount of future benefits, which are subject to certain withdrawal limitations.

(2) Summary of Accounting Policies, Continued

(c) Investment Valuation and Income Recognition, Continued

Withdrawal fees represent fees incurred if a participant separates from service and elects to withdraw accumulations from the traditional annuity within 120 days of separation.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation in the fair value of investments consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments.

(d) Subsequent Events

Subsequent events have been evaluated through June 27, 2025, which is the date the financial statements were available to be issued.

(3) Investment Contracts with Insurance Company

Participants who have elected the Traditional Annuity contract have entered into benefit responsive contracts with TIAA. TIAA maintains contributions in general accounts and accounts are credited with earnings on the underlying investments and charged with participant withdrawals and administrative expenses.

Certain annuity contracts underlying the Traditional Annuity contract are fully benefit responsive and therefore reported at contract value. Accordingly, as described in note 2(c), contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the annuity contract. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(3) Investment Contracts with Insurance Company, Continued

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the non-fully benefit responsive contracts through TIAA at December 31, 2024 and 2023 was \$33,946,925 and \$35,144,953, respectively, and the contract value of the fully benefit responsive contracts at December 31, 2024 and 2023 was \$22,426,420 and \$21,997,126, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(5) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(5) Fair Value Measurements, Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Annuity contracts: Valued based on accumulated cash contributions and earnings on the contract, less any withdrawals and administrative expenses.

Pooled separate accounts: Units of pooled separate accounts are valued at each accounts net asset value (NAV) as determined by TIAA as a practical expedient to estimate fair value.

(6) Party-in-Interest Transactions

Plan investments include shares of mutual funds and annuities managed by TIAA. TIAA is the custodian and recordkeeper, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

(7) Plan Termination

Although it has not expressed any intent to do so, SRC has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

(8) Tax Status

The Plan has been established using a volume submitter plan designed and maintained by the Plan's third-party administrator. The Internal Revenue Service (IRS) has determined and informed the volume submitter sponsor by a letter dated August 7, 2017, that the volume submitter plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
