### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audits of the financial statements of ET Works Retirement Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **Note 1. Description of Plan Provisions**

The following description of the ET Works Retirement Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan provisions.

### **General**

ET Works Retirement Plan is a defined contribution plan administered by ET Works, Inc. d/b/a Equipment Technologies and Subsidiaries (Company). The assets of the Plan are held by Empower Trust Company LLC and Empower Annuity Insurance Company of America, previously Great-West Life & Annuity Insurance Company. The Plan was established January 1, 1998 and amended January 1, 2023. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended.

### **Eligibility**

All employees who have completed 250 hours of service within a consecutive 3-month period and have attained the age of 18 may elect to participate in the Plan. Prior to amendment effective January 1, 2023, employees had to attain the age of 21.

### **Contributions**

Each year, participants can elect to make pre-tax or Roth contributions to the Plan by means of a salary deferral agreement up to the maximum amounts permitted by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified retirement plan and certain Individual Retirement Accounts.

Each year the Company may contribute a discretionary amount to the Plan, which is then allocated to participants equally based on a uniform percentage of salary. Additional discretionary matching contributions may not exceed 4% of compensation. During 2024, no discretionary amounts were contributed at the option of the Company's Board of Directors.

The Company is required to make safe harbor matching contributions. The Company manually computes the employer match as 100% of compensation deferred, up to 3% and 50% of deferrals between 3% and 5% of a participant's compensation.

The Plan utilizes an automatic enrollment feature for eligible employees. Unless participants otherwise enroll or specifically decline to contribute, participants hired on or after January 1, 2018 are automatically enrolled at 3% deferral rate of compensation. Fixed deferral rates auto-increase by 1% each plan year until the deferral reaches 6% of compensation unless participants otherwise enroll or specifically decline.

The entry date for all contributions is the first day of the month following eligibility. Contribution deferral rates can be changed each pay period.

### **Investment Options**

Upon enrollment in the Plan, participants may direct the investment of their contributions and all matching contributions into various mutual funds and a guaranteed investment option offered by the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, an allocation of the Company's contribution, Plan earnings (losses), and Plan expenses. Allocations are based on participant earnings (losses) or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

***Withdrawals***

On termination of service due to death, disability or retirement, a participant is entitled to receive the entire amount credited to his or her account. For termination of service due to other reasons, a participant may receive the entire amount in his or her compensation deferral contribution account and his or her discretionary contribution account. The participant is also entitled to receive the "vested percentage" of his or her matching contribution and supplemental contribution accounts. Participants may make withdrawals for financial hardship based on certain conditions defined in the Plan.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent (50%) of their vested account balance. The loans are secured by the balance in the participant's account. Principal and interest are repaid over a period not to exceed five years. However, if the loan is for the purchase of a principal residence, the administrator may permit a longer repayment period. Repayments are made through payroll deductions and are reinvested in the participant accounts according to individual investment elections. Interest rates at December 31, 2024 ranged from 4.50% to 9.50% per annum.

***Vesting***

Participants are immediately vested in their own contributions and all matching contributions, plus actual earnings thereon. This includes the Plan's discretionary match contributions prior to January 1, 2023, the date that immediate vesting was adopted.

***Forfeiture Amounts***

At December 31, 2024 and 2023, there were unused forfeitures of \$29 and \$27, respectively. Forfeitures may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During 2024, approximately \$1,634 of employer contributions and \$259 of plan expenses were paid from the forfeiture account.

***Administrative Expenses***

Expenses of the Plan, including administrative and professional fees, are paid on behalf of the Plan by the Company. Certain investment related fees are paid by the Plan.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully-benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses in investments bought and sold as well as held during the year.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants subsequently in 2024. No excess contributions were required to be distributed for the 2024 plan year.

***Subsequent Events***

The Plan has evaluated subsequent events through July 1, 2025, which is the date the financial statements were available to be issued.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Fair Value Measurements**

U.S GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability;
- and inputs that are derived principally from or corroborated by observable market data by correlation or other means and
- if the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

*Mutual funds:* Mutual funds are stated at fair value based on quoted market prices in an active market for each share held by the plan.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Investment Contract with Insurance Company**

The guaranteed investment contract is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Empower Annuity Insurance Company of America, previously Great-West Life & Annuity Insurance Company. The contract is fully benefit responsive and is reflected in the financial statements at contract value which approximates fair value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower Trust Company LLC and Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$60,217 and \$55,237, respectively.

The existence of certain conditions can limit the trust's ability to transact at contract value with the issuers of its investment contracts. Specifically, any event outside the normal operation of the trust that causes a withdrawal from an investment contract may result in a negative market value adjustment with respect to such withdrawal. Examples of such events include, but are not limited to, partial or complete legal termination of the trust or a unit holder, tax disqualification of the trust or a unit holder, and certain trust amendments if issuers' consent is not obtained. As of December 31, 2024, the occurrence of an event outside the normal operation of the trust which would cause a withdrawal from an investment contract is not considered to be probable.

**Note 6. Party-in-Interest Transactions**

The guaranteed investment contract is managed or issued by an affiliate of the custodians, and therefore, these transactions qualify as party-in-interest transactions.

Administrative fees related to the administration of the Plan are paid by the Plan and, therefore, these transactions qualify as party-in-interest transactions, totaling \$73,889 for the year ended December 31, 2024. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.

### **Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8. Plan Termination**

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and upon resolution by the Company's Board of Directors. In the event of Plan termination, affected participants who are actively employed by the Company at the time of termination shall be fully vested in their employer contributions.

### **Note 9. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Empower Retirement LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examinations by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **Note 10. Reconciliation of Financial Statements to Form 5500**

Form 5500 was prepared on a cash basis and the financial statements were prepared on the accrual basis for the Plan year ended December 31, 2024.
