Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be significant deficiencies or material weaknesses, and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, we identified a combination of deficiencies in internal control that, in the aggregate, we consider to be material weakness and another deficiency that we consider to be a significant deficiency.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis.

A material weakness is a deficiency, or a combination of deficiencies, in internal control such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We consider the following deficiency in the Plan's internal control to be material weakness:

General Contribution, Loan Repayment, and Payroll Controls

The Plan lacks certain controls over contributions and loan repayments, which, when considered in the aggregate, create a risk of material misstatement. Our findings include the following:

- **Late Participant Contributions and Loan Repayments** - Controls over compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA did not ensure the timely deposit of employee contributions and loan repayments, as required by the DOL. As a result, the net assets of the Plan could be understated for those contributions and related lost earnings, and the Plan would be out of compliance with DOL Rules and Regulations for Reporting and Disclosure under ERISA.

A DOL regulation requires that benefit plans remit employee contributions to the plan as soon as they can be reasonably segregated from the employer's general assets. In no case can this amount of time exceed 15 business days after the end of the month in which the amounts were withheld. The 15-business-day rule, however, is not a safe harbor. The general rule has been interpreted as being as little as zero days for entities with more than 100 employees. The DOL also looks at the consistency of timing and holds employers to a deposit standard, which is the employer's historically fewest number of days to actually deposit employee contributions, when determining if contributions are timely.

- **Lack of Supervision Surrounding Contributions and Loan Repayments** - In addition to late participant contributions described above, the plan sponsor did not have controls in place to ensure that certain employer contributions and participant loan repayments withheld from employee wages were remitted timely to the Plan, resulting in lost earnings. Lastly, accurate documentation was not retained to support all deferral elections made by participants. As a result, certain contributions made to the Plan could not be validated.

**Section I - Internal Control Related Matters Identified in an Audit
(Continued)**

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiency in the Plan's internal control to be a significant deficiency:

Late Form 5500 Filings

The Plan does not have controls in place to ensure compliance with the Department of Labor's requirements to file a timely and complete Form 5500. As a result, the Plan is not in compliance with DOL Rules and Regulations for Reporting and Disclosure under ERISA.

Section II - Required Communications with Those Charged with Governance

Our Responsibility Under U.S. Generally Accepted Auditing Standards

As stated in our engagement letter dated April 21, 2025, we conducted our audits in accordance with professional standards except that, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA and as instructed by you, we did not perform any auditing procedures with respect to certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America (GAAP). The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, were audited by us in accordance with auditing standards generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, were subjected to tests of your accounting records and other procedures as we considered necessary to enable us to express an opinion as to whether they are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Our audits of the financial statements do not relieve you or management of your responsibilities. As part of our audit, we considered the applicable internal controls of the Plan. Such considerations were solely for the purpose of determining our audit procedures and not to provide any assurance concerning such internal control.

We are responsible for communicating significant matters related to the audits that are, in our professional judgment, relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures specifically to identify such matters.

During 2022 and 2023, the plan sponsor remitted certain participant deferral contributions and loan repayments to the Plan after the time frame required by the DOL, as reported in the supplemental schedule of delinquent participant contributions. The contributions were remitted during 2022 and 2023, and related lost earnings will be remitted in 2025. The plan sponsor is aware of tax filing requirements and intends to comply.

In addition, an incomplete Form 5500 was filed on October 15, 2024 without the audited financial statements attached. The Plan will file a revised Form 5500 with the audited financial statements attached in 2025.

Planned Scope and Timing of the Audits

We performed the audits according to the planned scope and timing previously communicated to you in our meeting about planning matters on March 8, 2023. However, as noted in that communication, the original plan was to issue the audited financial statements by the filing deadline. Due to delays associated with determining the extent of late participant contributions and various other compliance issues surrounding contributions and access to information, filing of the Form 5500 and related issuance of the audited financial statements will occur subsequent to the required filing deadline.

Significant Audit Findings

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. In accordance with the terms of our engagement letter, we will advise management about the appropriateness of accounting policies and their application. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2022 or 2023.

We noted no transactions entered into by the Plan during the periods under audit for which there is a lack of authoritative guidance or consensus.

Section II - Required Communications with Those Charged with Governance (Continued)

We noted no significant transactions that have been recognized in the financial statements in a different period than when the transaction occurred.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was the Plan's valuation of investments.

Management has informed us that, in determining the appropriateness of the estimate of investment values, they have recorded the fair values based on market values provided by the investment custodian, plus any applicable valuation adjustments. We performed no specific procedures related to the valuation of the investments due to the scope and nature of an ERISA Section 103(a)(3)(C) audit.

The disclosures in the financial statements are neutral, consistent, and clear.

Difficulties Encountered in Performing the Audits

Our audits were significantly delayed due to management's difficulty obtaining requested audit documents as a result of the transition. We encountered no other significant difficulties in performing and completing our audits.

Disagreements with Management

For the purpose of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report.

We are pleased to report that no such disagreements arose during the course of our audits.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audits, other than those that are trivial, and communicate them to the appropriate level of management. The attached schedule summarizes uncorrected misstatements of the financial statements that were requested to be recorded for the year ended December 31, 2022. Management has determined that their effects are immaterial, both individually and in the aggregate, to the financial statements taken as a whole. However, uncorrected misstatements or matters underlying those uncorrected misstatements could potentially cause future period financial statements to be materially misstated.

Significant Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards and plans and strategies that may affect the risks of material misstatement, with management each year prior to our retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship, and our responses were not a condition of our retention.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated June 25, 2025.

Form 5500 - Annual Return/Report of Employee Benefit Plan

Our responsibility for Form 5500 does not extend beyond the financial statements, and we do not express an opinion or any form of assurance on Form 5500. However, we read the Plan's Form 5500 filings, and nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information or manner of its presentation appearing in the financial statements.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of The Wesley Communities 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of July 26, 2023; December 31, 2022; and December 31, 2021 and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through July 26, 2023 and the year ended December 31, 2022 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of July 26, 2023; December 31, 2022; and December 31, 2021 and for the period from January 1, 2023 through July 26, 2023 and the year ended December 31, 2022 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 - Plan Description

The following description of The Wesley Communities 403(b) Plan (the "Plan") prior to the Plan being merged into the Life Enriching Communities 403(b) Plan, as further discussed in Note 7, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established on January 1, 2007 and amended and restated as of March 1, 2018, is a defined contribution plan covering all employees of The Wesley Communities and its wholly owned subsidiaries (the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferrals subject to maximum tax-deferred and after-tax Roth limitations established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Certain loan repayments in 2023 and participant contributions and loan repayments in 2022 were paid after the time frame required by the Department of Labor. The Organization will remit these loan repayments and contributions and related lost earnings in 2025.

The Organization may make discretionary matching and/or nonelective contributions to eligible participants, which are those who have completed one year of service and are age 21 or older. The Organization elected to make matching contributions of 50 percent of participant deferral contributions limited to 2 percent of compensation in 2022. The Organization did not make any matching contributions in 2023. The Organization did not make any discretionary nonelective contributions in 2023 or 2022.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Organization's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Notes Receivable

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at 1 percent over the prime rate and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence).

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum or direct rollover to another qualified plan equal to the value of the participant's vested interest in his or her account. Account balances less than \$5,000 are paid in a single lump upon termination. Once participants attain age 59½, they may elect to withdraw from their accounts any amount not to exceed their vested portion. All accounts are subject to distribution upon the participant's termination, retirement, or death.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the employer contributions plus earnings thereon is in accordance with the following schedule:

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future organization contributions and plan expenses.

Party-in-interest Transactions

The Plan invests in certain investments managed by Empower Annuity Insurance Company of America (formerly known as Great-West Life & Annuity Insurance Company) (EAICA); Empower Trust Company, LLC (formerly known as Great-West Trust Company, LLC) (Empower Trust); Reliance Trust Company (Reliance); and Massachusetts Mutual Life Insurance Company (MassMutual) or their affiliates (collectively, the "Custodians"). Transactions of the Custodians qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

The Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except as noted below.

The fully benefit-responsive investment contract is valued as contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

All other investments are valued based on quoted market prices reported in active markets. See Note 6 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued but unpaid interest. Participant notes receivable are reclassified and written off when deemed uncollectible based on the terms of the plan document.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Various administrative costs are paid by the Organization.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including June 25, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

During 2022, the Plan changed custodians for a portion of the Plan from Reliance to Empower Trust. Empower Trust, MassMutual, and Reliance Trust held the Plan's investments and participant notes receivable and executed all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Empower Trust; Reliance Trust; and EAICA, on behalf of MassMutual.

Note 4 - Investment Contract

The Plan has a benefit-responsive investment contract with MassMutual. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest will be credited daily on all contributions. The rate of interest credited each day, if compounded for 365 days, yields the effective annual interest rate in effect for the day. The guarantee that will be credited is an effective annual interest rate of no less than the minimum guaranteed interest rate. Interest crediting rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan merger, further described in Note 7, did not impact the ability of participants to transact at contract value with the issuer.

Note 5 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated February 1, 2018. The Plan has not individually sought its own determination letter.

Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The Plan measures investment in mutual funds at fair value on a recurring basis. The fair value of mutual funds is based primarily on Level 1 inputs, as described above.

Note 7 - Plan Merger

Effective July 2023, the Plan merged and combined with the Life Enriching Communities 403(b) Plan. Accordingly, all assets, participants, and their related account balances were transferred to the Life Enriching Communities 403(b) Plan in 2023.
