- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters--Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Sacramento Children’s Home, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established on July 1, 2004, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan provides benefits for all employees of Sacramento Children’s Home, Inc. (the Home).

Eligibility – Participants are eligible to begin deferring into the Plan immediately upon employment. To be eligible to receive employer matching contributions, a participant must complete one year of service, as defined, and have attained the age of 21.

Administration – The Home is the administrator of the Plan and, as such, carries out the duties imposed under ERISA. The Home has delegated certain responsibilities for the operation and administration of the Plan. Reliance Trust Company is the appointed custodian of the Plan’s assets (the Trustee). Recordkeeping and technical assistance are provided by Standard Retirement Services (Standard), a subsidiary of StanCorp Financial Group, Inc. Investments in stable value funds are held by the Standard Insurance Company, which is also a subsidiary of StanCorp Financial Group, Inc.; therefore, the related transactions are party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Contributions – Participant contributions are made to the Plan through salary deferrals (before-tax), or Roth deferrals (after-tax). The Plan agreement provides for automatic participant salary deferrals, under which the Home automatically withholds a percentage of each participant’s compensation each pay period, based on the number of Plan years that have passed since the participant was first subject to automatic enrollment (the later of October 1, 2013 or eligibility date), and transmits these assets to the Plan. The automatic deferral percentages are as follows:

Participants have the option to opt out of automatic deferrals, or to defer at alternate percentages, up to the maximum amount allowed by IRS limitations. Participants are also permitted to deposit into the Plan distributions received from other plans (rollovers).

Matching – The Plan document provides for discretionary matching contributions, to be determined by the Home. Annually, the Executive Committee to the Board of Directors approves the continuation of a matching contribution of 50% of a participant’s first 6% of deferred compensation. The total matching contribution can therefore be no more than 3% of the participant’s compensation. Matching contributions are deposited each pay period and reconciled at the end of the year.

Nonelective contributions – The Plan document provides for discretionary nonelective contributions, to be determined by the Home. No nonelective contributions were made in 2024.

Participant accounts – Individual accounts are maintained for each Plan participant to reflect the participant's contributions and related matching contribution. Income and loss is allocated to the participant's account based on the ratio of the account balance of the individual participant to the aggregate of all account balances of all participants in the fund within the Plan. The vested balance in a participant's account is the benefit to which the participant would be entitled upon termination or retirement.

Vesting – Participants' contributions and rollovers from other qualified plans are 100% vested at all times. The Home's matching and nonelective contributions are 100% vested after two years of service, and 0% vested prior to attaining two years of service.

Payment of benefits – Benefits are payable upon retirement, termination, attainment of age 59 ½, disability, hardship or death. Additionally, military participants who serve active duty for more than 30 days are entitled to receive benefit payments. Benefits are paid in either a single lump sum distribution or a rollover to another qualified plan or an individual retirement account.

Notes receivable from participants – Under certain circumstances, participants are allowed to borrow against their vested account balance. Notes receivable from participants must be for a minimum of \$1,000 and are capped at the lesser of one-half of the participant's vested account balance or \$50,000. All loans must bear a reasonable rate of interest as determined by the Plan administrator based on prevailing interest rates. Loans must be repaid in level payments through after-tax payroll deductions on at least a quarterly basis over a five year period unless it is for the purchase of a principal residence, in which case the loan repayment period may not extend beyond 10 years from the date of the loan.

Forfeitures – Forfeitures are kept in a separate account and may be used to reduce the employer paid administrative expenses or employer contributions. The forfeiture account balance was \$0 at December 31, 2024 and 2023. In the year ending December 31, 2024, forfeitures of \$4,044 were used to reduce employer contributions.

Investment options – Plan investments are self-directed by the individual participants. Upon enrollment in the Plan, a participant may direct contributions in any selected investment options consisting of mutual funds and stable value funds of varying risks.

Costs of administration – Administrative expenses for 2024 include \$15,291 of transaction fees for loan origination and processing and certain distributions, paid out of Plan funds by participants initiating the transactions, and \$66,102 of administrative costs paid to the Standard out of Plan funds and allocated to all participants with account balances. The Home pays the salaries and related benefits of the Plan administrator and contributes the office space where Plan business is conducted and where records are kept. Plan consulting and audit expenses are also borne by the Home. During the year ended December 31, 2024, the Home paid \$14,000 in such fees.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to the fully benefit-responsive investment contract because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income and gains (losses) are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are valued at the outstanding loan balance, plus accrued unpaid interest, which approximates fair market value.

Interest on notes receivable from participants – Interest on notes receivable from participants is recognized in the period it is assessed.

Payment of benefits – Benefits are recorded when paid. Corrective distributions payable generally represent the distribution of certain assets to employees in order for the Plan to comply with ERISA nondiscrimination rules.

Contributions – Employee contributions and the related employer match are recorded in the period payroll deductions are made.

Income taxes – The Home is an adopting employer of the Standard Retirement Services, Inc. 403(b) Volume Submitter Plan. The Internal Revenue Service notified Standard Retirement Services, Inc., by advisory letter dated March 31, 2017, that the Volume Submitter Plan is acceptable under section 403(b) of the Internal Revenue Code for use by eligible employers for the benefit of their employees. In 2019, the Plan was restated and adopted. Management believes the amended plan is operating in compliance with IRS regulations.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events have been evaluated for recognition and disclosure through July 7, 2025, the date which these financial statements were available to be issued. Management concluded that no material subsequent events have occurred since December 31, 2024, that require recognition or disclosure in such financial statements.

3. FULLY BENEFIT-RESPONSIVE INSURANCE CONTRACT

The Plan’s investments in the Standard Stable Value Asset A are offered through a group annuity contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the Plan’s investment in fully benefit-responsive investment contracts at December 31:

As a traditional investment contract, the contract issuer, Standard Insurance Company, owns the underlying assets, and the Plan owns the contract itself. Participant principal and interest are fully guaranteed by the general account assets of Standard Insurance Company. Each quarter, the Standard Insurance Company declares a crediting rate for all assets in the stable value funds for the coming quarter, taking into account yield forecasts from their asset advisory group and the margins required for their business. Past crediting rates are not indicative of future rates, and declared crediting rates will never be below 1%.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Although not expected, certain events may limit the ability of the Plan to transact at contract value with the Standard Insurance Company. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules.

4. PLAN TERMINATION

Although it has not expressed any intent to do so, the Home has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will automatically become fully vested in their accounts.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within a fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual funds are traded.

6. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investments, in general, are exposed to various risks, such interest rate, credit, and overall market volatility. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).
