NOTE 1 DESCRIPTION OF THE PLAN

Organization

The HCI Group, Inc. 401(k) Profit Sharing Plan (the “Plan”) is a defined contribution plan covering all eligible employees of HCI Group, Inc. (the “Company” or the “Employer”). The Plan was established on January 1, 2013 and most recently restated on December 15, 2023. It was most recently amended, effective August 15, 2024 with amendment number 1. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The following brief description of the Plan provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan’s provisions.

General

The Plan covers all eligible employees, as defined by the Plan Document. Employees are eligible to become a participant when they have completed three consecutive months of service and attain the age of 21, as defined in the Plan Document.

Contributions

Participants in the Plan may make a pre-tax elective deferral or Roth deferral up to 100% of their annual pretax compensation, not to exceed the maximum allowed by the Internal Revenue Code (the “Code”). In addition, the Plan permits participants age 50 or over during the Plan year to make additional catch-up contributions to the Plan also subject to IRS limitations. Participants may also contribute amounts representing distributions from other qualified retirement plans. Entry date is immediate upon satisfaction of eligibility requirements.

The Company will make a Safe Harbor matching contribution equal to 100% of elective deferrals up to 4% of eligible earnings.

The Plan offers discretionary employer profit sharing contributions to eligible participants. As of December 31, 2024, there were no discretionary employer profit sharing contributions.

Investment Options

Upon enrollment, a participant may direct participant and employer contributions to any of the Plan’s fund options. Participants may also redirect their contributions or exchange their existing fund account balances on any business day, effective on the following business day.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocation of employer contributions and Plan investment results. Allocations are based on compensation or a ratio of the participant’s specific account balance to the total of all participants’ account balances, as specified in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided by the participant’s account.

Notes Receivable from Participants

Participants may borrow from their account balances a minimum of \$1,000 to a maximum of the lesser of one half of the vested account value or \$50,000. The note must be repaid through payroll deductions, and amortized over a term of no more than five years, unless the note is for the purchase of a principal residence as per the Plan Document. A participant may not have more than one loan outstanding at any point in time. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus one percentage point.

Vesting

Participant's contributions, including rollover contributions, and actual earnings thereon, are 100% vested. In addition, Employer Safe Harbor matching contributions and actual earnings thereon are 100% vested when made by the Employer.

Payment of Benefits

Upon death, disability, retirement, or termination of service, participants or their designated beneficiaries may receive a lump-sum payment amount equal to the vested amount of their account.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or discontinue the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, the account of each participant will be 100% vested.

NOTE 2 SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash Equivalents

Certain Plan assets, held in money market accounts, are classified as cash equivalents. The Plan considers all highly liquid investments with maturities of three months or less when purchased to be cash equivalents.

Valuation of Investments

The Plan's investments are comprised of mutual funds, common collective trust funds, and a group annuity contract. The mutual funds and common collective trust funds are stated at fair value as reported by Empower Trust Company, LLC. (the "Custodian"), and Empower Annuity Insurance Company of America, on the last business day of the

Plan year. The majority of the Plan's investments are valued at quoted market prices, which represent the net asset values (the "NAV") of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Gain or loss on sales of securities is based on average cost. Dividend income is recorded on the ex-dividend date. Interest income is recognized as earned on the accrual basis.

In the statement of changes in net assets available for benefits, the Plan presents the net appreciation / (depreciation) in the fair value of its investments. This consists of the realized gains or losses and the unrealized appreciation / (depreciation) on those investments.

The Group Annuity Contract is valued at contract value.

Benefit Payments

Benefits are recorded when paid.

Forfeitures

Forfeitures of terminated non-vested accounts are used to reduce employer contributions. There were no forfeitures during the year ended December 31, 2024.

Plan Expenses

Record-keeping fees and audit fees are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in the fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document. Approximately \$2,000 in defaulted loans were reclassified as distributions in 2024. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Subsequent Events

In accordance with Financial Accounting Standards Board Accountancy Standards Codification ("FASB ASC") Topic 855, *Subsequent Events*, the Plan evaluated subsequent events through June 30, 2025; the date the financial statements were available for issue.

NOTE 3 INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of compliance as permitted by Section 29 CFR 2520.109(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee and custodian, Empower Trust Company, LLC and Empower Annuity Insurance Company of America, has certified to

NOTE 4 FAIR VALUE MEASUREMENTS

In accordance with FASB ASC 820, *Fair Value Measurements and Disclosures*, the Plan assessed the guidelines for measuring fair value. These guidelines provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. FASB ASC 820 establishes three levels of fair value hierarchy that are described as follows:

The following methods and assumptions were used to estimate fair value of each class of assets that are recognized at fair value.

Registered Investment Companies and Common Collective Trust Funds

These investments are public investment vehicles valued at the daily closing price as reported by the administrator of the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commissions. These funds are required to publish their daily NAV and transact at that price. The NAV is based on the value of the underlying assets owned by the fund, minus the liabilities, and then divided by the number of shares outstanding. The mutual funds held by the Plan are deemed to be actively traded and, therefore, are classified within Level 1 of the valuation hierarchy.

The fair value of participation units in the collective trust funds are valued using net asset NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no future commitments on any of the collective trust funds.

Each IndexSelect strategy seeks to provide long-term investors with an asset allocation strategy designed to maximize assets for retirement consistent with the risk level and projected retirement date associated with each fund. The Funds are designed to

automatically adjust their risk over time in order to reduce the risk of investment in equity securities and shift from a focus on capital appreciation to one of capital preservation, while maintaining some exposure

NOTE 5 GROUP ANNUITY CONTRACT

The Plan has a fully benefit responsive group annuity contract with an insurance company. The insurance company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses.

Since the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. The group annuity contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include but are not limited to the following: (1) premature termination of the contracts by the Plan, (2) merger, or acquisition (3) and partial plan termination. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The insurance company may not terminate the contract at any amount less than the contract value.

Interest earned on the amounts invested in the fixed account is compounded daily at the declared interest rate. At the end of each calendar quarter, Empower will establish and declare the interest rate to be credited to the Plan's assets held in the fixed account during the next calendar quarter. Empower will reset the interest rate quarterly and declare all reset credit interest rates at least 48 hours in advance of each reset. The guaranteed minimum interest rate will be equal to 1.10%.

NOTE 6 INCOME TAX STATUS

The Department of the Treasury has determined by a letter dated November 14, 2022, that the form of the Plan is acceptable under section 401 of the Internal Revenue Code (the Code) for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is subject to income tax examinations for up to three years after tax returns are filed.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PARTIES IN INTEREST

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment.
