### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Spalding Auto, Inc. 401(k) Profit Sharing Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

**Note 1 – Description of the Plan**

The following description of the Spalding Auto, Inc. 401(k) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution and profit sharing which became effective on July 1, 1987 and was most recently restated effective April 1, 2024 to comply with Department of Labor guidelines. The Plan covers all employees of Spalding Auto, Inc. and Pull & Save Auto Parts, Inc. (together referred to as “the Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees may enter the Plan on the first entry date immediately following the completion of three months of service and having attained age 21. Entry dates occur quarterly. Participants (includes union, part-time, temporary and seasonal) with one year of service and having attained age 21 will be eligible for employer matching contribution and a discretionary employer profit sharing contribution.

Contributions

Each year, participants may contribute up to 100% of eligible annual compensation, as defined by the plan document, up to the maximum amount allowed by laws promulgated by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer may make a matching contribution equal to a uniform percentage of qualifying employee salary deferrals. This percentage is determined each year. Matching contributions are subject to a maximum of 40% of the first 8% deferred of eligible compensation. The Employer may make a profit-sharing contribution in addition to any match at its discretion. No profit-sharing contributions were made during the year ended September 30, 2024. Employees with one year of service and 1,000 hours are eligible, and part-time, temporary, and seasonal employees who worked at least 500 hours annually for three consecutive years are eligible for the Employer matching and profit-sharing contributions. The Employer’s contributions are invested as directed by the participant.

Participant Accounts

Each participant’s account is credited with the participant’s deferral contributions and the Employer’s matching contributions, as well as earnings thereon. Participant accounts may be charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are vested immediately in their deferral contributions and employer matching contributions, plus actual earnings on those contributions, or upon death or permanent disability. Vesting in the discretionary employer profit sharing contribution is based on years of continuous service. A participant is 100% vested after six years of credited service. Participants also become fully vested in discretionary employer profit sharing contributions upon death, disability, or upon reaching age 55.

Notes Receivable from Participants

Participants are not permitted to borrow from their fund accounts.

Forfeitures

As of September 30, 2024 and 2023, the forfeiture balance totaled \$645 and \$5,812, respectively. When forfeitures occur, the amounts are used to reduce employer contribution of the Plan. During 2024 and 2023, Employer contributions were reduced by \$6,201 and \$4,370, respectively from forfeiture.

Benefit Payments

Normal retirement under the Plan occurs at age 59 1/2th. Upon retirement or termination of employment, participation in the Plan will cease and benefits will be distributed according to provisions set forth in the Plan document. All vested account balances less than \$5,000 do not require spousal consent and shall be distributed in a lump-sum payment. If no election made by participant, the amount will be automatically rolled over into another qualified plan, at the election of the Employer. Participants with vested account balances exceeding \$5,000 that have retired or terminated employment are not required to take a payout until reaching the age of 73. In-service distributions may be made to current employees of the Employer provided the participant has attained age 59½. Hardship distributions of participants' pretax deferral and employer contribution balances are allowable, if the participant has a qualifying hardship, as defined by the Plan document.

Termination of the Plan

Although it has not expressed intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in all Employer contributions.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are recorded at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and related disclosures. Actual results could differ from those estimates.

Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's compensation. Employer matching contributions are recorded in the same period as the participant's deferral being matched. Profit-sharing contributions are recorded in the period the related compensation was earned.

### Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

### Payment of Benefits

Benefits paid to participants are recorded when paid.

### Administrative Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

Subsequent events have been evaluated through July 8, 2025, which is the date the financial statements were available to be issued.

## **Note 3 – Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures* ("Topic 820"), provides the framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted and observable quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are as follows:

- **Level 1** - Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- **Level 2** - Observable market inputs, other than quoted prices in active markets, that are observable either directly or indirectly, including:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.
- **Level 3** - Unobservable inputs where there is little or no market data, which required the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at September 30, 2024 and 2023.

*Pooled separate accounts* – The fair value of the pooled separate accounts is based on quoted prices, but in a market not considered active. The market price is determined based on the value of the underlying investments, adjusted for amounts such as fund dividends and administrative charges. These investments are measured at fair value on a recurring basis and classified within Level 2 of the fair value hierarchy.

There are no unfunded commitments. There are also generally no restrictions on redemption on the ability to sell the pooled separate account investments, and redemption notice periods are almost immediate.

Certain investments of the Plan are shares of mutual funds managed by Standard Insurance Company, a subsidiary of StanCorp Financial Group. The Standard Insurance Company is the Plan’s record-keeper and custodian. Purchases and sales of shares of these mutual funds qualify as exempt party-in-interest transactions.

**Note 5 – Information Prepared and Certified by the Custodian**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplementary schedule, including investments held at September 30, 2024 and 2023, as well as net appreciation of fair value of investments and interest income for the year ended September 30, 2024, was obtained or derived from information supplied by the plan administrator and certified as complete and accurate by The Standard Insurance Company (the custodian of the Plan).

**Note 6 – Fully Benefit-Responsive Investment Contract**

The Plan invests in a fully benefit-responsive contract with The Standard Insurance Company. This contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The balance of the investment contract was \$288,823 and \$295,861 at September 30, 2024 and 2023, respectively.

The contract held by the Plan is a guaranteed investment contract. With this type of contract, the Plan only owns the contract itself and is designed to accrue interest based on crediting rates established by the contract issuers. The contract issuer is obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by The Standard insurance Company but may not be less than 1%. The crediting rate is reviewed at least annually for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as the premature termination of the contract by the Plan, or the termination of the Plan, would limit the Plan's ability to transact at contract value. The Plan administrator believes that the occurrence of such events is not probable. Both management of the Plan and the contract issuer can terminate the contract with 30 days' advance notice, although the contract issuer can only terminate the contract for reasonable cause. There are no unfunded commitments and no restrictions on redemptions. A surrender charge may apply to transfers or withdrawals from unmaturing guaranteed accounts.

**Note 7 – Tax Status**

The Plan obtained its latest determination letter on March 31, 2014, in which the IRS stated that the Plan is qualified and the related trust is tax exempt under the appropriate sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management analyzed tax positions taken by the Plan, and has concluded that as of September 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
