Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Aurora Flight Sciences Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of the Plan

The following description of the Aurora Flight Sciences Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution 401(k) plan covering all eligible employees of Aurora Flight Sciences Corporation and Aurora Flight Sciences of West Virginia, Inc. (collectively referred to as the Company). Employees who are not part of an excluded class become eligible to participate on the first day of the month following the attainment of age 21 and completing one month of continuous service. Effective January 1, 2025, the Plan's eligibility age requirement is amended to eighteen. The Plan includes an auto-enrollment provision for newly eligible employees unless they affirmatively elect not to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration – Transamerica and State Street Bank and Trust Company (State Street) are the custodians of the Plan.

Contributions – Contributions to the Plan are in the form of salary reductions which participants have elected to defer in lieu of current compensation. Participants may elect to contribute, subject to statutory limitations, up to 100% of their eligible compensation. Participants age 50 or older are allowed to make catch-up contributions. Participants may elect to change contribution percentages to be effective the beginning of the next pay period after the request is received or as soon as administratively possible. The allocation of both their contributions and employer contributions to the funds may be changed at any time and become effective on the day of the change or the next business day based on the day and time the request for a change is made in relation to the stock market close of business. The Plan allows active employees to contribute to the Plan from pre-tax compensation after-tax compensation for Roth deferrals or a combination of both. The Plan also accepts certain rollover contributions.

Under the terms of the Plan, effective January 1, 2022, the Company makes safe harbor matching contributions to the Plan equal to 140% of the first 5% of each eligible participant's eligible compensation. In addition, the Company may make discretionary matching or profit-sharing contributions as determined by the Company's Board of Directors. For the year ended December 31, 2024, no discretionary contributions were made.

Participant accounts – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings (losses) from the funds in which the account is invested and charged with an allocation of certain administrative and investment-related expenses and participant-specific charges, if applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are fully vested in their rollover, elective and safe harbor matching contributions allocated to their account, including accumulated earnings. Discretionary contributions allocated to participant accounts are vested according to the following schedule:

Participants are also fully vested upon the attainment of early retirement age with three years of service, normal retirement age, death or disability.

Forfeitures – Forfeitures are the non-vested portions of a participant’s account that are lost upon termination of employment. Forfeitures occur when a participant receives a distribution of his or her entire vested account or, if the participant does not receive a distribution, after five consecutive one-year breaks in service. Forfeitures are retained in the Plan and may be used to reduce future Company contributions or pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 both plan years. During the year ended December 31, 2024, \$2,817 were used to offset employer contributions.

Withdrawals – Withdrawals of rollover contributions can be made at any time. Participants may elect to withdraw all or a portion of their vested account balance at any time on or after the day they attain age 59-1/2. If a participant is under age 59-1/2, withdrawals from pre-tax elective, Roth elective, employer match and discretionary contribution accounts are subject to certain hardship rules as provided by the Plan. Vested contributions may be fully withdrawn upon termination of employment.

Notes receivable from participants – Participants are permitted to borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their total vested account balance at the time of the loan issuance and may have only one loan outstanding at any time. Loans may be further limited in accordance with Plan provisions. The interest rate on new loans is set every month based on the prime rate plus 2% published by Reuters as of the close of business on the last business day of the calendar month immediately preceding the date of the loan. Interest rates on outstanding loans ranged from 5.25% to 10.50% at December 31, 2024, with loans maturing at various dates through January 2039.

Benefit payments – On termination of service, if the vested value of a participant’s account exceeds \$7,000, the participant may elect to receive either a lump sum amount or a partial withdrawal, to roll the account balance to another company’s qualified plan or an individual retirement account, or defer distribution until a later date. If the vested value of a participant’s account is \$7,000 or less, the entire vested balance in their account will be automatically distributed in a single lump sum payment. Effective January 1, 2025, the Plan is amended to allow installments as an optional form of distribution.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties – The Plan’s investments are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Valuation of investments and income recognition – The Plan’s investments are stated at fair value. The Plan’s custodian, State Street, certifies the fair value of all investments. If available, quoted market prices are used to value investments. Fair value of the financial instrument is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. Investments in the Plan are valued as follows:

Mutual funds – Mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Group annuity contract – Effective August 2022, the Plan entered into a fully benefit-responsive guaranteed investment contract (FBRIC) with Transamerica Life Insurance Company (TLIC). The contract meets the FBRIC criteria, and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan’s ability to receive amounts due is dependent on TLIC’s ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

The Transamerica Guaranteed Investment Option (TGIO) is the Plan investment option available through the Plan’s group annuity contract with TLIC. TLIC maintains the contributions in a general account. The TGIO is valued daily and is the sum of Plan contributions, transfers into the TGIO from other Plan investment options, and daily interest credited to the TGIO, less TGIO expenses, transfers out of the TGIO to other Plan investments, and distributions from the TGIO. The crediting interest rate for the TGIO is based on a formula agreed upon with TLIC. Interest rates are reset on an annual basis. In the event of a reduction in the interest rate, TLIC shall notify the Plan of such reduction at least 45 days prior to the reset date. The interest rate cannot be less than the minimum guaranteed interest rate of zero. As of December 31, 2024, the credit rate outstanding was 3.55%.

Certain events might limit the ability of the Plan to transact at contract value with TLIC. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, or (3) Plan sponsor events (for example, divestitures or spin-offs of a subsidiary, layoffs, retirement incentive programs) that cause a significant withdrawal from the Plan. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow TLIC to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include: (1) rejections of a modification to the contract, (2) TLIC ceases issuing new contracts of this type and intends to terminate substantially all contracts similar in nature, (3) the Plan does not meet a minimum investment threshold as defined in the contract, (4) the Plan is operated in a manner that TLIC determines would disqualify the Plan, or (5) the Company files for bankruptcy, is deemed insolvent, or otherwise ceases operations. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with TLIC and that also would limit the Plan's ability to transact at contract value with participants.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation or depreciation in fair value of investments consists of gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of benefits – Benefits are recorded when paid.

Expenses – Necessary and proper expenses of the Plan are paid from the Plan's assets, except for those expenses the Company is required by law or chooses to pay.

Subsequent events – The Plan has evaluated subsequent events through July 1, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements (ASC 820)*, established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Values are based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 – Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.

Level 3 – Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

The methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Tax Status

The Plan is based on a non-standardized pre-approved defined contribution plan that received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan's tax-exempt status has not been affected, and no provision for income taxes has been included in the Plan's financial statements.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 7 – Party-in-Interest Transactions

The Plan invests in a Transamerica Retirement Solutions collective trust fund, which is affiliated with Transamerica, the Plan's record keeper. Therefore, these transactions qualify as exempt party-in-interest transactions.
