INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the accompanying financial statements of IBEW Local 1357 Insurance Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of September 30, 2024 and 2023, the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of IBEW Local 1357 Insurance Trust (Plan) provides only general information. Participants should refer to the Plan documents for more complete information.

General

The Plan was established on October 5, 1976, under an agreement between Hawaiian Telcom, Inc. and the International Brotherhood of Electrical Workers, Local 1357 (Union). The purpose of the Plan is to provide insurance benefits to all eligible participants and their dependents. All Union members working in Hawaii and in good standing can voluntarily participate in the Union's Group Life Insurance plan with Pacific Guardian Life, which provides life insurance, accidental death and dismemberment benefits. In January 2007, the Plan established a Long-Term Care Insurance program with UNUM Life Insurance Company of America, which is available to all members enrolled in the group life insurance program. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a Board of Trustees comprised of twelve members: the President, Vice President, Treasurer, Recording Secretary, seven Executive Board members, and the Business Manager-Financial Secretary of the Union. The Board of Trustees has overall responsibility for the operation and administration of the Plan. The Board of Trustees determines the appropriateness of the Plan's investments and monitors investment performance.

Benefits

Members who voluntarily participate in the Group Life Insurance plan with Pacific Guardian Life are charged different premiums based on their age. Working members, who are under the age of 60, will pay a monthly premium of \$4.01 to the Plan and receive life insurance coverage of \$20,000. Working members or retirees, who are 60 years old and over, are covered by the Plan who pays their premium of \$3.88 and receive life insurance coverage of \$1,000.

In January 2007, the Plan established a Long-Term Care Insurance program with UNUM Life Insurance Company of America to attract more members to enroll in the Pacific Guardian Life Group Life Insurance Plan. Coverage for basic long-term care varies depending on age and is paid for by the Plan. Additional coverage for members and their spouses is available to participants at their own expense. In October 2010, the Plan elected to allow members to enroll in the Long-Term Care Insurance program after they have been a participant in the Pacific Guardian Life Plan for at least 90 days.

Experience-rated Contracts

Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid, and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Premiums paid by the Plan are recorded as premium payments.

Experience-rated Contracts

For experience-rated contracts, premium surpluses are recorded as a receivable from the insurance company and reflected as a separate income item in the Statements of Changes in Net Assets Available for Benefits. Surpluses are transferred to the Voluntary Stabilization Reserve at the beginning of the subsequent year. Premium deficits are carried forward and offset against the following years' experience.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment consultant, managers and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Voluntary Stabilization Reserve

The Retention Agreement established a Voluntary Stabilization Reserve to alleviate the fluctuations in claims experience. Experience gains are accumulated in the account. Funds are available for withdrawal by the Plan or can be retained in the account. For the Plan years ended September 30, 2024 and 2023, withdrawals amounted to \$15,545 and \$16,995, respectively.

The Voluntary Stabilization Reserve earns interest at a rate determined by the insurance company. For the plan years ended September 30, 2024 and 2023, the interest rate was 1.50%. Amounts in the voluntary stabilization reserve account are not federally insured.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (Continued)

Benefit Obligations

Benefits under this Plan are intended to continue indefinitely; however, benefits under this Plan are not guaranteed. The Board of Trustees reserves the right, in its sole and absolute discretion, to amend or modify benefits as they deem necessary or desirable, from time to time, or to terminate the Plan at any time, if necessary.

Administrative Expenses

The Plan's expenses are paid either by the Plan or by the Union, as provided in the Plan document. Expenses that are paid directly by the Union are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statements of Changes in Net Assets Available for Benefits.

Subsequent Events

Subsequent events have been evaluated through April 30, 2025, which is the date the financial statements were available to be issued.

In October 2024, Hawaiian Telcom Inc. (Hawaiian Telcom), the Union's primary signatory employer, offered certain bargaining positions a Voluntary Separation Program (VSP), which allowed separating employees a severance benefit consisting of a lump sum payment, less withholdings, calculated based on up to five weeks of current base pay for each year of service completed since the most recent hire date, up to a maximum of 104 weeks of pay. The VSP and related benefit was applied for and accepted by approximately 20% of the Union's existing members which is likely to impact overall participation in the Plan.

NOTE 3 – PLAN TERMINATION

Although they have not expressed any intention to do so, the Board of Trustees have the right under the Plan to modify the benefits provided to, and contributions required of, participants at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of participants and/or to pay administrative expenses of the Plan. No assets of the Plan may revert to the Employer or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

PGL – Voluntary Reserve: Valued at cost which approximates fair value.

NOTE 5 – TAX STATUS

The trust established under the Plan to hold the Plan’s assets was exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code (IRC). This exemption was revoked on October 17, 2011, due to failure to file the IRS Form 990. The Plan refiled for tax exemption under Section 501(c)(9) and received a new tax determination letter dated February 9, 2014, which reinstated the Plan’s exempt status retroactive to February 15, 2011. However, as a result of the Plan’s funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business income taxes.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain its tax-exempt status. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has concluded that there are no uncertain tax positions taken that would require recognition of a tax liability (or asset) or disclosure in the financial statements as of September 30, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RELATED PARTY TRANSACTIONS

Certain Trustees of the Plan are also on the Executive Board of the Union.

The Union provides administrative services for the Plan, which is equal to one hour at the staff assistant rate of pay. For the plan years ended September 30, 2024 and 2023, administrative fees paid to the Union were \$403 and \$398, respectively, which is reflected in the Statements of Changes in Net Assets Available for Benefits. The Union may pay for Plan expenses from time to time, however, only expenses paid by the Plan are reflected in the financial statements.

As described in Note 2, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

NOTE 7 – CONCENTRATION OF CREDIT RISK

The Plan maintains its cash and cash equivalents in a checking account and a Voluntary Stabilization Reserve account. The funds in the Voluntary Stabilization Reserve account may not be federally insured, may exceed federally insured limits, or may be insured by an entity other than an agency of the federal government. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risk related to cash and cash equivalents.
