Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of UNDC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(c) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of UNDC 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of UNDC 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about UNDC 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1: DESCRIPTION OF PLAN

The following description of the UNDC 401(k) Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 1995 to provide benefits for employees of Universal Network Development Corporation (the "Plan Sponsor") and the employees' beneficiaries. The Plan is a defined contribution plan covering employees of the Plan Sponsor who have completed 45 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An officer of the Plan Sponsor serves as the trustee to the Plan and Ameritas Life Insurance Corp. is the custodian of the Plan assets as of December 31, 2024 and 2023.

The plan was amended and restated effective August 20, 2013 and a new volume submitter plan was adopted.

Eligibility

All employees of the Employer are eligible to make salary deferrals after completion of 45 days of service. Participants are eligible for any employer matching or profit sharing contributions following the completion of 45 days of service or 1,000 hours during the plan year and they must be employed on the last day of the Plan year.

Contributions

The Plan allows for the following types of contributions:

Employee Salary Deferral 401(k) Contributions - The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code ("Code"). Employees may voluntarily contribute amounts from their regular wages subject to various nondiscrimination tests and limitations prescribed by the Code.

Employer Discretionary Matching Contributions - The Plan Sponsor may, at its discretion, contribute an amount to the Plan based upon each contributing participant's elective deferrals, up to a discretionary amount determined by the Plan Sponsor from year to year. Participants must be employed on the last day of the Plan year with at least 1,000 hours of service in the Plan year. The Plan Sponsor did not make a discretionary matching contribution for the 2024 plan year.

Employer Safe Harbor Matching Contributions - Effective January 1, 2019 the Company contributes a safe-harbor matching contribution each year. For the year ended December 31, 2024 the safe-harbor match was equal to 100% of an eligible participant's salary deferral that does not exceed 3% of the participant's eligible salary plus 50% of participant's salary deferral between 3% and 5% of participant eligible salary. The safe harbor matching contribution is 100% vested.

Employer Discretionary Profit Sharing Contributions - The Plan Sponsor may, at its discretion, contribute an amount to the Plan based on profits and other business considerations. Profit sharing contributions are allocated to eligible participants based on eligible compensation or a uniform dollar amount. Participants must be employed on the last day of the Plan year with at least 1,000 hours of service in the Plan year. The Plan Sponsor did not make a profit sharing contribution for the 2024 plan year.

Employee Rollover Contributions from Another Qualified Plan - Participants may make rollover contributions from another qualified plan.

Qualified Non-Elective Contributions (QNEC) - The Plan Sponsor shall have the right to make a discretionary QNEC contribution to eligible participants that are non-highly compensated employees.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Participants Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contributions and (b) plan earnings, and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement

Normal retirement under the Plan is the date on which the participant attains age 65.

Vesting

Employees are 100% vested in their elective salary deferral contributions, rollover contributions, and safe harbor matching contributions. Discretionary employer matching and other employer contributions vest over a five-year period as follows:

1	20%
2	40%
3	60%
4	80%
5	100%

A year of credited service is equivalent of 1,000 hours worked in a plan year. A participant is also fully vested upon reaching normal retirement age, upon death, or upon becoming disabled.

Payment of Benefits

Payment of retirement benefits may be made at the following times under the Plan: 1) normal retirement; 2) termination of employment; 3) death or disability of the participant; or, 4) upon demonstration of financial hardship. Payment of benefits under the Plan may be received in a lump-sum or substantially equal installments. As of December 31, 2024 and 2023, there were no participants who had requested a distribution and had not been paid.

Forfeitures

Forfeitures may be used to reduce any discretionary employer contributions or to pay administrative expenses. Forfeitures in the amount of \$8 and \$16,123 were available for the reduction of employer contributions or payment of administrative expenses at December 31, 2024 and 2023, respectively. Forfeitures of \$19,243 were used in 2024 to pay employer contributions.

Notes Receivable From Participants

The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of the participant's vested account balance, with a minimum loan amount of \$1,000. Borrowings bear interest and are due no later than five (5) years. Loans taken for the purpose of acquiring a principal residence are repaid within thirty (30) years. Loans are secured by the balance in the participants' account.

Administrative Expenses

Administrative expenses are paid by the Plan and Plan Sponsor at the discretion of the Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are maintained on the accrual basis of accounting.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged to the respective participant's account. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments, other than fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. See Note 5 for information on fair value measurements and a description of the methods and significant assumptions used to determine the fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on ex-dividend dates. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through July 7, 2025, the date on which the financial statements were available to be issued.

NOTE 2: SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Accounting Standards Issued but not yet Adopted

In 2022, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) 2022-03, Fair Value Measurement (Topic 820): *Fair Value Measurement of Equity Securities Subject to Contractual Sale Restrictions*.

The amendments in this ASU clarify that a contractual restriction on the sale of an equity security is not considered part of the unit of account of the equity security and, therefore, is not considered in measuring fair value. The amendments also clarify that an entity cannot, as a separate unit of account, recognize and measure a contractual sale restriction. The amendments in this ASU also require the following disclosures for equity securities subject to contractual sale restrictions: 1) The fair value of equity securities subject to contractual sale restrictions reflected in the balance sheet; 2) The nature and remaining duration of the restriction(s); and 3) The circumstances that could cause a lapse in the restriction(s).

The new requirements are effective for the Plan's December 31, 2025 year end. Management has not yet determined the impact of this accounting standard on the Plan's financial statements.

NOTE 3: UNAUDITED INFORMATION - CERTIFIED INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Substantially all information pertaining to the Plan's investments and notes receivable from participants included in the December 31, 2024 and 2023 financial statements, including the associated investment income and interest income from notes receivable from participants, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Ameritas Life Insurance Corp., the custodian of the Plan. This information has not been audited by independent accountants.

NOTE 4: INVESTMENT CONTRACT WITH AMERITAS LIFE INSURANCE CORP

The Plan has an investment in a Stable Value Fixed Account with Ameritas Life Insurance Corp. The contract value of funds held in the Ameritas Stable Value Fixed Account generally represents principal plus accrued interest. The Ameritas Stable Value Fixed Account earns a declared interest rate each month. Interest rate guarantees of the Ameritas Stable Value Fixed Account are backed by assets held by the Ameritas general account. Credited rates are set based on yields earned on new purchases of fixed income securities for the general account for new deposits. Subsequent renewal rates are based on the investment performance of the general account at the time of renewal. Credited rates are guaranteed for the duration of the guaranteed period, and do not vary with the subsequent performance of assets of the general account which back these guarantees. The value of the investment as of December 31, 2024 and 2023 is presented below:

Certain events may limit the ability of the plan sponsor and/or plan participants to transact at contract value with Ameritas. Examples of these events would include (but would not be limited to) premature termination of this contract and termination of the retirement plan. In these examples, the contract value could be reduced by any applicable surrender charges upon distribution of contract's funds. Under no event may Ameritas terminate this contract and settle at an amount different from contract value.

NOTE 5: FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification 820, Fair Value Measurements and Disclosures, established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts (PSA): Valued at the net asset value of each PSA at the reporting date. The PSA net asset value is not a publicly-quoted price in an active market. The net asset value is based on market values of the PSA's underlying investments.

The methods described in the previous paragraphs may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7: TAX STATUS

Income Taxes

The Plan has obtained a favorable opinion letter dated May 11, 2009, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities; however there are currently no examinations for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8: TRANSACTIONS WITH PARTIES-IN-INTEREST

At December 31, 2024 and 2023, certain Plan investments are units of pooled separate accounts and a guaranteed interest account managed by Ameritas Life Insurance Corp. Ameritas Life Insurance Corp. is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are recorded in net appreciation in fair value of investments. Fees for certain administrative expenses are paid to Ameritas Life Insurance Corp. the record keeper and third party administrator of the Plan. Notes receivable from participants are considered party-in-interest transactions. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 9: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
