## 1. Description of Plan

Settlement Health & Medical Services, Inc. (the "Employer") adopted the Safe Harbor 401(k) Profit-Sharing Plan for Employees of Settlement Health & Medical Services, Inc. (the "Plan") on January 1, 2015. The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### ***General and Eligibility***

The Plan is a safe-harbor 401(k) profit sharing plan covering all eligible employees of the Employer as defined by the Plan document and excludes per diem employees and non-resident aliens. Employees are eligible to participate in the Plan on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

### ***Contributions***

Participants may elect to have a percentage deducted on a pre-tax basis from their compensation, as defined by the Plan document. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Employer. There is an annual dollar limit as to the amount that can be contributed on a pre-tax basis into the Plan which is determined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the Plan year end are eligible to make catch-up contributions up to the statutorily permitted amounts. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 1% of eligible compensation on a pre-tax basis. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution retirement plans.

The Employer shall make safe harbor contributions to the Plan on behalf of each participant for each Plan year equal to 3% of the eligible compensation that the participant receives during the Plan year.

### ***Participant Accounts***

Each participant's account is credited with participant's contributions, Employer contributions and the investment earnings thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The contributions are allocated among investment options according to the participant's instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the amount accumulated in the participant's vested account.

### ***Vesting***

A participant is fully vested in his or her own contributions, Employer contributions and earnings thereon at all times.

**1. Description of Plan (*continued*)**

***Notes Receivable from Participants***

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract.

A participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of his/her vested balance or \$50,000 (whichever is less). A borrower is limited to having a maximum of two outstanding loans under the Plan at one time. Loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest is generally paid ratably through payroll deductions in equal payments over the term of the loan which ranges from one to five years, or longer for the purchase of a primary residence.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, the loan will be deemed in default. Defaults in loans are treated as a distribution at the time of default against the participant's account.

The interest rates for all outstanding loans at December 31, 2024 and 2023 ranged from 4.25% to 9.50%.

***Payment of Benefits***

Participants are eligible to receive distributions of their account without penalty upon reaching age 59 ½. The Plan also permits early retirement upon attaining age 55. Upon termination of service due to death, disability, retirement or other reasons, a participant is entitled to receive a distribution in the amount equal to the total value of the participant's account. Hardship withdrawals are allowed under the Plan and are generally defined as an immediate and heavy financial need for which funds are not reasonably available from other resources.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accounts of the Plan are maintained and the accompanying financial statements have been prepared on the modified cash basis; contributions and investment income are recognized when received and disbursements are recognized when made, except for investments and their related gains or losses, which are reflected at fair value. The Plan has determined that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Basis of Accounting and Use of Estimates (continued)***

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, which consist of separate accounts were valued using level 2 inputs.

***Investment Valuation and Income Recognition***

All investments of the Plan are stated at fair value, except for the insurance company general account, which is stated at contract value. Investments in separate accounts are reported at fair value as reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The Insurance Company General Account is stated at contract value which represents contributions plus earnings, less participant withdrawals and administrative expenses. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Participant loans are valued at outstanding principal amounts. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Administrative expenses may be paid from the assets of the Plan. The Employer, in its discretion, may decide to pay for any or all of these expenses. Investment related expenses are included in net appreciation in value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 2, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (“MOA”), a qualified institution.

**4. Insurance Company General Account**

Amounts placed in the MOA Interest Accumulation Account are credited with interest at a rate determined by MOA. MOA guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of their general account at a rate of at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (“NAIC”) standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula and cannot be less than 0.15% or more than 3.00% in any event. MOA determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year. The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year.

In MOA’s sole discretion, they may credit a higher rate of interest to a participant’s contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. MOA compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

**4. Insurance Company General Account (*continued*)**

The principal and previously credited interest is guaranteed by MOA. This guarantee is subject to MOA's financial strength and claims-paying ability. The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best (A- as of April 2025), Standard and Poor's (A as of December 2022), and Fitch (BBB+ as of April 2025).

Certain events limit the ability of the Plan to transact at contract value. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) the Plan breaches a provision of the contract; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the Plan or trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Mutual of America Interest Accumulation Account is fully benefit-responsive and represents approximately 11% and 12% of the net assets available for benefits as of December 31, 2024 and 2023.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**6. Tax Status**

The prototype plan document preparer has received a favorable opinion letter dated November 30, 2020, from the IRS regarding the Plan's compliance with the applicable requirements of Section 401(a) of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, management believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code, therefore, they believe the Plan is qualified.

The Plan recognizes the effect of income tax positions only if those positions are more likely than not to be sustained. Management has determined that the Plan had no uncertain tax positions that would require financial statement recognition or disclosure. The Plan is subject to examination by the applicable taxing jurisdictions for periods since 2021.

**7. Party-in-Interest Transactions**

Certain Plan investments are managed by MOA. MOA is the custodian as defined by the Plan and, therefore, these transactions are considered as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA and are reflected in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
