### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Gasparilla Inn, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) Audit]. The financial statements comprise the statement of net assets available for benefits as of September 30, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended September 30, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to the audit of Gasparilla Inn, Inc. 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE A - DESCRIPTION OF PLAN**

The following description of the Gasparilla Inn, Inc. (the "Company") 401(K) Plan (the "Plan") established October 1, 2007, provides only general information. Users of the financial statements and supplementary schedule should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who have one year of service and are aged twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of annual compensation, limited by regulations of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company may make a discretionary matching contribution. For the years ended September 30, 2024 and 2023 the Company made safe-harbor matching contributions equal to 100% of a participant's elective deferrals that do not exceed 5% on the participant's annual compensation. The Company may also make a discretionary profit-sharing contribution to the Plan. For the years ended September 30, 2024 and 2023 the Company has elected not to make this discretionary contribution.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution (if any). The Company contributions and participant forfeitures are allocated based on a pro rata basis of all participants in the proportion that a participant's compensation bears to the total of all participants' compensation.

Vesting

Participants are immediately vested in their contributions and the employer's safe harbor match contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after three years of credited service or is employed on or after reaching normal retirement age. A participant also becomes fully vested immediately upon death or total and permanent disability.

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms shall not exceed 5 years or a reasonable period of time for the purchase of a primary residence.

Participant Notes Receivable (continued)

The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest payments are credited to the participant's account. The maximum number of Plan loans that a participant may have outstanding at any one time is two.

Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. If a participant's vested account balance does not exceed \$5,000, the form of payment is a lump sum distribution. If a participant's vested account balance exceeds \$5,000, the form of payment is either a lump sum distribution or installments over a period of not more than the participant's estimated life expectancy.

Forfeited Accounts

Forfeited non-vested accounts totaled \$128 and \$128 as of September 30, 2024 and 2023. These accounts will be used to reduce future employer contributions.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. The difference between cost and market value from one period to the next is recognized as net appreciation (depreciation) in fair value of investments in the accompanying statements of changes in net assets available for plan benefits.

**NOTE B – SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis of accounting. Related fees are recorded as administrative expenses and expensed when incurred. No allowance for credit losses has been recorded as of September 30, 2024 or 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

Risk and Uncertainties

The Plan provides the various investment options in any combination of investment securities as selected by each participant. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

**NOTE C – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

*Mutual Funds* - Valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary schedule.

**NOTE E – TAX STATUS**

The trust established under the Plan to hold the Plan’s assets is qualified pursuant to the appropriate section of the Internal Revenue Code (IRC), and, accordingly, the trust’s net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter dated March 31, 2008 from the Internal Revenue Service.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE F - PLAN TERMINATION**

The Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Although the Company has not expressed any intention to terminate the Plan, if it were to do so, all participant accounts would become fully vested.

**NOTE G – EXCESS CONTRIBUTIONS**

There were no excess contributions for the plan year ending September 30, 2024 and 2023 as the Plan was amended to include a provision for a safe-harbor matching contribution.
