The financial statements comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE 1. DESCRIPTION OF PLAN

The following description of the SRF Consulting Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan. SRF Consulting Group, Inc. (the Company) is the administrator and sponsor of the Plan. The Plan was established on May 12, 1969 and uses State Street Bank and Trust Company as the plan trustee and custodian. The Plan was most recently restated June 1, 2021. The Plan has an agreement with Transamerica Retirement Solutions Corporation for the recordkeeping services. The Company has established a plan committee to oversee the Plan's administration. The committee is responsible for determining the investment options available to participants, for determining appropriate education for participants and for determining plan design changes. The participants are responsible for the direction of their account balances into specific investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility:

Employees of the Company who are not covered by collective bargaining agreements under which they have specifically negotiated coverage by the Plan, who are not resident aliens, who are not a leased employee, who are not a part-time, temporary or seasonal employee that has not worked for 1,000 hours and who have attained the age of twenty-one years or older are eligible to participate in the Plan and receive discretionary matching contributions. Employees who have obtained the age of twenty-one years or older and have completed a year of service are eligible for non-elective employer contributions. Plan entry dates for participation and receiving discretionary matching contributions are the earlier of the first day of the plan year or, the first day of the fourth, seventh or tenth month of the plan year following the date in which the employee meets the eligibility requirements. For the discretionary non-elective employer contributions, the plan entry dates are the first day of the month following the date eligibility requirements are met.

Contributions:

Each year, participants may contribute, through salary reduction and post-tax Roth contributions, up to 100% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan.

NOTES TO FINANCIAL STATEMENTS

NOTE 1. (CONTINUED)

Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Plan will increase the deferrals of automatically enrolled participants by 1% annually with a maximum of 10%. The Plan also allows for the participant to amend his or her deferral election of any bonus received by the participant. The Company may make discretionary matching and non-elective contributions. The Company set the match at 50% of the aggregate salary reduction contribution to the extent that the aggregate contribution does not exceed 5% of compensation for the years ended September 30, 2024 and 2023, respectively. The total discretionary matching contributions for the years ended September 30, 2024 and 2023 totaled \$1,017,210 and \$925,892, respectively. No discretionary profit sharing contributions were made for years ended September 30, 2024 and 2023. Contributions are subject to certain IRS limitations.

Participant accounts:

Each participant's account is credited with participant deferrals, post-tax Roth contributions, any other discretionary contributions made by the Company and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are valued at the end of each business day. The benefit the participant is entitled to is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited service.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balances or \$50,000. Any given participant can have a maximum of two loans outstanding at any given time. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are determined by the prime rate of interest plus 1%. Loans must be repaid within five years, except a loan used to build, purchase, or substantially remodel a principal home may be repaid over a ten-year period. Principal and interest are paid through bi-weekly payrolls.

NOTE 1. (CONTINUED)

Payment of benefits:

Distributions to terminated or retired participants are made in a single lump-sum payment to the participant (or in the case of death, the participant's beneficiary) or periodic installments over a period specified by the plan). If terminated/retired participants do not voluntarily elect to move their funds out of the plan, vested account balances greater than \$1,000 and less than \$5,000 are rolled into an IRA account set up in the participant's name. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator can authorize the benefit payment without the Participant's consent.

Active (not terminated/retired) participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan and withdrawals are limited pursuant to the Plan's provisions.

Forfeitures:

For the years ending September 30, 2024 and 2023, forfeited accounts of \$62,464 and \$0, respectively, were used to pay the employer matching contribution and pay administrative fees. Forfeited balances of terminated participant's non-vested Company contributions are first used to restore participants' accounts, then used to reduce the employer's matching contribution and finally pay Plan administrative expenses. Remaining unused forfeitures as of September 30, 2024 and 2023 were \$2,437 and \$39,116, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan are maintained on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2. (CONTINUED)

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principle balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are charged directly to the borrowing participant's and are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Certain Plan administrative expenses are charged directly to the participant accounts while other investment advisory related expenses are included in the net appreciation of fair value of investments.

Subsequent events:

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through July 8, 2025, the date the financial statements were available to be issued. Effective November 11, 2024, Plan management administratively adopted the provision to allow for Super Catch-up contributions for individuals ages 60-63 under the SECURE Act 2.0. Plan management has until December 31, 2026 to formally amend the Plan. Effective March 1, 2025, the Plan was amended to allow the use of forfeitures to reduce future employer matching and nonelective contributions.

NOTE 3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. State Street Bank and Trust Company, the trustee (custodian) of the Plan, have certified as to the completeness and accuracy of all investment and notes receivable information reflected in the accompanying statements of net assets available for benefits as of September 30, 2024 and 2023, the statements of changes in net assets available for benefits for the years ending September 30, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of September 30, 2024.

NOTE 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets and liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4. (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 30, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Mutual Funds held by the Plan are deemed to be actively traded.

Common Collective Trust: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee is a readily determinable fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the Common Collective Trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by State Street Bank and Trust Company. State Street Bank and Trust Company is the trustee and custodian and Transamerica Retirement Solutions Corporation is the recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. PLAN TAX STATUS

The Plan is placing reliance on an advisory opinion letter dated June 30, 2020, received from the Internal Revenue Service (IRS) on the Non-Standardized Pre-Approved Profit Sharing Plan with CODA indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore not subject to tax under the current income tax law. The prototype Plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10. SECURE ACT 2.0

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. Management has evaluated those provisions and elected to administratively adopt certain option provisions (see Note 2).
