Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Rukel Management, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered Rukel Management, LLC 401(k) Profit Sharing Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing our opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by American Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that have not been identified. However, as we discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in Rukel Management, LLC 401(k) Profit Sharing Plan's internal control to be significant deficiencies:

As part of the audit, management requested us to prepare a draft of the financial statements, including the related footnote disclosures. Management reviewed, approved, and accepted responsibility for those financial statements prior to final issuance. Management also is responsible for designating an individual with adequate knowledge and experience to evaluate the results of our services performed, including preparation of financial statements with footnote disclosures. Management did not designate an individual that can prepare and evaluate the completeness of all footnote disclosures. A significant deficiency exists because the Plan lacks the internal control procedure of designating an individual to prevent or detect and correct misstatements on a timely basis.

In regards to the preceding significant deficiency comment regarding footnote disclosure, which is often a topic of conversation with company owners, it is a required comment when applicable. The comment is applicable when the entity under audit does not have an individual within their organization that can complete the entity's footnote disclosures. The individual must be capable of determining that all required disclosures are present and complete. The comment does not mean that the entity lacks an individual that can read and confirm the accuracy of the footnote disclosures presented, but that they could not without the assistance of the auditor, ensure that all required disclosures are presented as required by professional standards. If the entity is unable to hire such an individual due to size and budget constraints or it is not practical, then the comment will simply appear each year for information's sake and does not result in an unfavorable opinion under current standards. As the comment is often questioned, peer reviewers and peer groups of CPA firms, as well as other noted experts, have confirmed the above is the case presently. This comment is issued with the majority of smaller and midsized entities and does not cause auditors any concerns in regards to the engagement taken as a whole or require expanded procedures in any way.

This communication is intended solely for the information and use of management, the Board of Trustees, and others within the Plan, and is not intended to be, and should not be, used by anyone other than these specified parties.

### Basis for Opinion

### **NOTES TO FINANCIAL STATEMENTS**

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of the Rukel Management, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### GENERAL

The Plan is a defined contribution plan covering all eligible employees of Rukel Management, LLC, AJR Filtration, Inc., AJR Enterprises, LLC, AJR Specialty Products, LLC, AJR Custom Foam Products, LLC, Midwest Filter, LLC and Delta Pure Filtration, LLC (collectively, the "Company"). Effective July 1, 2024, AJR Enterprises, LLC, ceased participation in the Plan. Effective April 25, 2025, AJR Specialty Products, LLC and AJR Custom Foam Products, LLC ceased participation in the Plan.

#### CONTRIBUTIONS

Participants may elect to contribute pre-tax earnings and Roth contributions up to current Internal Revenue Service ("IRS") regulations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All employees, except members of a collective bargaining unit or non-resident aliens, are eligible to enter the Plan after having attained age 21. Eligible employees can enter the Plan on the first day of the month coincident with or next following satisfaction of the eligibility requirement. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Company must also contribute a safe harbor matching contribution to the Plan. This amount is allocated to participants who have attained age 21 and are contributing elective deferrals into the Plan. The safe harbor contribution is calculated as a 100% match on the first 3% of salary deferrals and 50% match on the next 2% of salary deferrals. The Company may also contribute a discretionary profit-sharing contribution and/or match. This amount is allocated to the participants' accounts who have completed 1,000 hours of service during the Plan year and are employed on the last day of the Plan year, unless terminated due to death, disability, or retirement. The Company did not elect to make a discretionary profit-sharing contribution or match for the year ended December 31, 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

#### PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's elective contribution and allocations of: a) the Company's safe harbor matching contribution, b) the Company's discretionary profit sharing contribution and/or match (if applicable), c) investment earnings, and d) administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### VESTING

Participants are vested immediately in their deferral contributions and safe harbor employer matching contributions plus actual earnings thereon. Vesting in the Company's profit sharing and discretionary matching contribution portion of their account is based on years of service.

Upon termination of employment by reason of death, disability, or retirement, the balance in the participant's account will become fully vested.

VESTING (Continued)

Upon termination of employment for reasons other than by death, disability, or retirement, participants will receive the amount of their participant account valued at its fair market value and shall vest according to the following schedule based upon years of service:

3 or more	100%

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their account a minimum loan of \$1,000 and up to a maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. The participants may have one loan outstanding at any time.

PAYMENT OF BENEFITS

On termination of service due to death, disability, or retirement a participant or his beneficiary may elect to receive a single lump-sum payment equal to the value of the participant's vested interest. For termination of services for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum payment.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The summary of significant accounting policies is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management, which is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with generally accepted accounting principles.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

##### USE OF ESTIMATES

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Due to the inherent uncertainty involved in making estimates, actual results may differ from those estimates.

##### INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

##### PAYMENT OF BENEFITS

Benefit obligations are recorded when paid.

##### EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

##### SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through July 7, 2025, the date which the financial statements were available to be issued.

#### **NOTE C - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and all assets will be liquidated and paid to participants.

#### **NOTE D - TAX STATUS**

The IRS has determined and informed the Company by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and there, believe that the Plan is qualified, and the related trust in tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Federal or Illinois taxing jurisdictions. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE E – CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American Trust Company, as sub-custodian to, and on behalf of, Trust Company of Illinois (the trustee and custodian of the Plan).

#### **NOTE F - FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.
- Level 2 Inputs to the valuation methodology include
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (NAV) of shares, which are based on quoted market prices, held by the Plan as of the end of the year.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
