Note 1 – Plan Description

The following description of the Corvesta, Inc. New Comparability Cash or Deferred Profit Sharing Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Corvesta, Inc. and its subsidiaries, Revolv, Inc. and Delta Dental of Virginia (the “Company”) age twenty-one or older. The Plan allows prior service for employees of Northwinds Technology Solutions to count toward service, entry, and vesting. Employees are eligible for elective deferrals and matching contributions on the first day of the month following their date of hire. For purposes of eligibility for Company discretionary contributions, the service requirement is one year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. The Plan excludes certain employee taxable compensation and payment amounts from Plan compensation for the purpose of calculating contributions. The Plan allows participants to make Roth contributions. The Company may contribute to the Plan at the option of the Company’s Board of Directors. Employees are automatically enrolled at an initial 4% of compensation deferral rate. Annually, all participants contributing less than 8% will automatically escalate by 1% of compensation per year up to a maximum of 8% of compensation, unless a contrary election is made. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. For 2024, the Company made a discretionary matching contribution of 50% of the first 4% of compensation that a participant contributed to the Plan. The Company also made additional discretionary profit-sharing contributions. For 2024, the Company made profit-sharing contributions of approximately \$1,689,000. Participants direct the investment of their contributions, matching, and any additional discretionary contributions, into various investment options offered by the Plan. Contributions are subject to certain limitations.

Effective October 1, 2023, the plan was amended to allow the automatic deferral escalation on Roth contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching and additional contributions, allocations of earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years unless the note is for the purchase of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Trustee. At December 31, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their contributions and employer matching contributions plus earnings thereon. Vesting in discretionary employer contributions plus actual earnings thereon is based on years of service. A participant is 100% vested after six years of credited service.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$127,118 and \$33,717, respectively. Forfeitures can be utilized to reduce employer contributions or reallocated to participant accounts as defined in the Plan document. During 2024, forfeitures of \$33,752 were used to reduce the employer contributions.

Administrative Costs

Administrative expenses incurred by the Plan may be paid by either the Plan or the Company as provided by the Plan document. During 2024, a portion of these fees were paid by the Plan.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes from Participants

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Payment of Benefits

Benefit payments are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through June 26, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The Galliard Stable Return Fund PN is a collective investment trust fund owned at December 31, 2024 and 2023. This investment is composed primarily of investment contracts and security backed contracts and is valued at the net asset value (NAV) of units of the Galliard Stable Return Fund PN. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There is a twelve month notice period if the Plan initiates a full redemption of the collective investment trust.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted NAV of the shares held by the Plan at year end. The self-directed brokerage account consists of cash, interest bearing cash equivalents, common stock and U.S. Treasury bills and notes, which are valued at the closing price reported on the active market on which the individual securities are traded.

Level 2 Fair Value Measurements

The fair values of common collective funds and pooled separate account are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The common collective funds and pooled separate account invest in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the NAV of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Investments Measured Using the NAV per Share Practical Expedient

The following table, which includes the Galliard Stable Return Fund PN summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 4 – Investment Contracts

At December 31, 2024 and 2023, the Plan had investments in the Galliard Stable Return Fund PN. Included in this fund are guaranteed investment contracts and certain wrapper contracts. This contract is considered to be benefit-responsive and is required to be stated at fair value with a corresponding adjustment on the statements of net assets available for benefits to contract value. The average yields for this fund is as follows:

Note 5 – Related Party Transaction

Plan investments are managed by Principal Trust Company (“Principal”). Principal is the Trustee and recordkeeper for the Plan and therefore, these transactions qualify as party in interest transactions.

The Trustees receive revenue from mutual fund and collective trust fund service providers for services the trustees provide to the funds. This revenue is used to offset certain amounts owed to the trustees for its administrative services to the Plan. If the revenue received by the Trustees from such mutual fund or collective trust fund service providers exceeds the amount owed under the Services Agreement, the Trustees remit the excess to the Plan’s trust on a quarterly basis. Such amounts can be applied to pay Plan administrative expenses with any remaining amounts allocated to the accounts of the participants. The Plan can make payments to the Trustee for administrative expenses not covered by revenue sharing. During 2024, expenses paid to Principal for plan administration were \$74,315, of which revenue credits of \$38,391 were used to pay Plan expenses. Administrative expenses are presented net of revenue credits used.

Certain administrative functions are performed by officers or employees of the Company. These employees are also Plan participants. No such officer or employee receives compensation from the Plan.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7 – Tax Status

The Company has adopted a non-standardized pre-approved profit-sharing plan sponsored by Principal Life Insurance Company. The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the pre-approved profit-sharing plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and therefore believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 8 – Trustees' Certification

Certain information was certified as complete and accurate by Principal Trust Company, the Plan's Trustee. This information is as follows:

Note 9 – Transfers

During 2021, the Board approved a resolution for the Company to become a member of Northwinds Technology Solutions, LLC ("Northwinds"). All Corvesta IT employees were transferred to Northwinds and, as a result, these employees' accounts were rolled over to the Northwinds Technology Solutions Retirement Plan. Transfers were made during 2024 and 2023 totaling approximately \$-0- and \$473,000, respectively.
