### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the accompanying financial statements of Employee Stock Ownership Plan of Vita Plus, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of September 30, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Employee Stock Ownership Plan of Vita Plus as of September 30, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 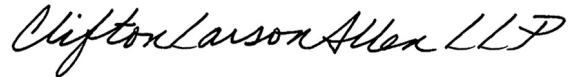

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Employee Stock Ownership Plan of Vita Plus (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

VP Holdings Corporation (the Company and the Sponsor) established a profit-sharing plan and trust effective as of January 1, 1952, to provide retirement and other benefits to eligible employees. The Plan was subsequently amended and restated to operate in part as an employee stock ownership plan (ESOP) and a salary reduction contribution plan. The salary reduction contribution plan was spun off on July 1, 2000, to form the Vita Plus Corporation 401(k) Plan. The Plan is designed to comply with Section 4975(e)7, and the regulations of the Internal Revenue Code (IRC), as amended, and is subject to the applicable provisions of ERISA, as amended.

The trustee is appointed by the Company and is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investments and monitors investment performance.

**Eligibility and Contributions**

Participants of the Plan include all employees of Vita Plus Corporation, Smith Feed Service, Inc., Dodgeville Agri-Services, Inc., Lake Mills Feed and Grain, Inc., Lanark Ag Center, LLC, Agri Business Consultants, LLC, Mix Rite Agri-Service LLC, Cornette Farm Supply, Inc., Loyal Ingredients, LLC, Spensley Feed Sales, LLC and Vita Builders, LLC (the Companies), with the exception of union and leased employees. Participants must have completed at least 500 hours during the Plan year in order to receive an allocation of employer contributions for the year. Company contributions are made to the Plan in such amounts as determined by the Company's Board of Directors, provided that the contributions do not exceed the maximum amounts deductible under Section 404 of the IRC. Contributions are allocated proportionately based upon a participant's eligible compensation to the total of all participants' eligible compensation.

**Vesting**

Vesting in the Company's contribution account plus actual earnings thereon is based on years of credited service. A participant is 100% vested after three years of credited service. In computing the number of credited years of service for vesting purposes, all of a participant's years of service shall be taken into account except for years of service prior to age 18. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Forfeitures**

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures of terminated nonvested account balances allocated to remaining participants at September 30, 2024 and 2023 were \$78,791 and \$32,981, respectively. There were no balances in forfeited nonvested accounts at September 30, 2024 and 2023.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

**Payment of Benefits**

A participant's vested benefit will normally be paid upon death, disability, retirement, or a withdrawal due to a financial hardship. Benefits are paid in cash as a lump-sum or annual installments, but it is the Plan's intent for the foreseeable future that distributions will be paid in a lump-sum.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

**Voting Rights**

The trustee shall vote all Company stock held by the Plan except in certain major corporate matters that requires voting rights to be passed through to ESOP participants. In such cases, each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is required to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

**Put Option**

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**Cash and Cash Equivalent**

The Plan considers all highly liquid debt instruments purchased with maturity of three month or less to be cash and cash Equivalent. The Plan has cash deposit with financial institutions which at times may exceed the federal insured limit. The company has not experienced any losses in such accounts and does not believe it is exposed to any significant credit risk.

**Investment Valuation and Income Recognition**

The shares of Company common stock are valued at estimated fair value and all other investments are valued at fair value. See Note 4 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investment presented in the accompanying statements of changes in net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 30, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Subsequent Events**

The Plan has evaluated subsequent events through July 3, 2025, the date the financial statements were available to be issued.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the valuation methodologies used at September 30, 2024 and 2023.

*Interesting Bearing Cash* – Valued based on cost, which approximates fair value.

*Collective Investment Trust* – Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*VP Holdings Corporation Common Stock* – The fair value of the Company common stock held by the Plan is valued at fair value based on an independent third-party appraisal. This appraisal is based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

*Other Common Stock* – Valued at the quoted prices in active markets.

*Cash surrender value of Life Insurance* – The cash surrender value of life insurance is based upon the surrender or conversion value of the policies, net of policy loans, as reported by the insurance company. Management has determined that these cash surrender or conversion values represent the best available evidence of fair value for investments in life insurance policies.

The Plan believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 PLAN TERMINATION**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Employee Stock Ownership Committee shall direct the trustee to pay all liabilities and expenses of the trust fund and to sell shares of financed stock held in the loan suspense account to the extent it determines such a sale to be necessary in order to repay the loan. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6 TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated August 1, 2017, that the Plan and related Trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan investments consist primarily of the Company's common stock, collective investment trust, common stock and cash surrender value of life insurance, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumption process, it is at least reasonably possible that changes in the value of common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 8 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan's assets, which consist primarily of Company's common stock, collective investment trust, common stock and cash surrender value of life insurance, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received, interest and dividends income and makes distributions to participants. The Plan is administered by VP Holdings and certain administrative functions are outsourced to a third-party administrator. A certain officer of the Company is Plan trustee. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan invests in Company common stock. These are related party and party-in-interest transactions. As the Company is the Plan Sponsor, transactions involving Company common stock qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
