Report of Independent Auditors

To the Administrator of Repsol Services Company 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Repsol Services Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the Financial Statements

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.⁴

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.⁴

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the Repsol Services Company 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General—Repsol Services Company (the “Company”) is a holding company owned by Repsol S.A. The Plan was created effective January 1, 2007 and restated effective January 1, 2022, to encourage employees to regularly save for retirement. The Investment Committee of the Company determines the appropriateness of the investment offerings and is responsible for the oversight of the Plan. The Plan is a defined contribution plan in which salaried and hourly employees, as well as outbound US expatriates paid on home country or host country payroll, are eligible to participate. Leased employees, employees covered under a collective bargaining agreement and nonresident aliens that are under a secondment agreement are not eligible to participate. An employee is eligible to begin participation in the Plan on the first day of the calendar month following the date on which they complete 1 day of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Empower Trust Company, LLC (“Trustee” or “Empower”) serves as trustee of the Plan and custodian of the majority of the investments, while Empower Annuity Insurance Company (“Empower Annuity”) serves as custodian for the remaining investments.

Contributions—Each year, participants may contribute up to Internal Revenue Code (“IRC”) limitations. The Company matching discretionary contribution is dollar for dollar on the participant’s contribution into the Plan up to a maximum 6% of the participant’s base salary. The Company also makes a safe-harbor contribution on the participant’s behalf in an amount of up to 6% of the participant’s base salary. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Contributions are subject to certain IRC limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; these additional contributions are eligible for a Company matching contribution.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and an allocation of (a) the employer’s contributions, (b) Plan earnings, and (c) the indirect costs of brokerage fees, commissions, taxes, and other expenses incident to the income or assets of the Plan or the purchase or sale of securities by the Trustees. Allocations are based on contributions, participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Investments—Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a Guaranteed Income Fund as investment options for participants.

Vesting—Participants are vested immediately in their contributions plus investment earnings thereon. For purposes of eligibility and vesting under this Plan, years of credited service shall include service with any affiliate of the Company. All active accounts of active employees are 100% vested from January 1, 2017 forward.

Notes Receivable From Participants—Any participant having vested account balances is eligible to obtain a loan. The minimum loan amount is \$1,000 and the maximum loan amount is the lesser of \$50,000, or 50% of the vested balances of the participant’s account. Loans are repayable through payroll deductions over a period up to 60 months (loan repayment may extend to 10 years if the loan is for the purpose of a principal residence). As of December 31, 2024, participant loans have maturities through 2034 at interest rates ranging from 3.25% to 8.50% percent.

Payment of Benefits—Participating employees receive a lump-sum distribution equal to their vested account balances upon retirement, total and permanent disability, death or termination of employment. As allowed under the provisions of the Plan and in compliance with regulatory requirements, certain participating employees may withdraw participant contributions and vested employer matching contributions from their accounts. If a participant makes such a withdrawal, six months must elapse before another withdrawal can be made. Hardship withdrawals are also permitted. Effective January 1, 2023, the minimum distribution age was increase to 73 years of age, under the Setting Every Community Up for Retirement Enhancement Act of 2019 (the “SECURE Act”).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan utilizes various investment instruments, primarily mutual funds. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants’ account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan’s investments are stated at fair value (see Note 3), except the Guaranteed Income Fund, which is reported at contract value and the Pooled Separate Accounts which are reported as net asset value (“NAV”). The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by custodians and insurance companies. Mutual Funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Guaranteed Income Fund is presented at contract value. Contract value is contributions plus earnings, less participant withdrawals and administrative expenses. This amount is available for withdrawal by participants.

The Pooled Separate Accounts (“PSA”) are presented at net asset value per share. PSA is valued at its NAV based on the market value of its underlying investments. The amount available for

withdrawal is the contribution plus earnings, less participant withdrawals and administrative expenses. The PSA seeks long-term capital growth and investments are in equities or bonds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants—Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are settled through treatment as benefit payment deductions against the participant's vested account balance based on the terms of the plan document.

Administrative Expenses—Certain administrative expenses of the Plan are paid by the Plan Sponsor as provided in the plan document. This includes recordkeeping fees of 3 basis points of plan assets. Participants pay administrative costs for loans and qualified domestic relations orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits—Benefit payments to participants are recorded when paid.

3. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurement*, provides a framework for measuring fair value, as well as related disclosure requirements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's policy is to recognize significant transfers between levels at year-end. For the year ended December 31, 2024, there were no transfers.

5. GUARANTEED INCOME INTEREST FUND WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive Guaranteed Income Fund (“GIF”) with Empower Retirement. Empower Retirement is the issuer of the group annuity contract that the Plan entered into in order to obtain this investment. Empower Retirement maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIF is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. As of December 31, 2024 and 2023, the balance of the Plan’s GIF investment was \$25,830,837 and \$26,412,971, respectively.

The Plan Sponsor is required to provide Empower Retirement 90 days notice in order to discontinue the contract. The contract value is provided by Empower Retirement at the end of the 90 days.

Limitations on the Ability of the GIF to Transact at Contract Value—The GIF has certain restrictions that affect the ability of the Plan to collect the full contract value, for example, the Plan may not withdraw more than 10% of the beginning of the year balance of the contract without incurring a penalty. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Empower Retirement may not terminate the contract at any amount less than the contract value.

Average Yields—Empower Retirement is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with Empower Retirement, but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate of the contract will track current market yields on a trailing basis.

6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies and a Guaranteed Income Fund managed by Empower Trust Company, LLC, the trustee of the Plan and Empower Annuity Insurance Company. Therefore, these transactions qualify as party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. TAX STATUS

As of December 31, 2018, the Plan uses a prototype document sponsored by Empower Retirement, LLC (“Empower”). Empower received an opinion letter from the Internal Revenue Service (“IRS”), dated September 16, 2022, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan’s management believes that the Plan is currently designed and being operated in

compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

9. SUBSEQUENT EVENTS

Subsequent events were evaluated through July 8, 2025, the date the financial statements were available to be issued and has determined there are no items that require disclosure or adjustment to the financial statements.
