Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Hollis + Miller Architects, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Hollis + Miller Architects, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") for employees of Hollis + Miller Architects, Inc. (the "Company").

Matrix Trust Company ("Matrix") serves as the custodian of the Plan. TPP Retirement Plan Specialists, LLC serves as the Plan's participant recordkeeper. Employees of the Company serve as trustees of the Plan.

Eligibility – An employee is eligible to participate in the Plan after three months of service and upon reaching the age of 21. The employee may enroll in the Plan on the first day of the month following the satisfaction of these requirements. The Plan is not open to union employees or seasonal emerging professionals.

Contributions – Participants may elect to contribute any amount of their annual compensation subject to certain Internal Revenue Code ("IRC") limitations as either a 401(k) deferral, or as a Roth deferral.

The Plan includes an automatic enrollment provision. Eligible participants will have an automatic deferral amount of 6% of eligible compensation, unless the participant opted to have another amount or 0% withheld. The automatic enrollment provision also includes an annual automatic deferral increase, with affected participants increased by 1% to a maximum of 15%.

The Company may make discretionary matching contributions to contributing employees, and discretionary profit-sharing contributions. Participant must complete 1,000 hours of service and be employed on the last day of the Plan year to receive discretionary matching or profit-sharing contributions. For 2024, the Company made discretionary matching contributions of 50% up to 6% of employee deferrals. Profit sharing contributions are allocated to eligible participants in accordance with applicable provisions of the Plan. For 2024, the Company did not make discretionary profit-sharing contributions.

Participant Accounts – Each participant's account is credited with the participant's contribution, the Company's discretionary matching and profit-sharing contributions (if any) and allocations of Plan earnings, and charged with an allocation of Plan losses and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – Participants direct their contributions to various mutual funds and a money market fund.

Vesting – Participants’ contributions are fully vested at all times. The employer discretionary contributions vest in 25% increments, with 0% vested after year one, 25% vested after year two, and increasing in 25% increments. After 5 years of service, Company contributions become fully vested. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures of employer contributions are used to reduce future employer contributions, or to pay administrative expenses. During 2024, forfeitures in the amount of \$22,678 were used to fund the employer contribution receivable as of December 31, 2024, and forfeitures in the amount of \$22,907 were used to pay administrative expenses. There is \$14,188 and \$15,952 in forfeitures as of December 31, 2024 and 2023, respectively.

Payment of Benefits – Upon termination of employment, the participant, or in the case of death, the participant’s beneficiary receives the participant’s account balance in a single lump-sum payment. In the event that a participant terminates employment, and their account balance is less than \$5,000, the balance will automatically be paid out in a single lump sum payment, or be rolled over into an IRA.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years, except if the loan is to acquire the participant’s principal residence, which may have a longer repayment term. Interest rates are established by adding one percentage point to the Prime rate. The balance in the participant’s account secures the loan. A participant may have no more than two loans outstanding at any one time.

In-Service Withdrawals – Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balance in a single lump sum payment prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Document and permitted by the IRC. Hardship withdrawals are limited to the participant’s account balance that is 100% vested.

Administrative Expenses – Administrative expenses may be paid by the Company or the Plan, at the Company’s discretion. The Plan paid expenses of \$28,345 for the year ended December 31, 2024.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants’ accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan’s investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is accrued when earned.

Certain management fees and operating expenses charged to the Plan for investments in the mutual funds and money market funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distribution based upon the terms of the Plan document. No allowance for doubtful account is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Date of Management’s Review – Subsequent events have been evaluated through July 8, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

3. FAIR VALUE OF INVESTMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds and Money Market Fund – Valued at the published net asset value (“NAV”) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Net appreciation on fair value of investments
- Dividend and Interest income
- Schedule of assets (held at end of year), excluding Notes Receivable from Participants

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. EXEMPT PARTIES-IN-INTEREST

Certain Plan investments include a money market account managed by the custodian, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest.

The Plan pays certain fees to Matrix to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.

7. TAX STATUS

The Plan has adopted a Prototype Non-Standardized Profit-Sharing Plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
