**Note 1. Description of the Plan**

***General***

The following description of Crete Carrier Corporation Welfare Benefits Plan (Plan) provides only general information about the Plan's provisions. Participants should refer to the Plan document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan is sponsored by Crete Carrier Corporation and its affiliated company, Hunt Transportation, Inc. (the Company). The Plan provides health, dental, vision, life, employee assistance, short-term disability, flexible spending (health care), hospital indemnity and critical illness and accident benefits for substantially all employees who work at least 30 hours per week and to their covered dependents and beneficiaries. Other than flexible spending benefits, these benefits are also available to certain independent contractors and their beneficiaries and covered dependents. Employees and independent contractors are eligible to enroll immediately upon hire/affiliation. Coverage is effective on the first day of the month following 30 days of service after the date of hire/affiliation for health, dental, vision, life, employee assistance, flexible spending benefits, hospital indemnity and critical illness and accident. Coverage for short-term disability is effective on the first day of the month following one year of service after the date of hire/affiliation. The Plan also provides long-term disability benefits for "salaried exempt non-driver employees" who work at least 30 hours per week with coverage effective on the first day of the month following one year of service after the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

***Benefits***

The Plan provides health, dental, vision, life, employee assistance, short-term and long-term disability, flexible spending, hospital indemnity and critical illness and accidents benefits. The Plan also provides continuation of health, dental, vision, employee assistance, and flexible spending to participants who no longer meet the eligibility criteria due to a reduction in employment hours or termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

***Insured Benefits***

The Plan fully insures life, employee assistance, long-term and short-term disability, hospital indemnity and critical illness and accident benefits. The Plan purchases annual insurance contracts for these insured benefits whereby the Plan pays premiums per participant to obtain coverage under the various policies. Premiums for insured benefits are paid by Company and participant contributions as defined. Employee assistance benefits are available to participants enrolled in group life insurance with Mutual of Omaha.

***Self-Insured Benefits***

The Plan self-insures health, dental, and vision benefits. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's trust or the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

***Stop-Loss Coverage***

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured health benefits of individual participant claims over a specific dollar amount.

***Flex Spending Accounts***

The Plan has flex spending accounts (FSA) that are funded solely through employee contributions. The FSA allows eligible participants to be reimbursed tax free for qualified medical expenses costs subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year for a period of 90 days. The employer is not permitted to refund any part of the balance to the employee. The account cannot be used for anything other than reimbursements for qualified medical expenses and remaining amounts are not portable upon termination once the employee leaves the employer. The Company holds employee contributions until a reimbursement request is made.

***Contributions***

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit election through payroll deductions. Independent contractors who elect to participate contribute all of the calculated premium. The Company makes contributions to the plan to fund premiums, administrative expense and claims in excess of participant contributions for self-funded benefits.

The Company and employees contribute amounts for life, long-term and short-term disability, hospital indemnity and critical illness and accident insurance based on premium rates that are contracted with various insurance companies under fully insured contracts.

Employees contribute to their flex spending account based on rates established yearly by the employee and limited by the Internal Revenue Code.

Any deficiency of the Plan's net assets over benefit obligations is funded by the Company through employer contributions on a pay-as-you-go basis.

***Plan Termination***

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants and their covered dependents. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported (IBNR) claims, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Payment of Benefits***

Premiums paid by either the Company or the Plan Trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Payment of health, dental and vision claims and flex spending benefits are provided by third-parties under administrative service agreements. Claim payments are recorded when paid by the third-party claim's processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as claims payable in the accompanying statements of Plan's benefit obligations. The third-party claims processor processes health, dental, vision, and flexible spending benefits for participants, dependents and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan.

***Stop-Loss***

Premiums for stop-loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling \$128,392 and \$1,614,541 have been netted with health care claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

***Refunds***

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date, if any, have been reported as a receivable, with the offset being netted against health care claims paid. Pharmacy rebates totaling approximately \$4,200,000 and \$2,200,000 have been netted with health care claims paid directly to participants in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

***Flex Spending Accounts***

The Company holds amounts totaling \$99,648 and \$158,788 deposited by participating employees that are available to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023, respectively.

***Valuation of Investments and Income Recognition***

The Plan's investments in a short-term federal investment trust account and interest-bearing cash with a bank are stated at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, if any.

***Administrative Expenses***

Substantially all costs of the plan administration, including miscellaneous, general and administrative expenses, are paid by the Plan. The Company provides certain administrative services at no cost to the Plan.

**Note 3. Benefit Obligations**

The Plan's benefit obligations include the Plan's liability for claims payable, claims reported, but not yet processed and claims incurred but not reported for health care, dental and vision benefits and premiums currently due to insurers for disability, life insurance, hospital indemnity and critical illness and accident coverage. The Plan's liabilities for claims incurred but not reported are estimated by the third-party administrators utilizing prior claims experience, past claims payment patterns, and employee demographics. The Plan is obligated to pay for the care of covered claims regardless of future participation in the Plan. The liability for claims payable and premiums due to insurers are based on invoiced amounts.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023, relates primarily to health claims incurred but not reported. The deficiency will be funded through future increases in contribution rates.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan has a number of service providers. Such providers are parties in interest under ERISA. Funds totaling \$3,467,513 and \$3,215,717 for the years ended December 31, 2024 and 2023, respectively were paid by the Plan to Highmark, Inc., Ameritas Life Insurance Corp., and Maxcare, LLC for administrative expenses.

The Company provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Short-term Federal Investment Trust and Interest-bearing Cash***

The Plan's investments consist of a short-term federal investment trust account and interest-bearing cash accounts with a bank. Fair values are estimated by using quoted prices of similar securities or discounted cash flows analysis on interest-bearing investments based on market rates. Such securities are classified in Level 2 of the valuation hierarchy.

Claims payable, claims incurred but not reported and premiums due to insurers for participants, dependents, and beneficiaries are recorded on Form 5500 for benefit claims that have been processed and approved for payment and claims incurred but not reported prior to December 31, 2024 and 2023, but not yet paid as of that date.

**Note 7. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan's benefit obligations include amounts for claims incurred but not reported which is based on certain assumptions related to prior claims experience, past claims payment patterns and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Note 8. Plan Tax Status**

The Crete Carrier Corporation Welfare Benefits Plan was established January 1, 2010, to provide health and employee welfare benefits to eligible employees. The Plan includes a Welfare Benefit Trust. The trust was not established as a tax-exempt trust. As a result the Trust, from time to time may be subject to income taxes related to its investment income. Federal and state income taxes were not significant in 2024 and 2023. The plan administrator believes the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through June 27, 2025, which is the date the financial statements were available to be issued.
