### **Note 4: Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC (Empower), the Trustee of the Plan.

### **Note 5: Tax Status**

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter, which states the plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 6: Party-in-Interest Transactions**

Empower is the recordkeeper and, therefore, qualifies as a party-in-interest. Fees incurred and paid by the Plan to Empower for the year ended December 31, 2024 for recordkeeping services were \$13,619. Fees incurred and paid by the Plan to Orgel Wealth Management, investment advisor, for the year ended December 31, 2024, for investment advisory services were \$40,390.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* Valued at NAV provided by the trustee of the fund using NAV as a practical expedient. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. The fund invests in stable value products in order to achieve stability of principal and current income. The trustee of the trust attempts to maintain a stable NAV for units of participation in the trust based on the value of the units of participation of the underlying investments. The NAV of a unit of participation is determined daily and published to participants in the trust.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with GAAP.

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

#### **Subsequent Events**

The Company has evaluated subsequent events through June 5, 2025, which is the date the financial statements were available to be issued.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor and Company matching contributions, and allocations of (a) Company nonelective and profit-sharing contributions and (b) plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company matching and Company nonelective and profit-sharing contributions plus actual earnings thereon will vest based on their years of vesting service. Effective January 1, 2024, non-safe harbor Company contributions vest at a rate of 20% per year beginning the second year of service and become fully vested after six years of service. Prior to January 1, 2024, Company safe harbor contributions vested fully after two years of service.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a direct rollover to another eligible retirement plan. Upon termination of services for any reason, the Plan will make a mandatory lump-sum distribution equal to the value of the participant's vested interest in their account if the balance is less than or equal to \$1,000. If the account balance is greater than \$1,000, but less than \$5,000, a mandatory distribution would be subject to direct rollover. If the account balance is greater than \$5,000, a participant can elect to receive a lump sum amount, partial distribution, or installment equal to the value of the participant's vested interest in their account. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$308 and \$733, respectively. These accounts will be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, forfeited nonvested accounts of \$5,772 and \$2,332 were used to reduce Company contributions and offset administrative expenses.

### Note 1: Description of Plan

The following description of the Security Financial Bank 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) plan covering employees of Security Financial Bank (the "Company") who have one month of service for employee and safe harbor contributions, and three months of service for matching and nonelective contributions, and are age 21 or older. Previous to March 1, 2023, the Plan required three months of service for all contributions types. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has a safe harbor matching contribution equal to 100% of each eligible participant's employee contributions, up to 5% of compensation. The Company can also make nonelective matching and profit-sharing contributions each year. For 2024, the safe harbor matching contribution was \$413,443, and there were no nonelective contributions.

Participants may elect to make a Roth 401(k) deferral. These deferrals are subject to federal income taxes in the year of deferral.

The Plan includes an automatic salary deferral feature in which 5% of the participant's compensation will be automatically withheld and contributed to the Plan once the participant meets the eligibility requirements. The amount of such automatic enrollment will increase by 1% per year on the first day of the Plan Year up to a maximum of 15%. A participant may elect not to participate in the Plan or change their deferral rate upon notification to the Plan Administrator.
