### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Tronox Incorporated Savings Investment Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tronox Incorporated Savings Investment Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

#### Note 1. Description of Plan

The following description of the Tronox Incorporated Savings Investment Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of all the Plan's provisions. The Plan is administered by the Tronox Incorporated Benefits Committee (the Committee or Plan Administrator).

**General:** The Plan was formed on March 30, 2006, as a defined contribution plan covering all eligible employees of Tronox Incorporated (the Company), as defined in the Plan agreement. The Plan has been restated throughout the years to comply with tax legislation and was most recently restated effective January 1, 2024. The purpose of the Plan is to encourage and assist employees in accumulating retirement savings. The Plan is subject to the provisions of the Department of Labor's (DOL) Rules and Regulations under the Employee Retirement Income Security Act of 1974 (ERISA). Certain provisions of the Plan are different for employees represented by a collective bargaining unit; however, the Company has no such employees that would otherwise be eligible.

**Eligibility:** A Participant must be employed in an eligible position. All employees are employed in an eligible position except for temporary employees, independent contractors, leased employees, and employees who work outside the US. An employee becomes an active participant immediately.

**Contributions:** Participants may make voluntary contributions to the Plan, not to exceed 85% of their total annual compensation. Contributions are subject to annual limitations imposed (\$23,000 for 2024), pursuant to section 401(k) of the Internal Revenue Code (IRC). Post-tax Roth deferrals are permitted under the Plan. Upon meeting eligibility requirements, the Company will automatically withhold 6% of the participant's compensation as a pre-tax contribution.

Plan participants age 50 and older were eligible to make a catch-up contribution of an additional \$7,500 to the Plan during the year ended December 31, 2024. The participants eligible to make the catch-up contributions may do so only after making the total elective deferral contributions allowed by the Internal Revenue Service (IRS). Rollover contributions from other qualified plans are allowed, and are always 100% vested.

Contributions by employees in excess of amounts allowable under the IRC are considered to be contributions to the Plan's after-tax savings program. The maximum contributions allowed to each program may be limited for highly compensated employees, depending upon the balance of contributions at all levels.

For 2024, the Company made safe harbor matching contributions to active participants' accounts equal to 100% of the first 6% of eligible compensation the participant deferred to the Plan each month (or at such other time as the Committee may determine, but not less than annually). Each active participant was entitled to receive matching contributions if he or she performed at least one hour of service during the respective month and had submitted a salary reduction agreement.

Employer profit sharing contributions are defined as discretionary employer contributions contributed to the Plan. As of the last business day of each calendar month, (or at such other time as the Committee may determine, but not less than annually), the Company may make a discretionary profit sharing contribution to the Plan, which shall be allocated to each active eligible participant.

The total of each Participant's deferrals, Roth contributions and post-tax program contributions, plus respective Company safe harbor matching and profit sharing contributions, are subject to an annual overall limit under the IRC.

**Participant accounts and investment options:** Participants may direct their contributions and Company contributions to a selection of several investment options offered by the Plan.

Each participant's account is credited with the participant's contribution, employer matching and profit sharing contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** All participants are immediately vested in their voluntary contributions plus actual earnings or losses thereon and rollover contributions from other qualified plans.

Company matching contributions are immediately vested at 100%.

Participants entering the Plan after December 31, 2011 shall not be vested in Company profit-sharing contributions until they have completed three years of service, at which time they will be 100% vested.

**Payments of benefits:** On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her vested account balance, or may elect a partial distribution from their account once each year. The Plan allows for in-service distributions if a participant reached age 59 1/2 and hardship distributions subject to Plan provisions. Effective January 1, 2024, if a participant's account balance does not exceed \$7,000 (previously \$5,000) the plan administrator will authorize the benefit payment without the participant's consent.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not extend past five years for a general purpose loan or 10 years for a residential loan. The loans are secured by the balance in the participant's account and bear interest at the prime rate stated in the *Wall Street Journal* on the Thursday before the 15th day of March, June, September and December, plus 1%. Principal and interest are paid ratably through payroll deductions. Delinquent participant loans remain as Plan assets until they meet certain default criteria as specified in the terms of the Plan document.

**Administration:** The Committee has overall responsibility for the Plan. This includes the power to interpret the provisions of the Plan and to determine questions concerning eligibility, participation and benefits and such other powers and duties as are necessary to the operation and administration of the Plan.

**Forfeited accounts:** Forfeited nonvested accounts are used to either reduce employer contributions or pay administrative expenses of the Plan. During 2024, there were \$612,809 forfeitures used to offset employer contributions and no forfeitures used to pay administrative expenses. As of December 31, 2024 and 2023, there were approximately \$10,320 and \$249,336, respectively, of unused forfeitures.

**Plan termination:** Although it has not expressed any intent to do so, the Company has the right under the Plan to change Plan provisions or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

**Basis of accounting:** The financial statements of the Plan are prepared using the accrual method of accounting.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded, based upon the terms of the Plan agreement.

**Use of estimates:** The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties:** The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Payment of benefits:** Benefits are recorded when paid.

**Contributions:** Contributions from participants and Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. In January 2015, the plan entered into a revenue credit arrangement. In 2024, there were \$20,116 in revenue credits earned, and \$124,016 expenses paid out of the revenue credit account. As of December 31, 2024 and 2023, the revenue credit account balance totaled \$144,421 and \$239,157, respectively.

**Income tax status:** The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements.

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Fidelity Management Trust Company (the Trustee or Fidelity) and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

Fidelity also certified the completeness and accuracy of \$30,635,079 of net appreciation in fair value of investments, \$9,203,881 of interest and dividend income, and \$264,435 of interest income on notes receivable from participants for the year ended December 31, 2024.

**Note 4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy, under ASC 820, are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust fund:** Valued based on the NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
